3. RF Exposure

3.1 Standard Applicable

According to § 1.1307 and § 2.1093, the portable transmitter must comply the RF exposure requirements.

3.2 Test Result

4. RF Output Power

4.1 Standard Applicable

According to \$22.913(a)(2), The ERP of mobile and portable stations transmitters and auxiliary test transmitters must not exceed 7 Watts.

According to §27.50(d)(4), Fixed, mobile, and portable (hand-held) stations operating in the 1710-1755 MHz band and mobile and portable stations operating in the 1695-1710 MHz and 1755-1780 MHz bands are limited to 1 watt EIRP.

According to §27.50(c)(10), Portable stations (hand-held devices) in the 698-746 MHz band are limited to 3 watts ERP.

4.2 Test Procedure

Conducted output power test method:



- Radiated power test method:
- 1. The setup of EUT is according with per ANSI/TIA Standard 603E and ANSI C63.26 measurement procedure.
- 2. The measurement antenna was placed at a distance of 3 meters from the EUT. During the tests, the antenna height and polarization as well as EUT azimuth were varied in order to identify the maximum level of emissions from the EUT. The test was performed by placing the EUT on 3-orthogonal axis.
- 3. The frequency range up to tenth harmonic of the fundamental frequency was investigated.
- 4. Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.

5. Peak-to-average Ratio (PAR) of Transmitter

5.1 Standard Applicable

According to §27.50(B), the peak-to-average power ratio (PAPR) of the transmitter output power must not exceed 13 dB. The PAPR measurements should be made using either an instrument with complementary cumulative distribution function (CCDF) capabilities to determine that PAPR will not exceed 13 dB for more than 0.1 percent of the time or other Commission approved procedure. The measurement must be performed using a signal corresponding to the highest PAPR expected during periods of continuous transmission.


5.2 Test Procedure

According with KDB 971168

- 1. The signal analyzer's CCDF measurement profile is enabled
- 2. Frequency = carrier center frequency
- 3. Measurement BW > Emission bandwidth of signal
- 4. The signal analyzer was set to collect one million samples to generate the CCDF curve

5. The measurement interval was set depending on the type of signal analyzed. For continuous signals (>98% duty cycle), the measurement interval was set to 1ms. For burst transmissions, the spectrum analyzer is set to use an internal " RF Burst" trigger that is synced with an incoming pulse and the measurement interval is set to less than the duration of the " on time" of one burst to ensure that energy is only captured during a time in which the transmitter is operating at maximum power

7. Out of Band Emissions at Antenna Terminal

7.1 Standard Applicable

According to 22.917(a), the power of any emissions outside of the authorized operating frequency ranges must be attenuated below the transmitting power (P) by a factor of at least $43 + 10 \log(P) dB$.

According to \$27.53 (h), the power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) in watts by at least $43 + 10 \log 10$ (P) dB.


According to \$27.53 (g) For operations in the 600 MHz band and the 698-746 MHz band, the power of any emission outside a licensee's frequency band(s) of operation shall be attenuated below the transmitter power (P) within the licensed band(s) of operation, measured in watts, by at least $43 + 10 \log (P) dB$.

According to \$27.53 (m)(4) For mobile digital stations, the attenuation factor shall be not less than $40 + 10 \log (P) dB$ on all frequencies between the channel edge and 5 megahertz from the channel edge, $43 + 10 \log (P) dB$ on all frequencies between 5 megahertz and X megahertz from the channel edge, and $55 + 10 \log (P) dB$ on all frequencies more than X megahertz from the channel edge, where X is the greater of 6 megahertz or the actual emission bandwidth as defined in paragraph (m)(6) of this section. 7.2 Test Procedure

The RF output terminal of the transmitter was connected to the input of the spectrum analyzer via a suitable attenuation. The RBW of the spectrum analyzer was set to 100kHz and 1MHz for the scan frequency from 30MHz to 1GHz and the scan frequency from 1GHz to up to 10th harmonic.

- 3. The frequency range up to tenth harmonic of the fundamental frequency was investigated.
- 4. Remove the EUT and replace it with substitution antenna. A signal generator was connected to the substitution antenna by a non-radiating cable. The absolute levels of the spurious emissions were measured by the substitution.



9. Frequency Stability

9.1 Standard Applicable

According to §22.355, §27.54 the limit is 2.5ppm.

9.2 Test Procedure

According to §2.1055, the following test procedure was performed. The Frequency Stability is measured directly with a Frequency Domain Analyzer. Frequency Deviation in ppm is calculated from the measured peak to peak value. The Carrier Frequency Stability over Power Supply Voltage and over Temperature is measured with a Frequency Domain Analyzer in histogram mode
