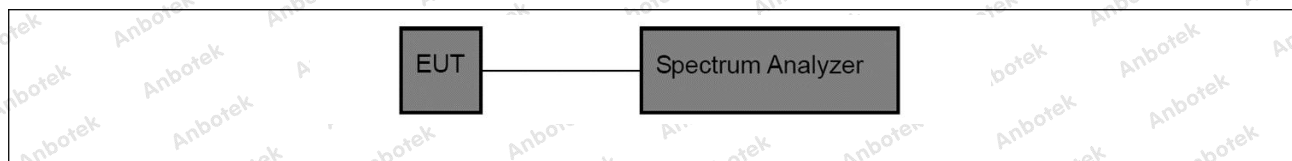
## 6. Power Spectral Density
