## Getting Started

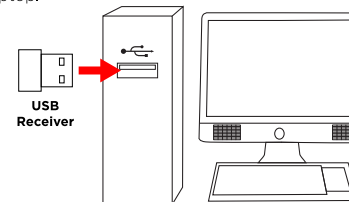
### Installing Batteries

1. Remove the battery cover from the bottom of the mouse.
2. Install two (2) new AAA-sized Alkaline batteries (*not included*), following the polarity (+/-) diagram in the compartment. Do not mix old and new batteries, or mix different brands or types of battery.
3. Replace the battery cover.

### Setting Up

Plug the included USB receiver into any of the USB ports (Type-A) on your computer or laptop.

Make sure that the line of sight between the mouse and the USB receiver is clear.



The mouse does not require any special installation or software. Your computer should automatically detect and install the mouse.

If your computer does not automatically connect to the mouse, try restarting your computer or checking the devices settings in your computer's **Settings** or **System Preferences** panel.
