2.2 Test Mode

a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Y plane) were recorded in this report, and the worst mode of radiated spurious emissions is Bluetooth 1Mbps mode, and recorded in this report.





<Buetooth Tx Mode>








Channel Separation Plot on Channel 00 - 01


Channel Separation Plot on Channel 39 - 40

Channel Separation Plot on Channel 77 - 78




Channel Separation Plot on Channel 00 - 01


Channel Separation Plot on Channel 39 - 40

Channel Separation Plot on Channel 77 - 78




Channel Separation Plot on Channel 00 - 01


Channel Separation Plot on Channel 39 - 40

20 dB Bandwidth Plot on Channel 00




20 dB Bandwidth Plot on Channel 39






99% Occupied Bandwidth Plot on Channel 39

99% Occupied Bandwidth Plot on Channel 78




99% Occupied Bandwidth Plot on Channel 39


Low Band Edge Plot on Channel 00

High Band Edge Plot on Channel 78




Low Band Edge Plot on Channel 00

High Band Edge Plot on Channel 78




Low Band Edge Plot on Channel 00




Hopping Mode Low Band Edge Plot

Hopping Mode High Band Edge Plot




Hopping Mode Low Band Edge Plot

Hopping Mode High Band Edge Plot




Hopping Mode Low Band Edge Plot



- 6. The RF fundamental frequency should be excluded against the limit line in the operating frequency band.





CSE Plot on Ch 00 between 30MHz ~ 3 GHz




CSE Plot on Ch 39 between 30MHz ~ 3 GHz


CSE Plot on Ch 39 between 2 GHz ~ 25 GHz


CSE Plot on Ch 78 between 30MHz ~ 3 GHz

CSE Plot on Ch 78 between 2 GHz ~ 25 GHz






CSE Plot on Ch 00 between 30MHz ~ 3 GHz


CSE Plot on Ch 00 between 2 GHz ~ 25 GHz


CSE Plot on Ch 39 between 30MHz ~ 3 GHz


CSE Plot on Ch 39 between 2 GHz ~ 25 GHz


CSE Plot on Ch 78 between 30MHz ~ 3 GHz

CSE Plot on Ch 78 between 2 GHz ~ 25 GHz




CSE Plot on Ch 00 between 30MHz ~ 3 GHz


CSE Plot on Ch 00 between 2 GHz ~ 25 GHz


CSE Plot on Ch 39 between 30MHz ~ 3 GHz
