5. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.10 and FCC CFR 47 15.207, 15.209 and 15.247 and KdB 558074.

6. FACILITIES AND ACCREDITATIONS

6.1 FACILITIES

All measurement facilities used to collect the measurement data are located at No.8, Jiucengling, Xinhua Dist., Tainan City 712, Taiwan (R.O.C.)

The sites are constructed in conformance with the requirements of ANSI C63.7:1992, ANSI C63.10: 2013 and CISPR Publication 22.

6.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with preselectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."


MAXIMUM PEAK OUTPUT POWER (GFSK(4.0) MODE)

Set the center frequency of the instrument to the center frequency of the transmission. Set RBW ≥ OBW if possible; otherwise, set RBW to the largest available value. Set VBW ≥ RBW. Set detector = peak or average. The zero-span measurement method shall not be used unless both RBW and VBW are > 50/T and the number of sweep points across duration T exceeds 100. 
POWER SPECTRAL DENSITY (GFSK(4.0) MODE)



9kHz ~ 30MHz




