The antenna is a Ceramics Antenna which permanently attached, and the best case gain of the antenna is **2.7 dBi** . It complies with the standard requirement.



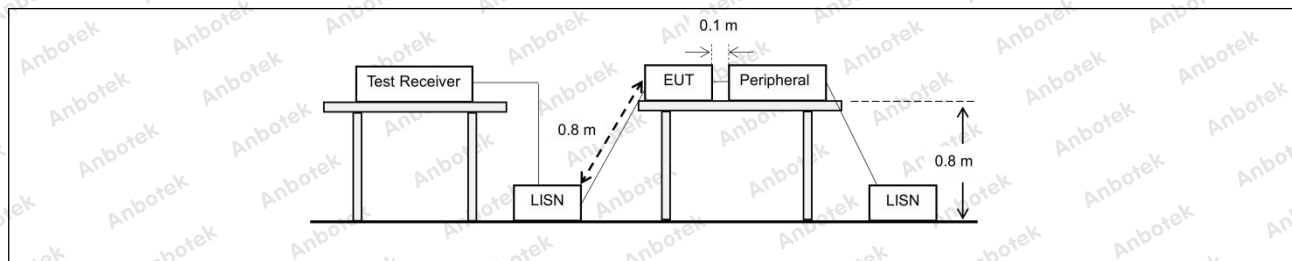

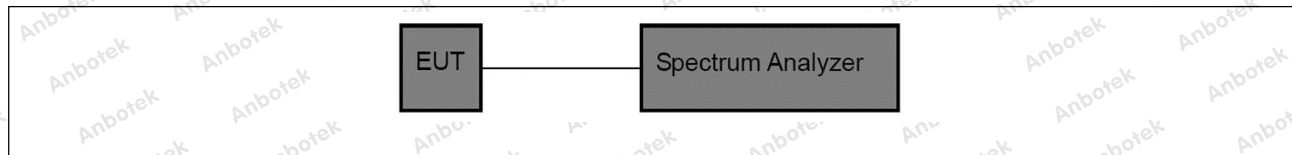
5. Maximum Conducted Output Power
