Calculation Formula:  $Pd = (Pout*G)/(4*pi*r^2)$ 

Where

Pd = power density in mW/cm<sup>2</sup>

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

r = distance between observation point and center of the radiator in cm

Pd is the limit of MPE, 1mW/cm<sup>2</sup>. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.


So EIRP<sub>Ant 1</sub> (dBm) = Conducted Power(dBm) + Peak Gain <sub>Ant 1</sub>(dBi) – RF Cable Loss(dB)

Note 2: EIRP<sub>Ant 2</sub> (dBm) = Conducted Power(dBm) + Peak Gain <sub>Ant 2</sub>(dBi)

#### **CONCLUSION:**

The max Power Density at R (20 cm) = 0.2666mW/cm<sup>2</sup> < 1 mW/cm<sup>2</sup>.
