

# EUPHO SYN V™ OVERVIEW:

The Eupho Syn V is a 5th generation anatomically designed hands-free male G-spot stimulator, combining design elements from our award winning Eupho Syn Trident and the added intensity of vibration with the convenience of remote control operation. With a simple contraction, Eupho Syn V pivots inward and upward stimulating the male G-spot (prostate), anus, perineum and K-spot simultaneously. Eupho Syn V's ultra-compact design produces guiet yet powerful vibration and can be used in two control modes powered (wireless or manual) and an unpowered (discreet mode). Larger than the original Eupho Syn, Eupho Syn V offers a unique experience in unpowered mode with fuller, more robust stimulation. Wireless mode utilizes an elegant rechargeable multifunction remote for effortless command of Eupho Syn V's powerful motor using an ergonomic layout that will allow you to scroll back and forth between vibration patterns and select different levels of vibration intensity. Manual control is accessed by a simple multifunction button on the base of the Eupho Syn V. Both powered modes provide 10 preset vibration patterns at 4 levels of intensity for a total of 40 enhanced sensory experiences. Level one offers very subtly elevated stimulation that promotes more sensation while allowing the user to maintain full awareness of movement and responsiveness to contractions. Terrific for Super O sessions, this setting is specifically designed for users who find typical vibrating products desensitizing. Levels 2 and 3 operate at twice and four times the speed of level one, respectively, and are best for those who enjoy moderate degrees of vibration while maintaining an awareness of massager movement and responsiveness. And are terrific settings for Super O and traditional (non-ejaculatory) sessions. Level 4 is 2.5 times stronger than level 3 and is specifically designed for those who enjoy high intensity vibration. When combined with your own internal contractions, the variety of sensations are endless. Eupho's legendary anatomically designed contours produce focused stimulation with the highest level of agility of any of our products, allowing you to customize your own level of sensation. This results in orgasms of enormous power and depth, experiences so intense. they will forever change your frame of reference about sexual pleasure. Feel the SYN from within!

## **GETTING STARTED:**



- Charge Eupho Syn V for two hours before first use. (see charging instructions)
- Wash Eupho Syn V with soap and water, or a toy cleaner compatible with silicone items.\*
- 3. Lubricate Eupho Syn V with a water-based or silicone-compatible lubricant.\*
- 4. Lay on your back with both knees pulled up slightly.
- Slowly insert the Eupho Syn V until the P-TAB is flush against your perineum (the area between the scrotum and anus. You may feel an emerging pressure on your prostate).
- Start with a few anal contractions to familiarize yourself with the sensations and responsiveness of the device.
- 7. Choose an operating mode and enjoy!

## EUPHO SYN V™ OPERATING MODES:

#### Discreet

Discreet is an unpowered mode. The Eupho Syn V has been designed to be propelled by your contractions alone for focused prostate and anal stimulation. As there is no vibration associated with this mode, there is no sound to identify it is in use. Great for wearing out for some secret pleasure. We strongly recommend that users get started by inserting the Helix Syn V in this mode in order to familiarize themselves with its feel and responsiveness before powering up.

#### **POWERED MODES:**

#### Manual

Manual mode allows you to use the Eupho Syn V without the remote.

Click the multifunction button twice to turn the Eupho Syn V on. You will notice the LED indicator is blinking, this is standby/ready mode. Double click to turn the massager off.



#### Pattern Selection

From standby mode, single click multifunction button to advance to vibration patterns 1 though 10. (LED will stop blinking and remain lit when Eupho Syn V is vibrating). Preset vibration patterns are of varying lengths and duration and feature different levels of intensity. Patterns 9 and 10 are special composite patterns derived from patterns 1 – 8 edited for duration and intensity and sequenced together to simulate randomness.


#### Intensity (Motor Speed) Selection

Depress and hold multifunction button 2 seconds to change to one of four motor speeds: Speed one: 10%. Speed two: 20%. Speed three: 40%. Speed four: 100%.

Turning power off and on will reset the Eupho Syn V back to standby mode and from there Speed one, pattern one.

## **REMOTE**

The Eupho Syn V wireless remote provides access to all of the massagers features including: 10 vibration patterns at 4 levels of intensity, shuffle navigation forward and back, and power on / off.



Power/ Intensity Selection/Counter Reset



#### **POWFR**

Press and hold 2 seconds to turn the remote power on. \*Note, the Eupho Syn V must be turned on manually for the remote to connect to it. Pressing and holding the button thereafter for 2 seconds will turn both the remote and the Eupho Syn V off.

#### Counter Reset:

Double click to reset the LED display back to 00 (ready mode)

# REMOTE: (continued)

#### Intensity (Motor Speed) Selection

Depress and hold multifunction button 2 seconds to change to one of four motor speeds: **Speed one: 10%. Speed two: 20%. Speed three: 40%. Speed four: 100%.**Turning power off and on will reset the Eupho Syn V back to standby mode and from there Speed one, pattern one.



The LED display indicates the vibration pattern in use by number. On power-up the remote is in ready mode and 00 is displayed. Press right arrow or left arrow to choose a pattern.



All vibration patterns can be accessed by pushing the left or right pattern selector arrow buttons. The right button advances from 1 to 10 and back to 00, the left button advances from 10 to 1 and back to 00. This feature makes it easy to navigate through the large number of patterns quickly. To fast forward up or down, depress and hold the right or left arrow buttons.

# **POWER SAVE FEATURES**

The Eupho Syn V and remote have special power save features designed to conserve battery life. When the Eupho Syn is operated in manual mode (without the remote), if left in ready/standby mode (with LED blinking) for longer than 5 minutes, it will automatically power off. Once a vibration pattern is selected, the massager will operate continuously (This feature is deactivated once the remote is powered on and synced with the Eupho Syn V). Once a vibration pattern is chosen on the remote, the Eupho Syn V will operate continuously for 60 minutes. If no other command is selected on the remote (a different pattern or a different power level) then the remote and the Eupho Syn V will power off after 60 minutes. Each time you select a different vibration pattern or a different power level you reset both devices for another hour of use.

## **EUPHO SYN V CHARGING INSTRUCTIONS:**








Eupho Syn V's USB charging cable can be plugged into any USB type A port or USB type A AC power adapter (not included). Place the charger head over the two magnetic contacts on the base of the unit next to the button. Eupho Syn V requires 2 hours for a full charge and will last for approximately 90 minutes of continuous use at highest speed.

- Blinking Light = Charging
- Solid Light = Fully Charged

## REMOTE CHARGING INSTRUCTIONS



The Eupho Syn V remote takes a micro USB charging cable (included) and can be plugged into any USB type A port or USB type A, AC power adapter (not included). Insert the micro USB jack into the bottom of the remote. The remote requires 90 minutes for a full charge and will last for over 50 hours of use.

- Blinking Light = Charging
- Solid Light = Fully Charged

## EUPHO SYN V HANDLING AND CARE:



- 1. Always clean Eupho Syn V before and after use.
- Wash with soap and lukewarm water or a silicone compatible toy cleaner. Rinse clean and pat dry using a lint-free cloth or towel. Do not use cleaners containing alcohol, acetone or petroleum-based solvents.

#### NEVER boil the Eupho Syn V.

- 3. For maximum comfort and responsiveness, always apply a high quality water-based or plant oil-based lubricant before insertion. \*Silicone-based lubricants are not recommended and should never be used with the Eupho Syn V as they will damage the product's surface and void your warranty.
- 4. Avoid exposure to high heat or long periods in sunlight.
- 5. Eupho Syn V is water (splash) resistant so it can be used in the shower and washed over a sink. Never bathe with the Eupho Syn V or submerge it for long periods in water.

## REMOTE HANDLING AND CARE:

- 1. Wipe with a clean slightly damp lint-free cloth or towel. Do not use cleaners containing alcohol, acetone or petroleum-based solvents.
- 2. Avoid exposure to high heat or long periods in sunlight.
- 3. Avoid contact with water or other liquids.

## PRECAUTIONS:

Do not use Eupho Syn V on any area of the body that is swollen, inflamed or where the skin is broken. Do not use this device if you have prostate cancer. Do not use this device while under the influence of drugs or alcohol as they may impair your judgment and increase the risk of injury.
