2. TEST METHODOLOGY

All calculations were made in accordance with FCC KDB 447498 D01 and KDB 447498 D03 and IC Safety Code 6.

3. REFERENCES

All measurements were made as documented in test report UL Verification Services Inc. Document 12727679-E4 for operation in the 915 MHz.

Antenna gain data is excerpted from the applicable test report.

4. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 47173 and 47266 Benicia Street, and 47658 Kato Road, Fremont, California, USA. Line conducted emissions are measured only at the 47173 address.

UL Verification Services Inc. is accredited by NVLAP, Laboratory Code 200065-0.

5. DESCRIPTION OF EUT

The EUT is a Reset Controller with LoRa 915MHz wireless communication. It receives data from the Manifold Controller(s) and helps distribute and modulate water temperatures based on those needs. It is categorized as Digital Transmission System (DTS).

6. MAXIMUM PERMISSIBLE RF EXPOSURE

6.1. FCC RULES

6.2. IC RULES

6.3. **EQUATIONS**

POWER DENSITY

Power density is given by:

 $S = EIRP / (4 * Pi * D^2)$

Where

S = Power density in mW/cm^2 EIRP = Equivalent Isotropic Radiated Power in mW D = Separation distance in cm

Power density in units of mW/cm² is converted to units of W/m² by multiplying by 10.

DISTANCE

Distance is given by:

D = SQRT (EIRP / (4 * Pi * S))

Where

D = Separation distance in cm EIRP = Equivalent Isotropic Radiated Power in mW S = Power density in mW/cm^2

SOURCE-BASED DUTY CYCLE

Where applicable (for example, multi-slot cell phone applications) a duty cycle factor may be applied.

Source-based time-averaged EIRP = (DC / 100) * EIRP

Where

6.4. IC EXEMPTION

INDUSTRY CANADA EXEMPTION

RF exposure evaluation is required if the separation distance between the user and/or bystander and the device's radiating element is greater than 20 cm, except when the device operates as follows:

- below 20 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1 W (adjusted for tune-up tolerance);
- at or above 20 MHz and below 48 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 4.49/f0.5 W (adjusted for tune-up tolerance), where f is in MHz;
- at or above 48 MHz and below 300 MHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 0.6 W (adjusted for tune-up tolerance);
- at or above 300 MHz and below 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 1.31 x 10-2 f0.6834 W (adjusted for tune-up tolerance), where f is in MHz;
- at or above 6 GHz and the source-based, time-averaged maximum e.i.r.p. of the device is equal to or less than 5 W (adjusted for tune-up tolerance).

In these cases, the information contained in the RF exposure technical brief may be limited to information that demonstrates how the e.i.r.p. was derived.

Notes:

- 1. The device operates above 300 MHz and below 6 GHz with a maximum EIRP less than or equal to 1.38 Watts in the 915Mhz band as a mobile device with a minimum separation distance of 20 cm, therefore it is exempt from routine RF Exposure Evaluation under RSS-102.
- 2. A tolerance value of +2 dB was included in the output power values above to cover the output power tolerance of +/-2 dB under extreme conditions in the real filed as declared by the applicant.
