### VOLUME UP AND DOWN

PRESS THE VOLUME BUTTON +/-.  
NOTE: BT VOLUME IS CONTROLLED FROM THE PHONE, NOT FROM THE MUFF.

### BT/PAIRING MODE

PRESS DOWN AND HOLD THE BT BUTTON FOR 2 SECONDS UNTIL THE BLUE/RED LED IS FLASHING.

LOOK FOR "CHAMPION" TO PAIR WITH YOUR DEVICE.

A QUICK PRESS OF THE BT BUTTON WILL LET THE USER ANSWER A CALL OR START/STOP MUSIC.

PRESSING THE BT BUTTON LONGER THAN 2 SECONDS WILL TURN THE BT OFF.

### ACTIVE NOISE REDUCTION (ANR)

THE ANR PROVIDED BY THIS HEADSET PROVIDES APPROXIMATELY AN ADDITIONAL 5-10 dB OF REDUCTION IN THE 50-400 Hz FREQUENCY RANGE AS MEASURED ON A TEST FIXTURE DESIGNED FOR THIS TYPE OF MEASUREMENT.

### POWER ON/OFF

PRESS THE POWER BUTTON FOR 2 SECONDS, TO TURN THE UNIT ON. PRESS FOR ANOTHER 2 SECONDS TO TURN THE UNIT OFF.

### ACTIVE NOISE CANCELLATION

ONCE THE UNIT IS POWERED ON, A SIMPLE PRESS OF THE POWER BUTTON WILL ACTIVATE THIS FEATURE. TO TURN OFF ACTIVE NOISE CANCELLATION, SIMPLY PRESS THE POWER BUTTON AGAIN.

### BATTERY CHARGING

TO CHARGE THE BATTERY, USE THE INCLUDED MICRO USB CABLE. PLUG THE CABLE INTO THE CHARGING PORT LOCATED ON THE BOTTOM SIDE OF THE LEFT EAR CUP.
