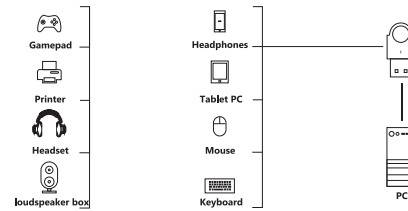

4. Select the "Bluetooth"-5, Right-click and select the "Disable Device", After completing the above steps, you can start to install driver.

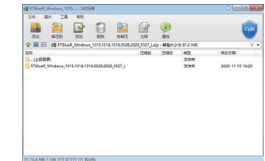

Step 1

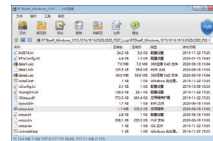
Select the folder for installation, click RTBlueR_Windows_1015.1016.1016.0528.2020_F027_L

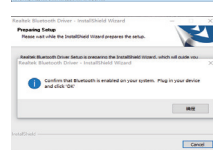
Step 2

Find the "setup.exe" and double-click to install, run the setup program,



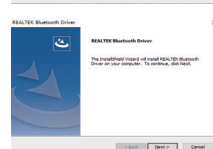
Step 3

Insert the Bluetooth adapter into the USB port of the computer, click "OK" to continue the installation.



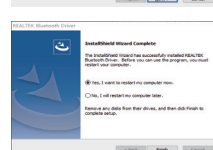
Step 4
