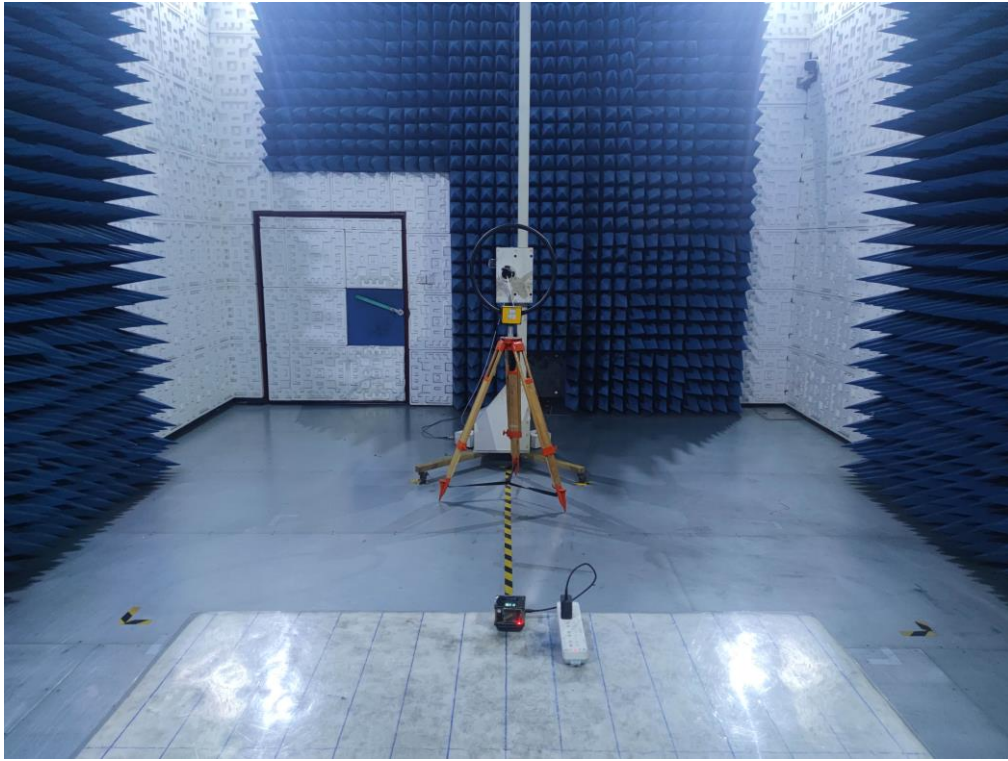
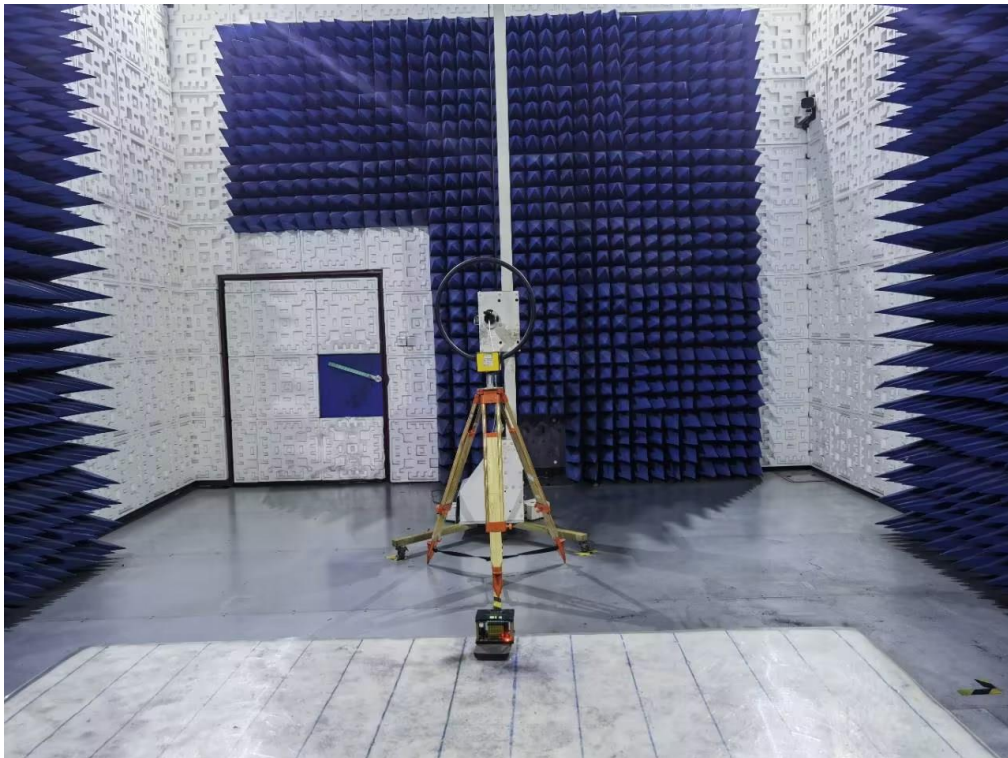

RADIATED EMISSION TEST SETUP BELOW 30MHz (**Portable**)

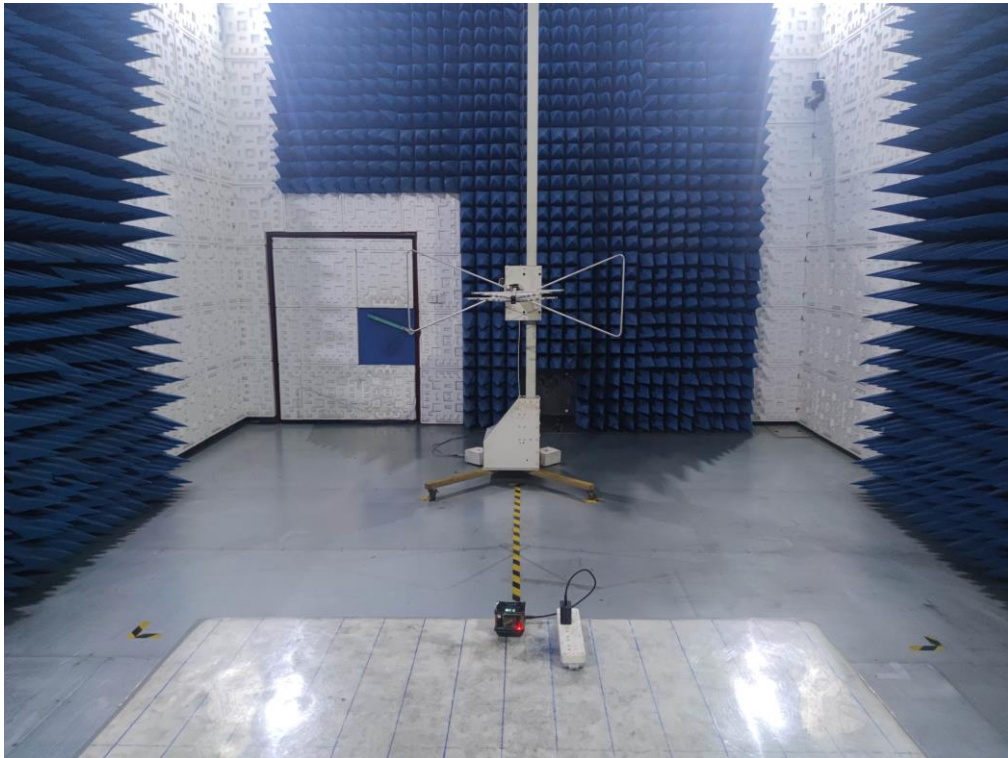
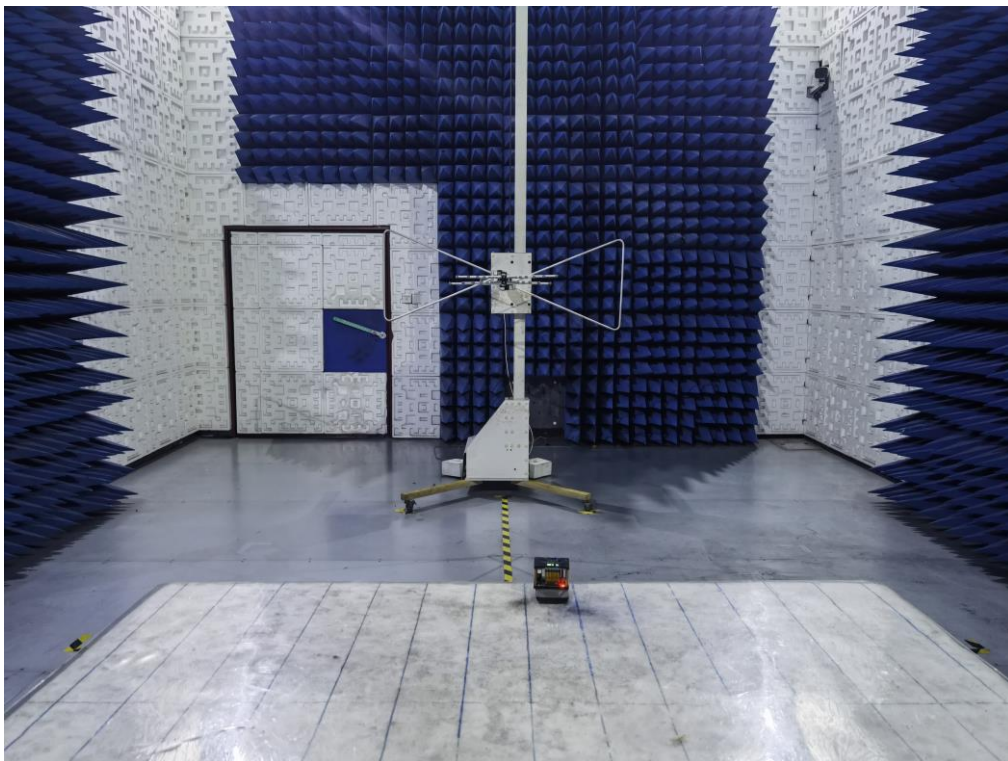

AC POWER LINE CONDUCTED TEST SETUP

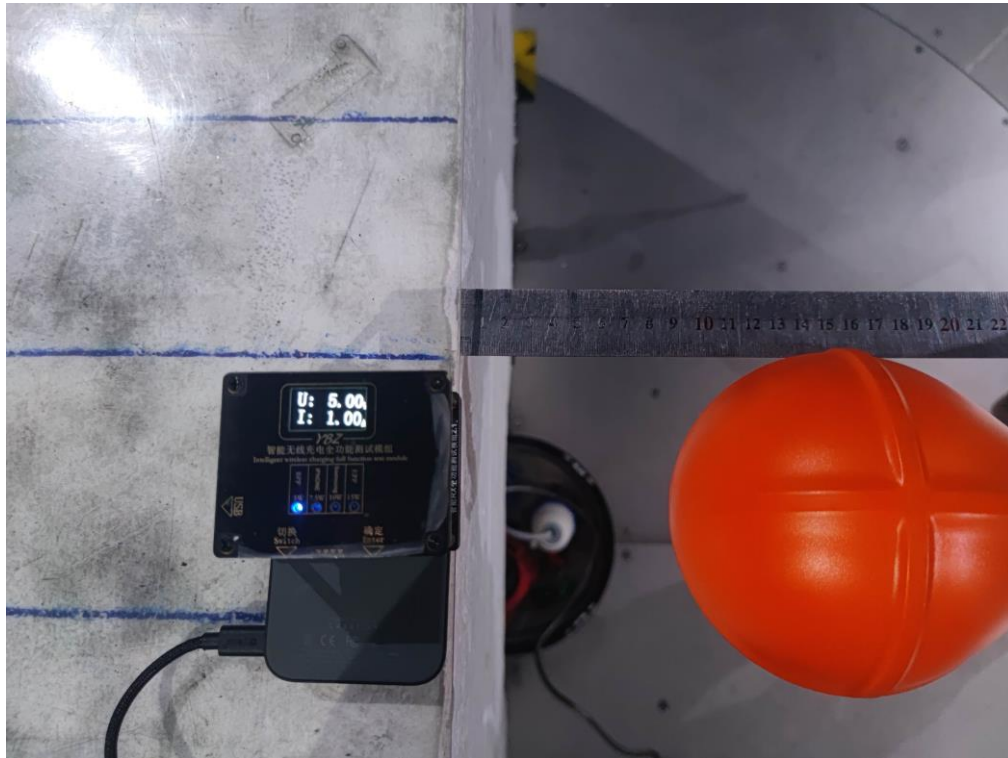

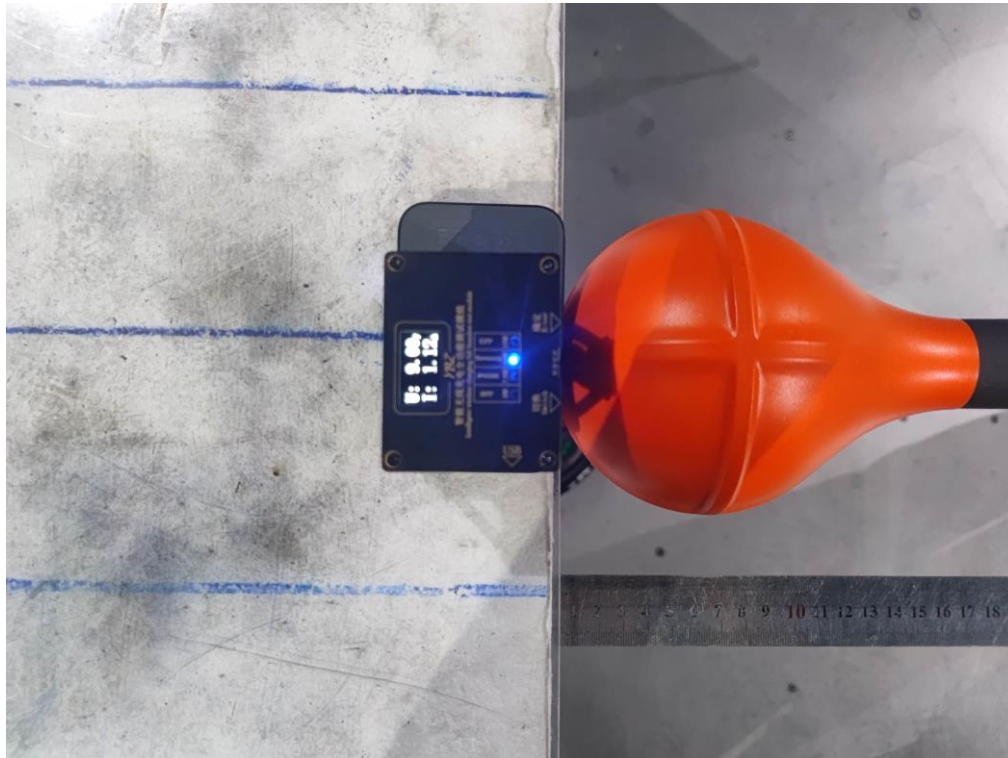


H-Field & E-Field Strength_ Position B

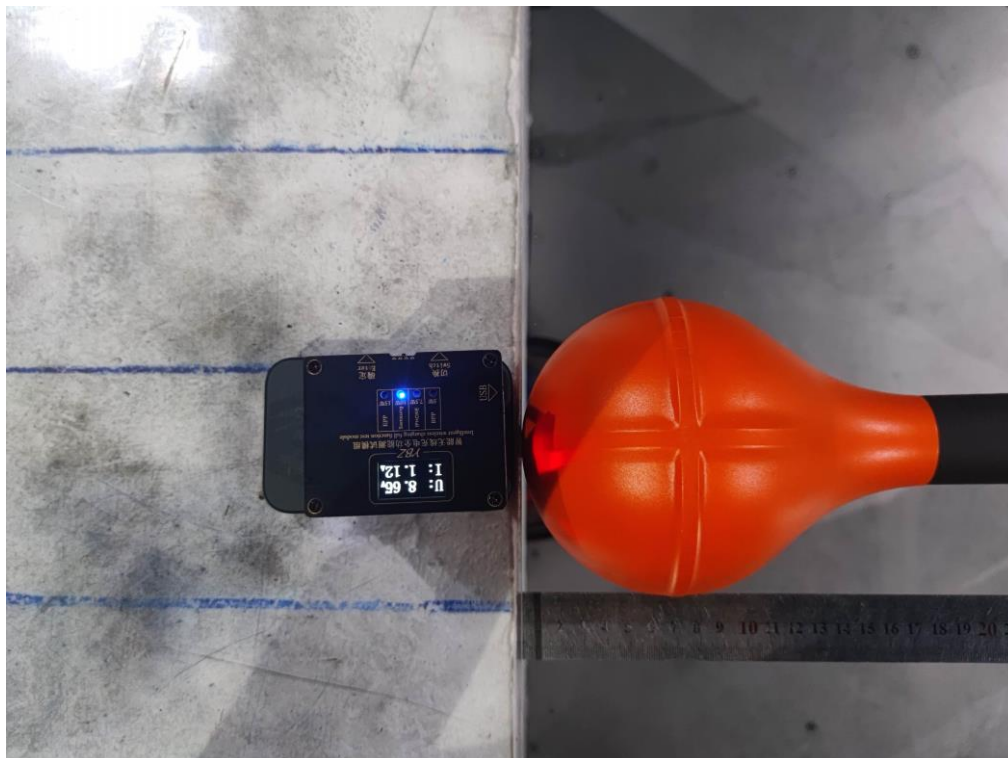

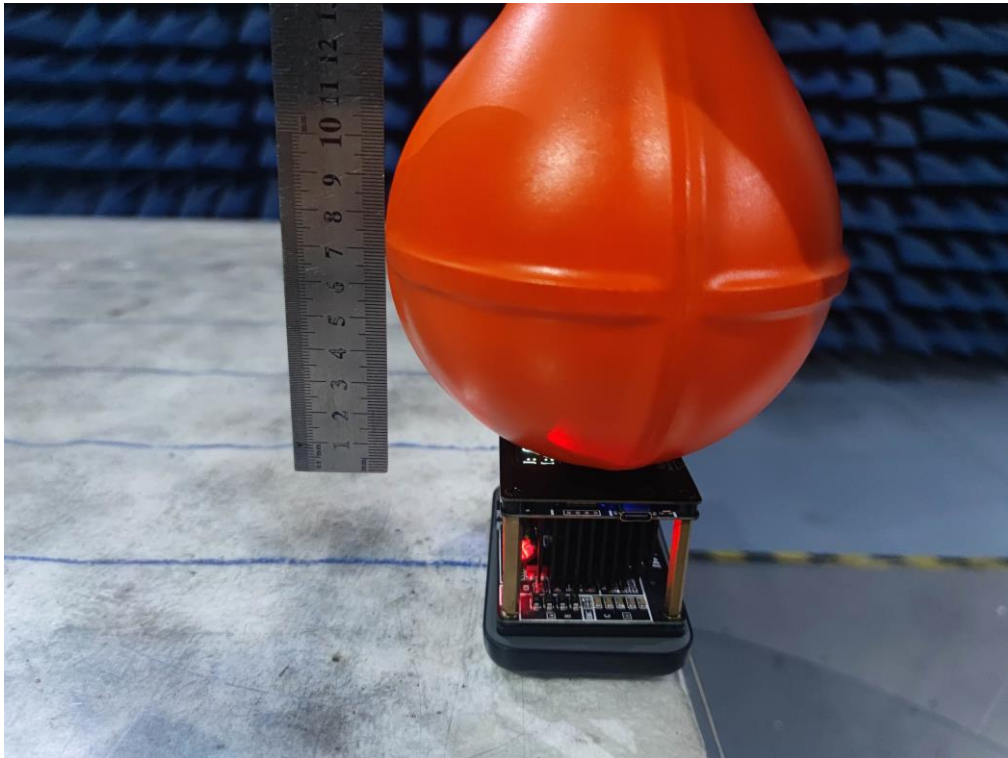

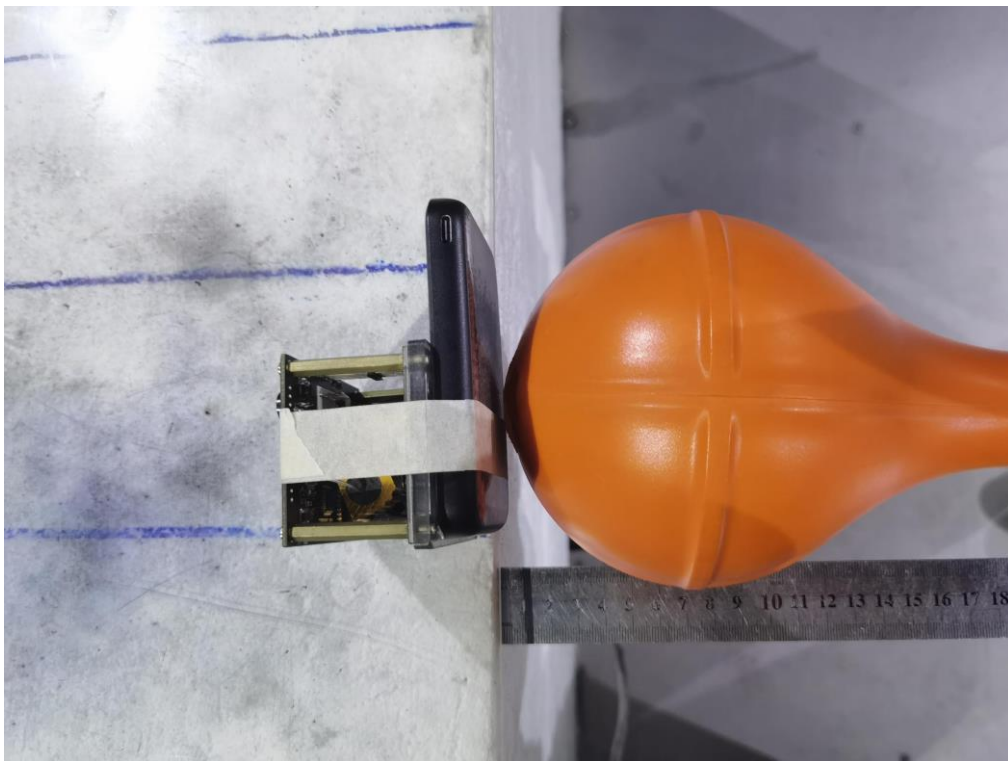
