

## 7.1 Antenna requirement

7.1 Antenna requirem	
Test Requirement:	The applicant for equipment certification shall provide a list of all antenna types that may be used with the transmitter, where applicable (i.e. for transmitters with detachable antenna), indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna. The test report shall demonstrate the compliance of the transmitter with the limit for maximum equivalent isotropically radiated power (e.i.r.p.) specified in the applicable RSS, when the transmitter is equipped with any antenna type, selected from this list.  For expediting the testing, measurements may be performed using only the antenna with highest gain of each combination of transmitter and antenna type, with the transmitter output power set at the maximum level. However, the transmitter shall comply with the applicable requirements under all operational conditions and when in combination with any type of antenna from the list provided in the test report (and in the notice to be included in the user manual, provided below).  When measurements at the antenna port are used to determine the RF output power, the effective gain of the device's antenna shall be stated, based on a measurement or on data from the antenna's manufacturer.  The test report shall state the RF power, output power setting and spurious emission measurements with each antenna type that is used with the transmitter being tested.  For licence-exempt equipment with detachable antennas, the user manual shall also contain the following notice in a conspicuous location:  Immediately following the above notice, the manufacturer shall provide a list of all antenna types which can be used with the transmitter, indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna type.

#### 7.2 Maximum conducted output power

Test Limit:	For client devices in the 5.15-5.25 GHz band, the maximum conducted output power over the frequency band of operation shall not exceed 250 mW provided the maximum antenna gain does not exceed 6 dBi. If transmitting antennas of directional gain greater than 6 dBi are used, the maximum conducted output power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.
Test Method:	ANSI C63.10-2013, section 12.3
Procedure:	Method SA-1 a) Set span to encompass the entire 26 dB EBW or 99% OBW of the signal. b) Set RBW = 1 MHz. c) Set VBW >= 3 MHz. d) Number of points in sweep >= [2 × span / RBW]. (This gives bin-to-bin spacing <= RBW / 2, so that narrowband signals are not lost between frequency bins.) e) Sweep time = auto. f) Detector = RMS (i.e., power averaging), if available. Otherwise, use sample detector mode. g) If transmit duty cycle < 98%, use a video trigger with the trigger level set to



enable triggering only on full power pulses. The transmitter shall operate at maximum power control level for the entire duration of every sweep. If the EUT transmits continuously (i.e., with no OFF intervals) or at duty cycle >= 98%, and if each transmission is entirely at the maximum power control level. then the trigger shall be set to "free run." h) Trace average at least 100 traces in power averaging (rms) mode. i) Compute power by integrating the spectrum across the 26 dB EBW or 99% OBW of the signal using the instrument's band power measurement function, with band limits set equal to the EBW or OBW band edges. If the instrument does not have a band power function, then sum the spectrum levels (in power units) at 1 MHz intervals extending across the 26 dB EBW or 99% OBW of the spectrum.



If transmitting antennas of directional gain greater than 6 dBi are used, the maximum power spectral density shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6 dBi.

	1 dB to the final result to compensate for the difference between linear averaging and power averaging.
