








Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


Dynamic Range f(SAR_{head}) (TEM cell , f_{eval}= 1900 MHz)






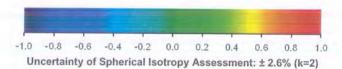
Uncertainty of Linearity Assessment: ± 0.6% (k=2)







S11 Parameter Return Loss












