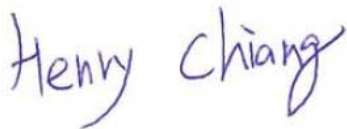

Measurements should be made from all sides and the top of the primary/client pair, with the 10 cm, 15 cm and 20 cm measured from the center of the probe(s) to the edge of the device. Emissions between 100 kHz to 300 kHz should be assessed versus the limits at 300 kHz in Table 1 of Section 1.1310: 614 V/m and 1.63 A/m.

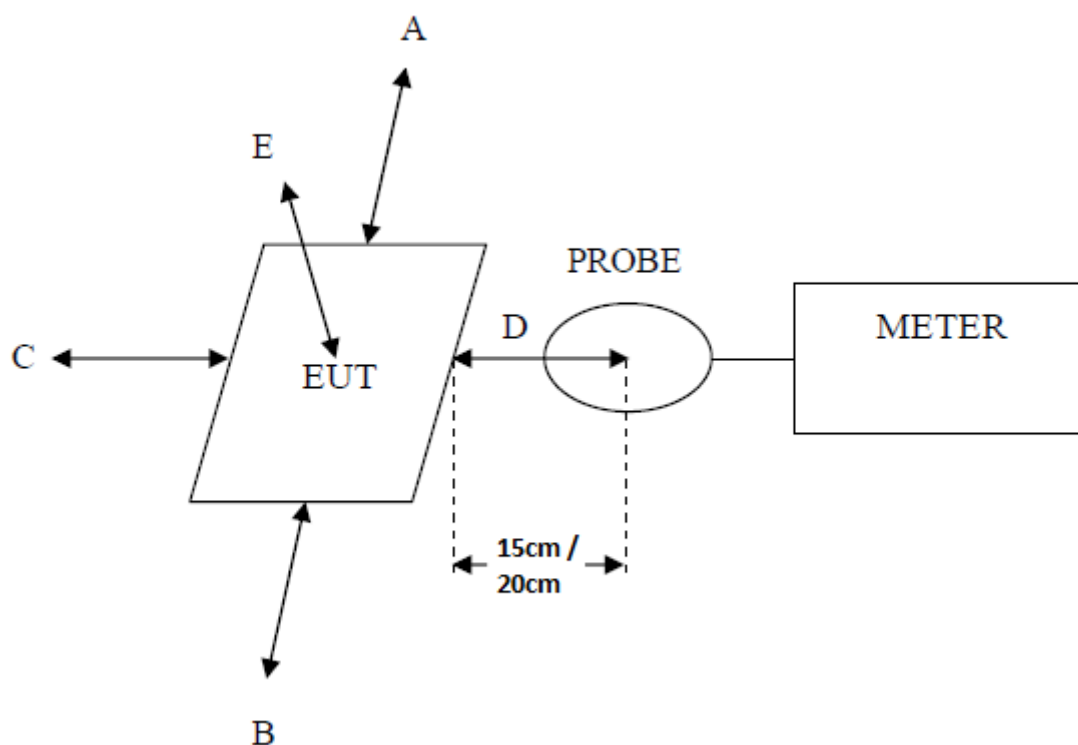
