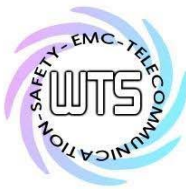

2.4 General Test Procedure

POWER LINE CONDUCTED INTERFERENCE: The procedure used was ANSI STANDARD C63.10-2013 6.2 using a LISN (if necessary). Both lines were observed. The bandwidth of the spectrum analyzer was 10 kHz with an appropriate sweep speed.

RADIATION INTERFERENCE: The test procedure used was according to ANSI STANDARD C63.10-2013 6.3 employing a spectrum analyzer. For investigated frequency is equal to or below 1GHz, the RBW and VBW of the spectrum analyzer was 100 kHz and 100kHz respectively with an appropriate sweep speed. For investigated frequency is above 1GHz, both of RBW and VBW of the spectrum analyzer were 1 MHz with an appropriate sweep speed. The analyzer was calibrated in dB above a microvolt at the output of the antenna.

FORMULA OF CONVERSION FACTORS: The Field Strength at 3m was established by adding the meter reading of the spectrum analyzer (which is set to read in units of dBμV) to the antenna correction factor supplied by the antenna manufacturer. The antenna correction factors are stated in terms of dB.

Example:

Freq (MHz)	METER READING + ACF + CABLE LOSS (to the receiver) = FS

ANSI STANDARD C63.10-2013 6.2.2 MEASUREMENT PROCEDURES: The EUT was placed on a table 80 cm height and with dimensions of 1m by 1.5m (non metallic table). The EUT was placed in the centre of the table. The table used for radiated measurements is capable of continuous rotation. The spectrum was scanned from 30 MHz to 10th harmonic of the fundamental.

Peak readings were taken in three (3) orthogonal planes and the highest readings.

When an emission was found, the table was rotated to produce the maximum signal strength. At this point, the antenna was raised and lowered from 1m to 4m. The antenna was placed in both the horizontal and vertical planes.

ANSI STANDARD C63.10-2013 B.2.7: Any measurements that utilize special test software shall be indicated and referenced in the test report. During testing, test software 'EZ EMC' was used for setting up different operation modes.

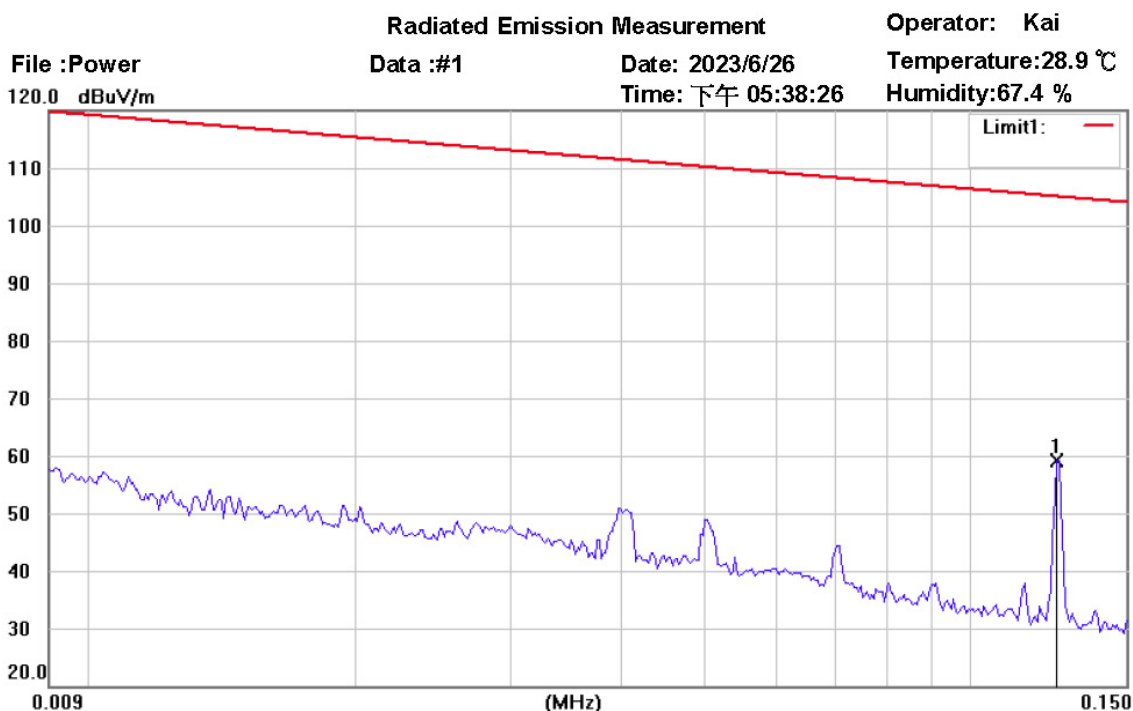

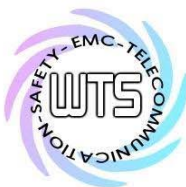

The test was performed in the anechoic OATS at 3 meter test distance, i.e. the distance between measuring antenna and EUT boundary. The results were extrapolated by using the square of an inverse linear distance factor DF:

DF (distance factor) = $40 \log (D_1/D_2) = 80 \text{ dB}$, where

D₁ is the 300 meter specified measurement distance,

D₂ is the 3 meter test measurement distance.

For 125 kHz frequency the calculated limit is:

$\text{Limit}_{3\text{m}} = \text{Limit}_{300\text{m}} + \text{DF} = 25.65 \text{ dBuV/m} + 80 \text{ dB} = 105.65 \text{ dBuV/m}$

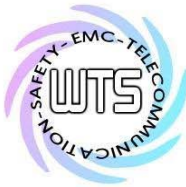

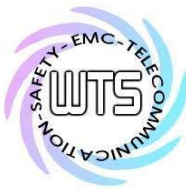

However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

3.6 Power Line Conducted Emission
