# Geavio LED Light uer Instruction manual

## **Product overview**

Gravioi Led light is a color indicator that represents the state in different states of color. It is based on zigbee wireless technology and uses Philips' hue value to adjust the color. His use is very simple, the back plate is attached to the place where you want to indicate the status. After the LED is inserted into the usb, after matching, the light is hung on the back plate at a slight oblique angle and can be used.

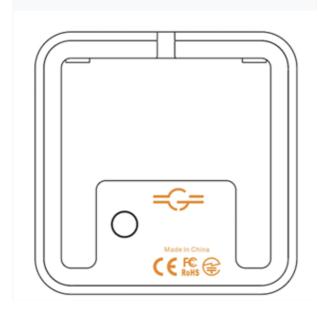


Light out



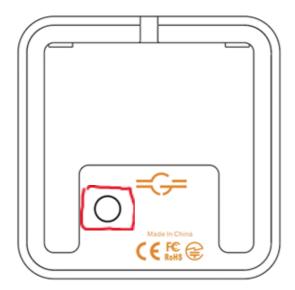
Green light

First need to enter the pairing mode, press and hold the button in the picture for five seconds

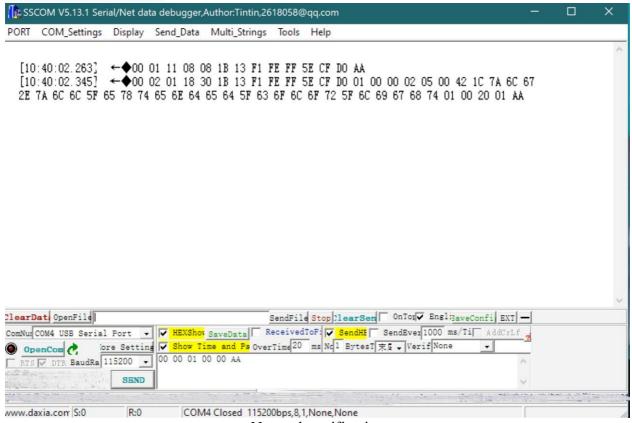
# Gateway establishes network

>> send: 00 00 01 00 00 AA >>receive: 00 01 01 08 02 00 03 AA

Open to allow devices to access the network

>> send: 00 00 10 00 01 FF AA >> receive: 00 01 10 08 01 00 AA

# At this time, the lights will automatically enter the network.



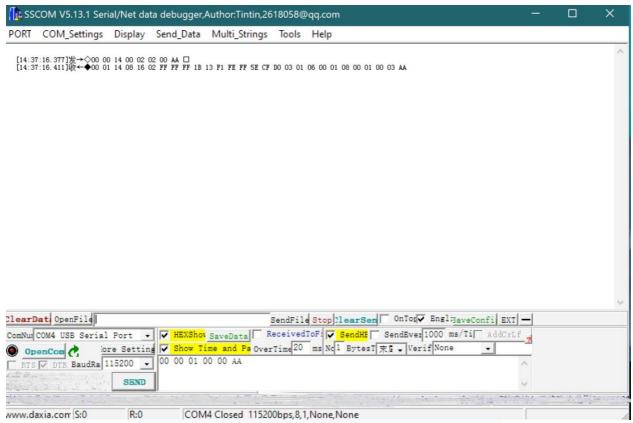

### To Bind

>> send: 00 00 13 00 01 FF AA >> receive: 00 01 13 08 02 01 00 AA

Obtaining information about the network access device can obtain information about the network access device

>> send: 00 00 14 00 02 00 00 AA >> receive: 00 01 14 00 08 12  $\lceil mac \rfloor$  03 01 06 00 01 00 08 00 01 00 03 AA



Mac address is 00 13 after eight hexadecimal digits

#### Light out

>> send : 00 00 01 20 0A 1B 13 F1 FE FF 5E CF D0 01 00 AA >> receive : 00 01 01 28 01 00 AA

#### Light up

>> send : 00 00 01 20 0A 1B 13 F1 FE FF 5E CF D0 01 01 AA >> receive : 00 01 01 28 01 00 AA

#### Coloring with hue value

>> send : 00 00 02 30 0C 1B 13 F1 FE FF 5E CF D0 01 00 00 00 AA >> receive : 00 01 02 38 01 00 AA
