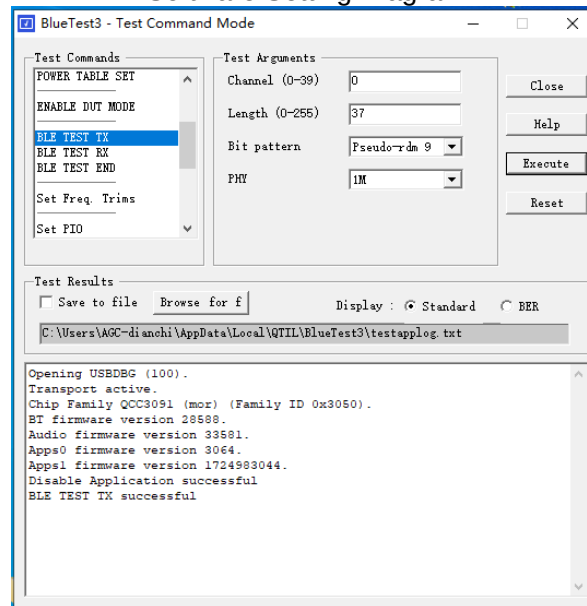

6. Duty Cycle Measurement

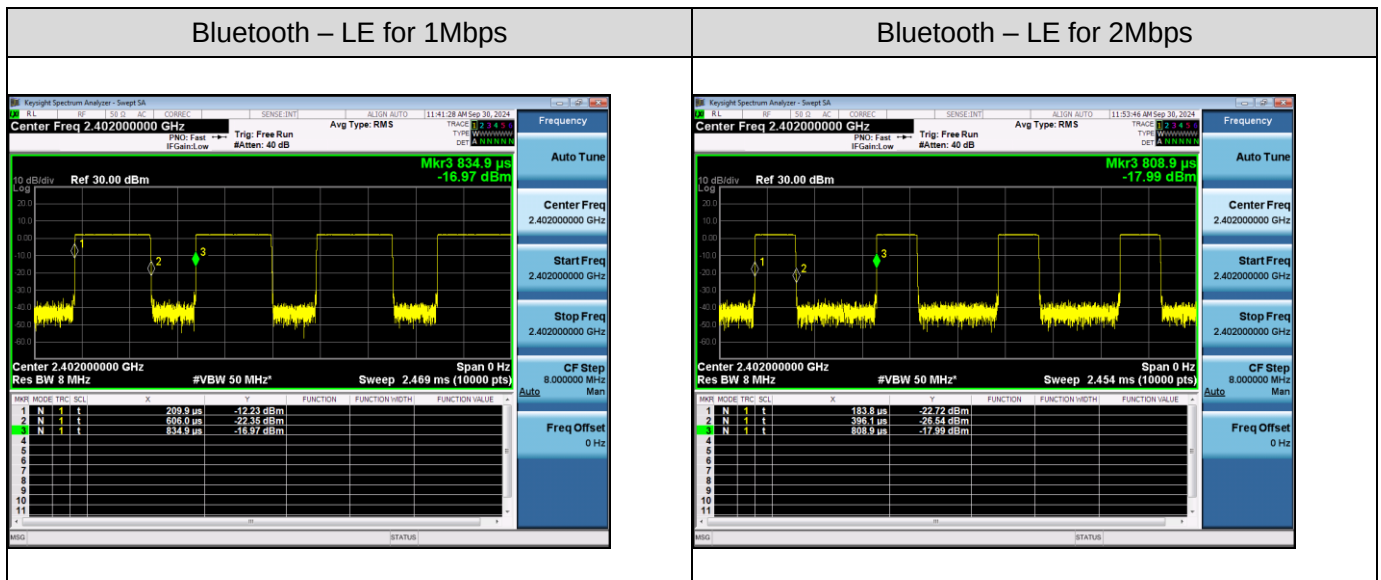
The maximum achievable duty cycles for all modes were determined based on measurements performed on a spectrum analyzer in zero-span mode with RBW = 8MHz, VBW = 50MHz, and detector = Peak. The RBW and VBW were both greater than 50/T, where T is the minimum transmission duration, and the number of sweep points across T was greater than 100. The duty cycles are as follows:

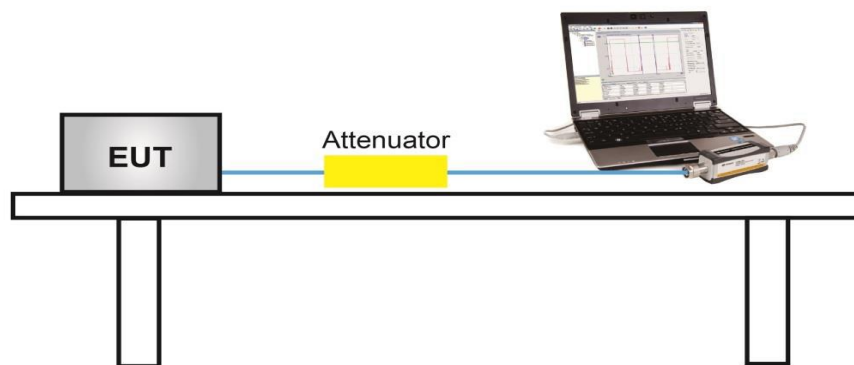
1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. Set the RBW $\geq$ DTS bandwidth
3. Set the VBW $\geq$ $[3 \times \text{RBW}]$.
4. Span $\geq$ $[3 \times \text{RBW}]$.
5. Sweep= auto couple.
6. Detector Function= Peak.
7. Trace mode= Max hold.
8. Allow trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. The indicated level is the peak output power, after any corrections for external attenuators and cables.

☐ For Average power, the testing follows ANSI C63.10 Section 11.9.2.3.2 Method AVGPM-G:

1. The RF output of EUT was connected to the power meter by RF cable and attenuator.
2. The path loss was compensated to the results for each measurement.

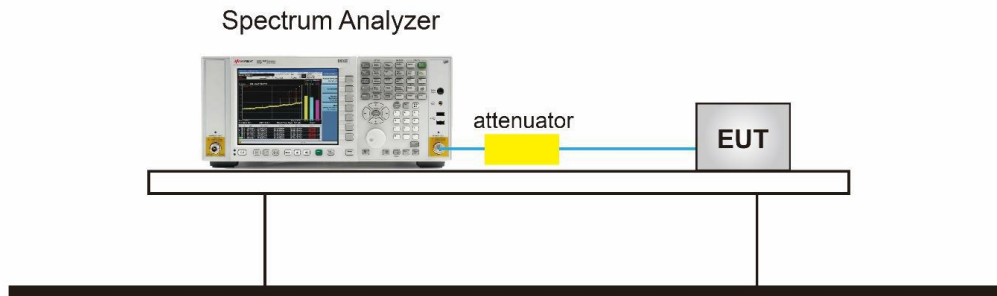

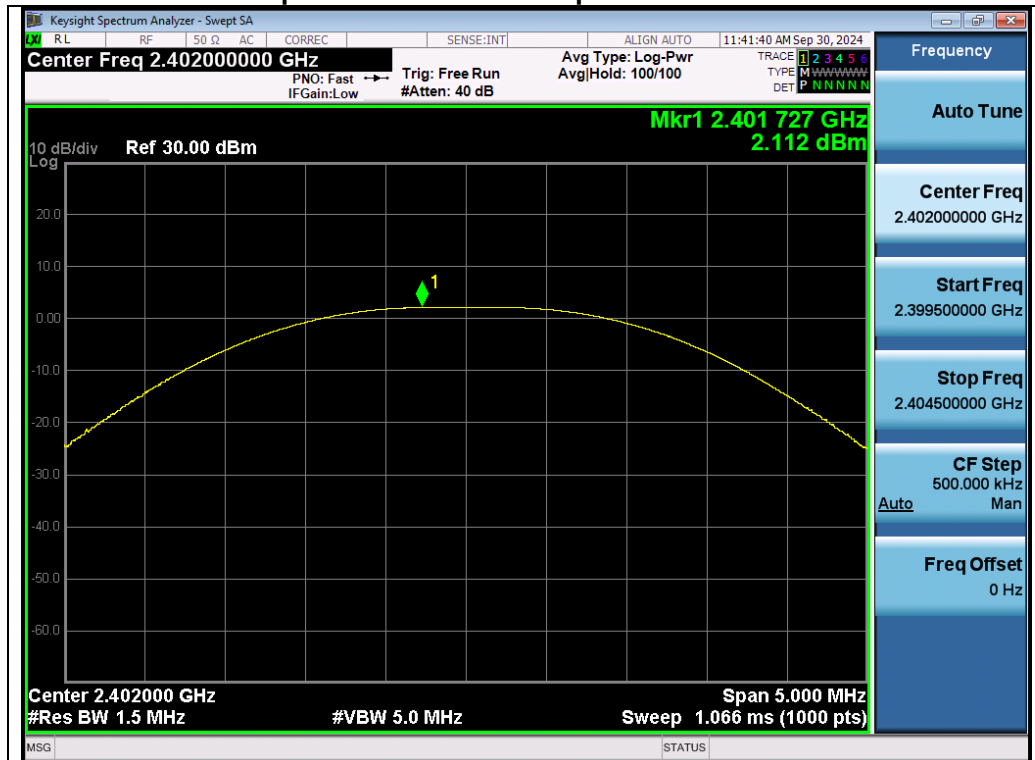

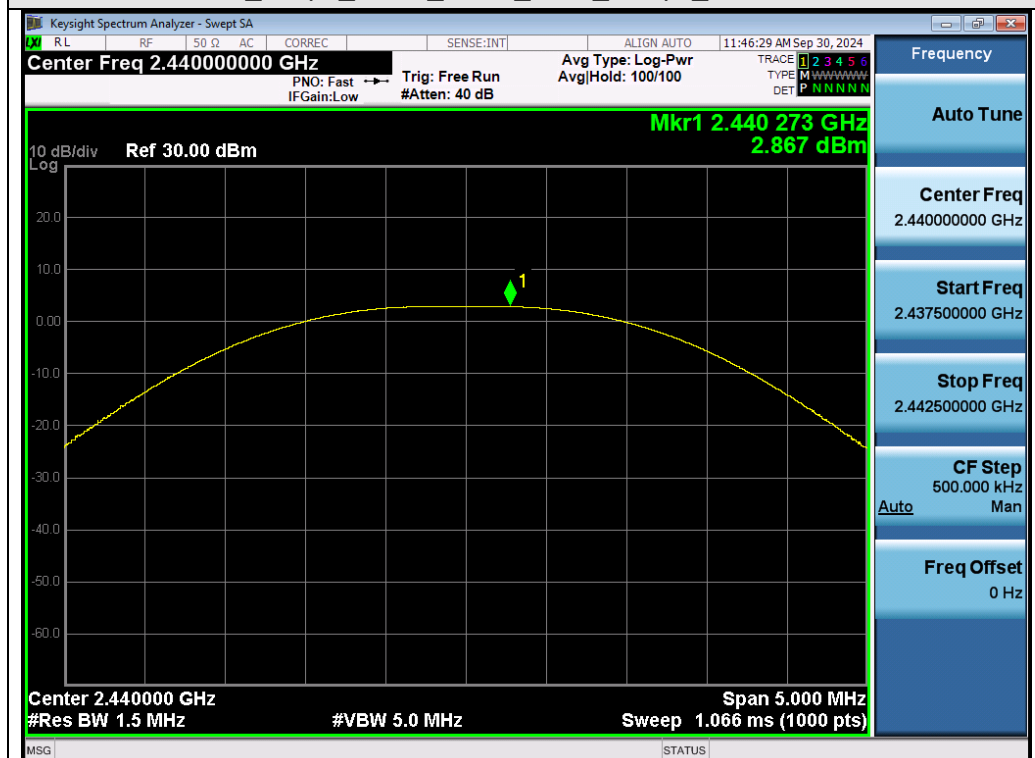

Test Graphs of Conducted Output Power-Left headset

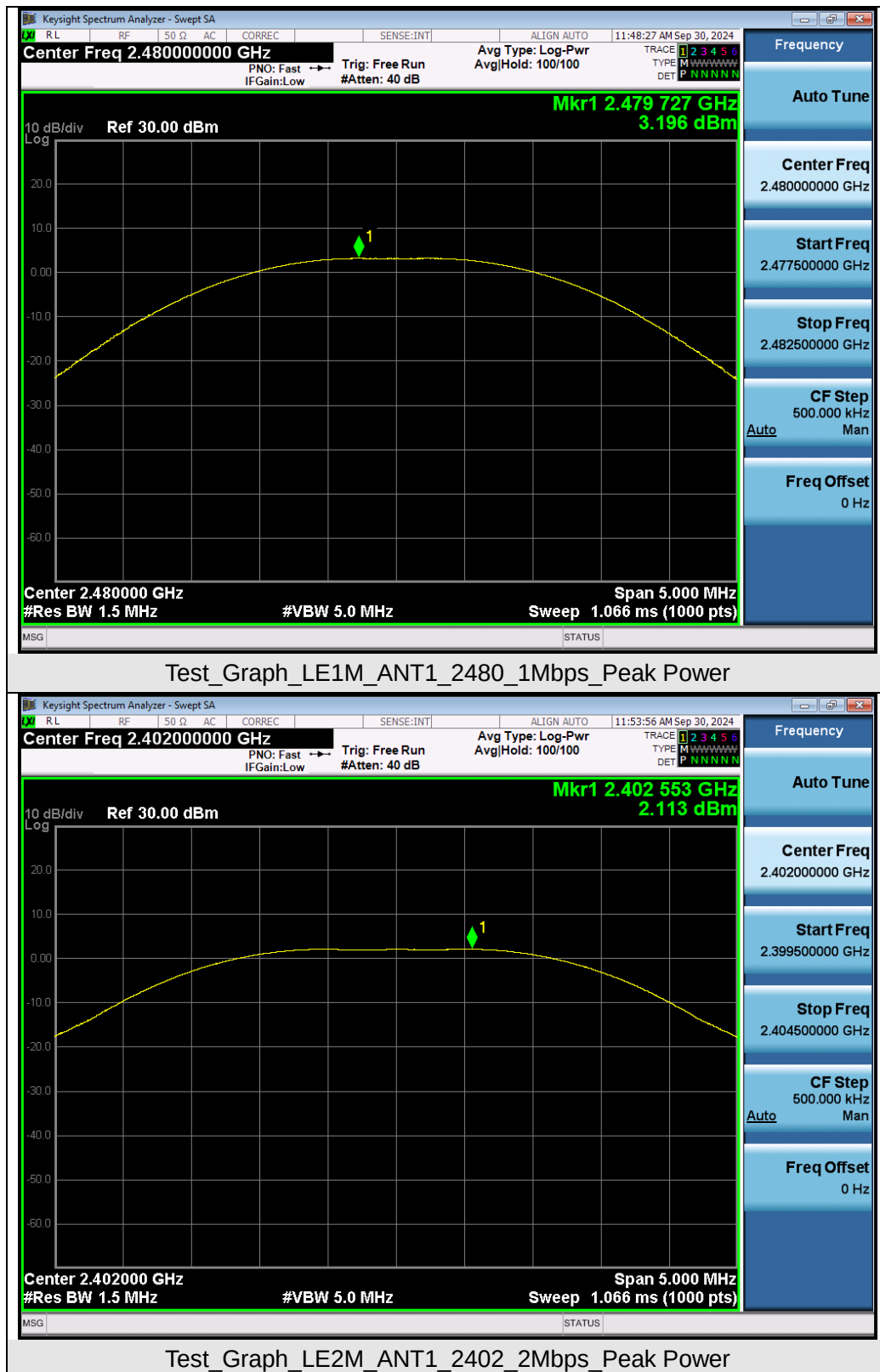

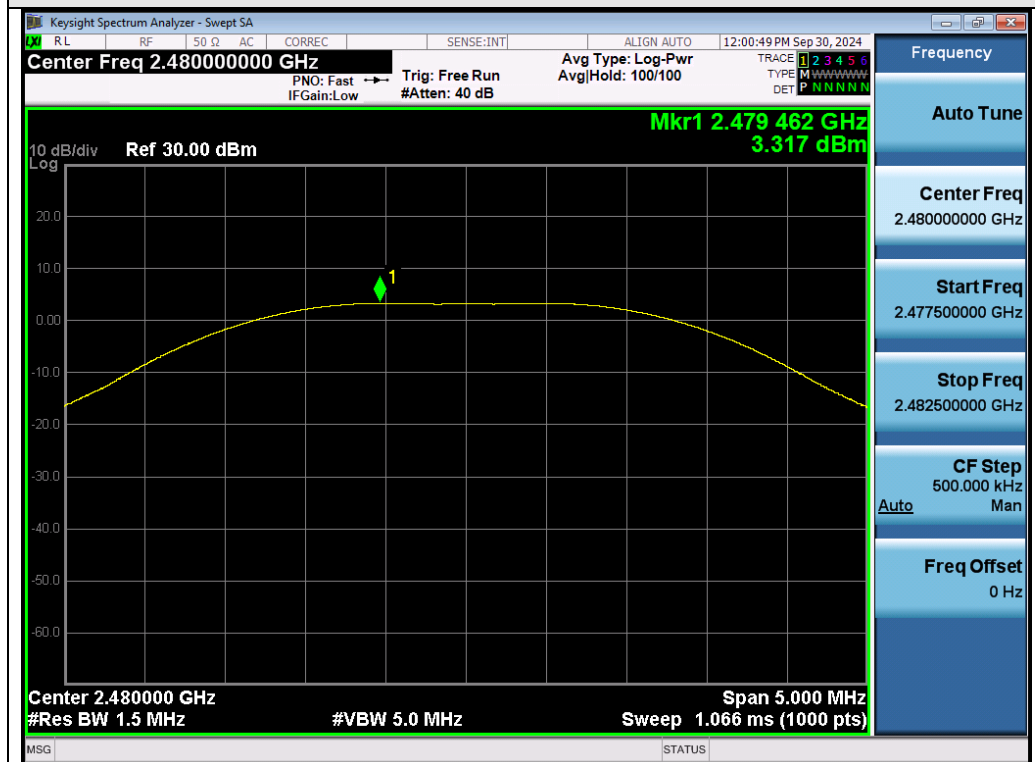
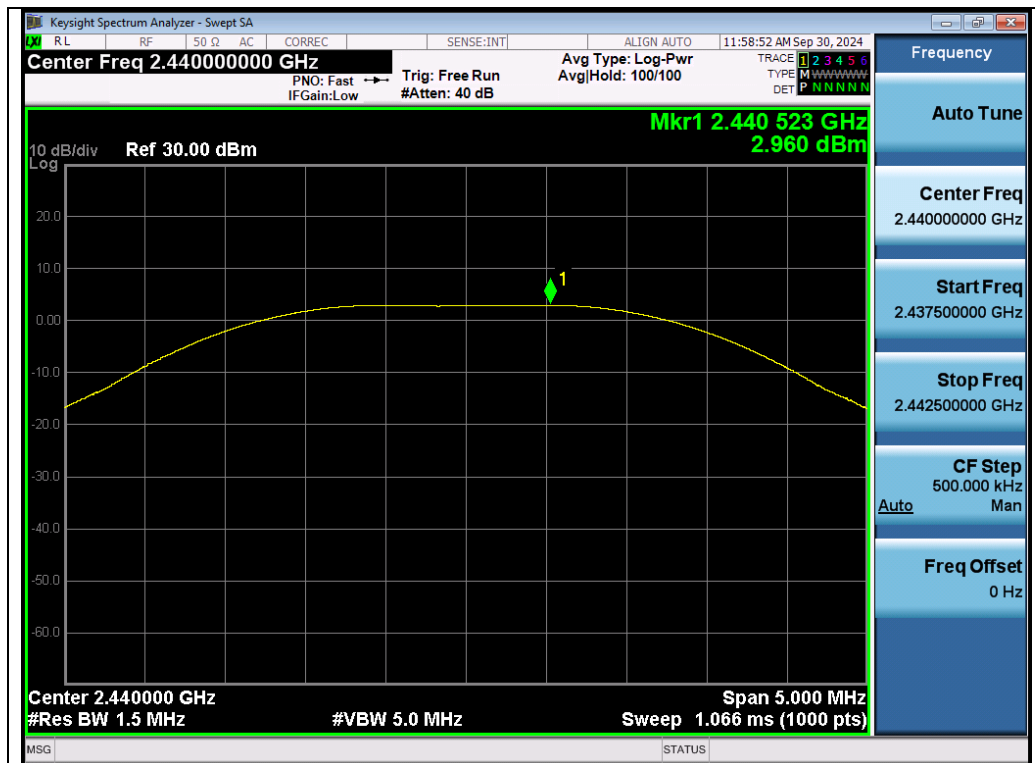


Test_Graph_LE1M_ANT1_2440_1Mbps_Peak Power

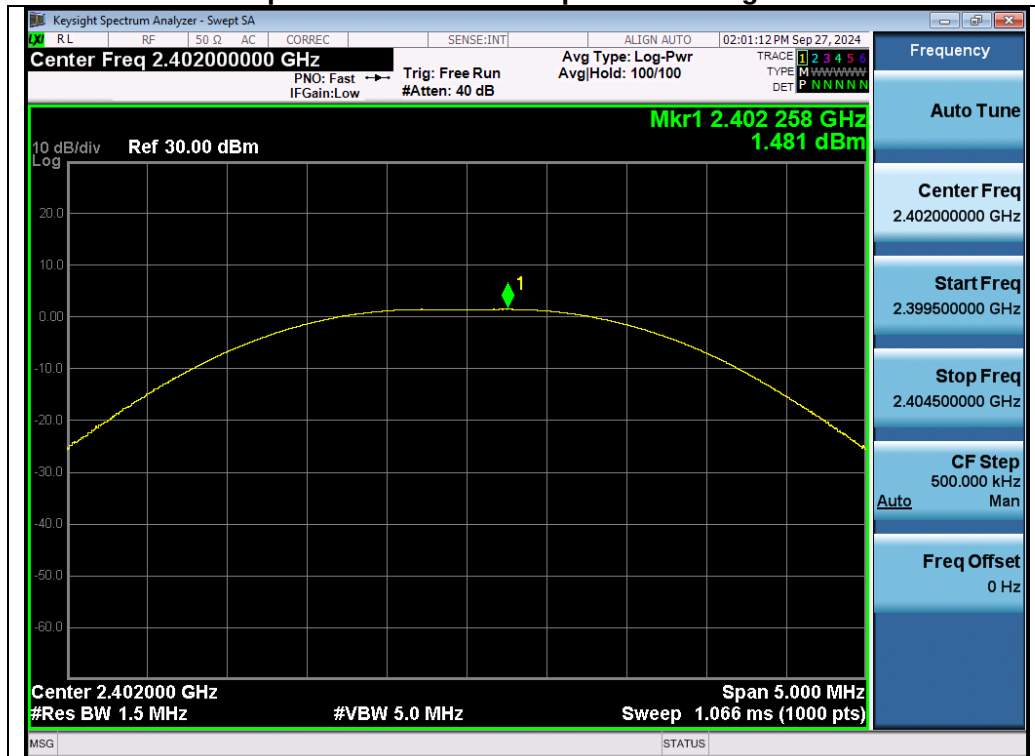

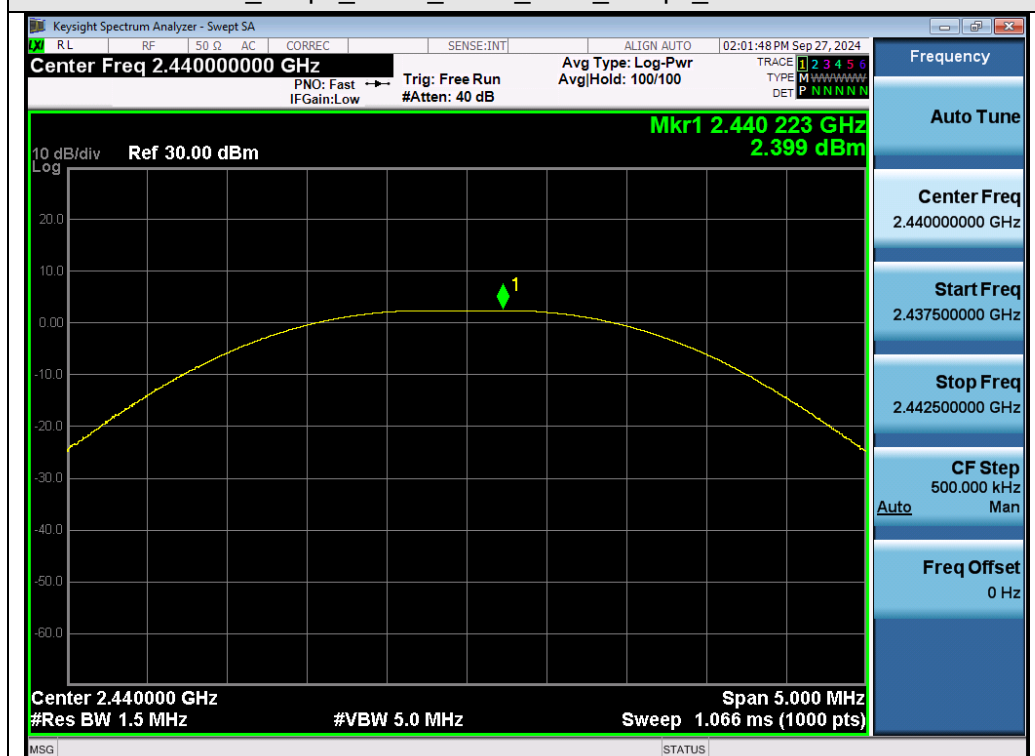

Test Graphs of Conducted Output Power- Right headset

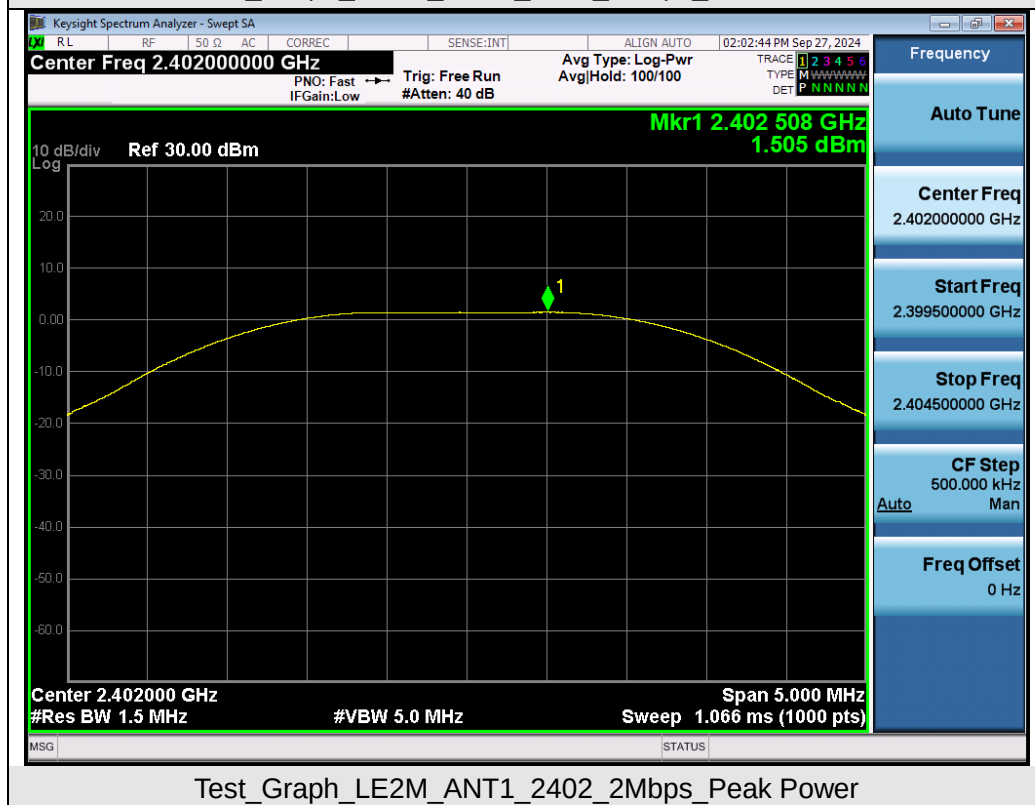
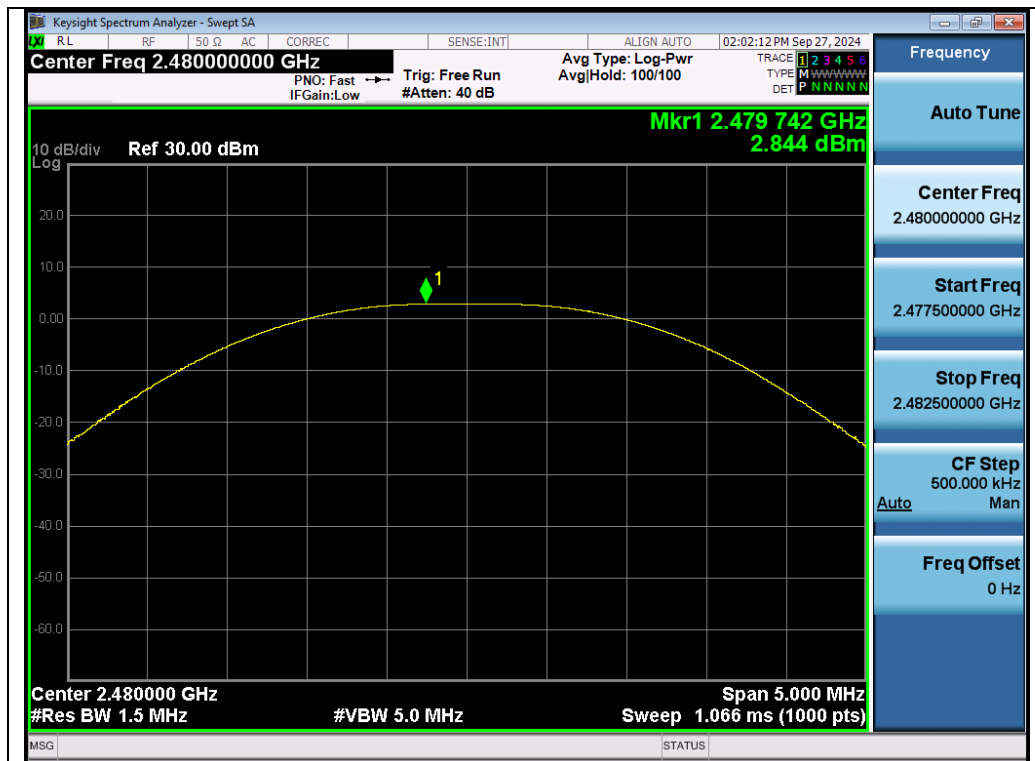


Test_Graph_LE1M_ANT1_2402_1Mbps_Peak Power

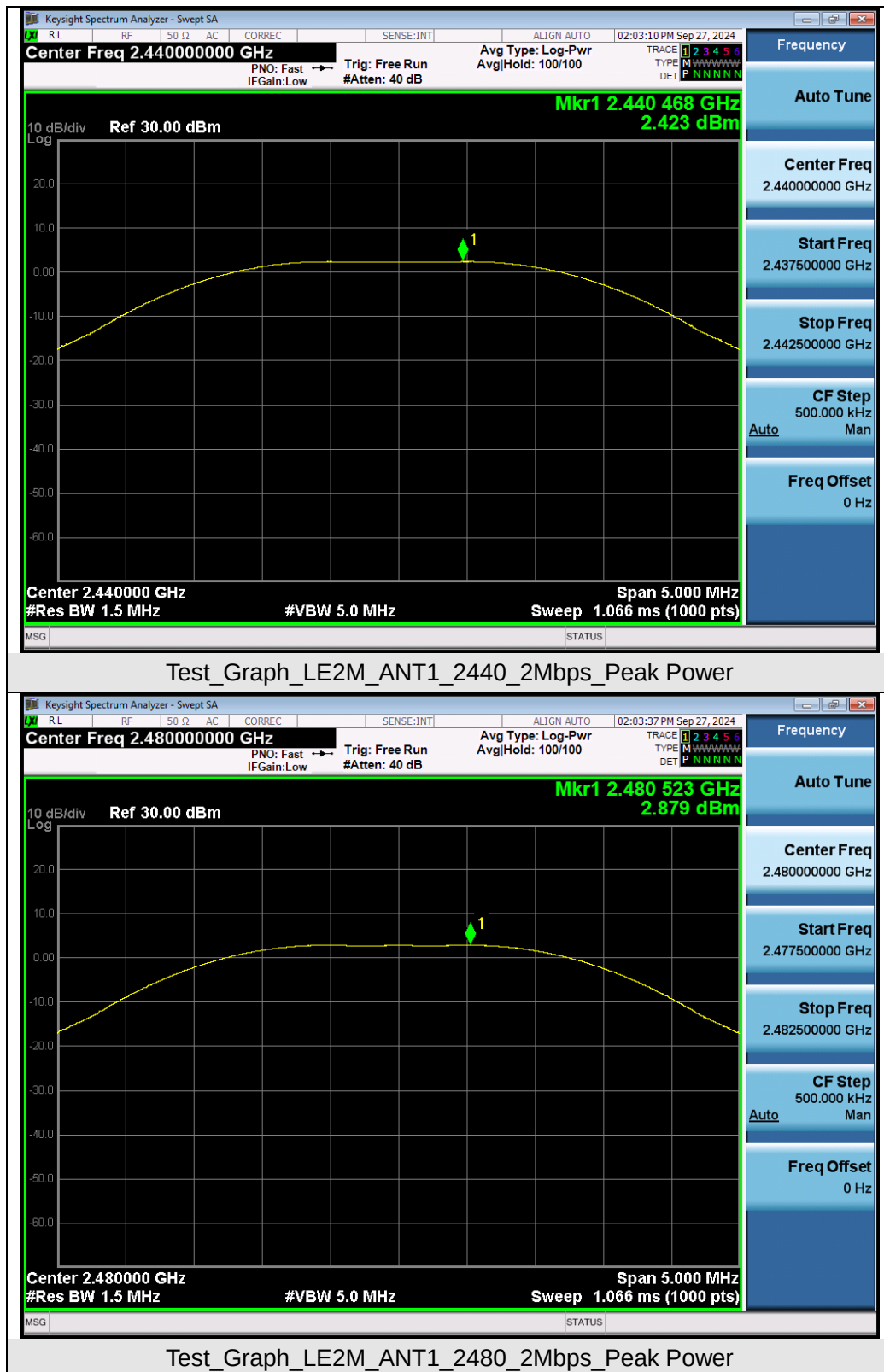


Test_Graph_LE1M_ANT1_2440_1Mbps_Peak Power

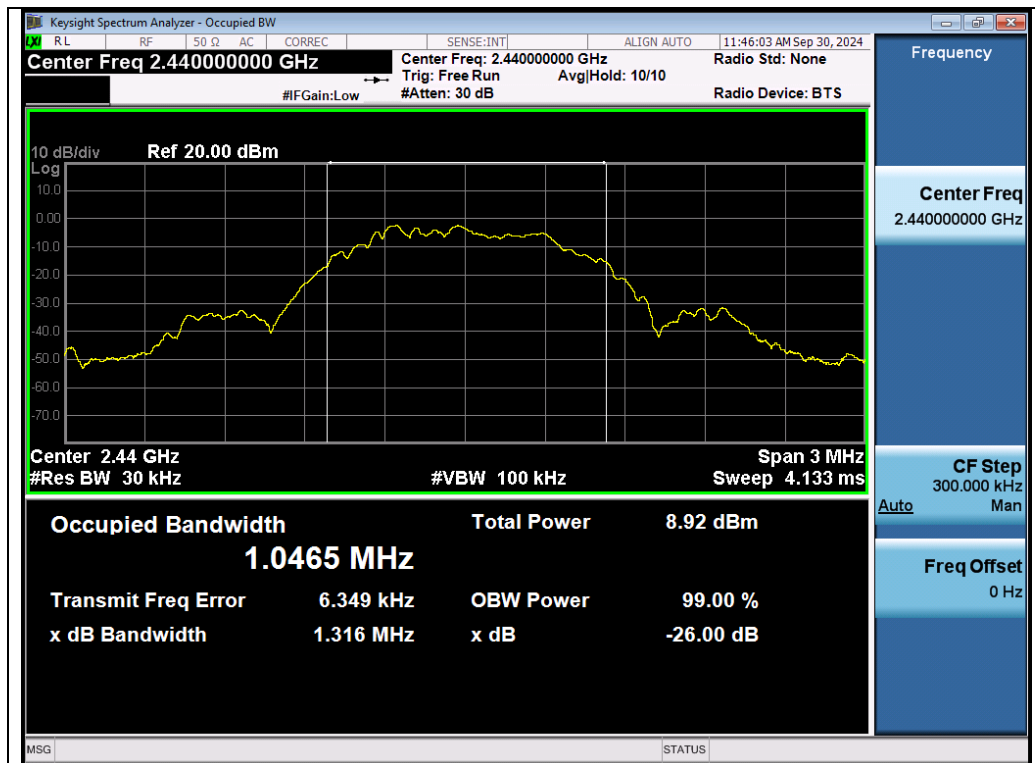

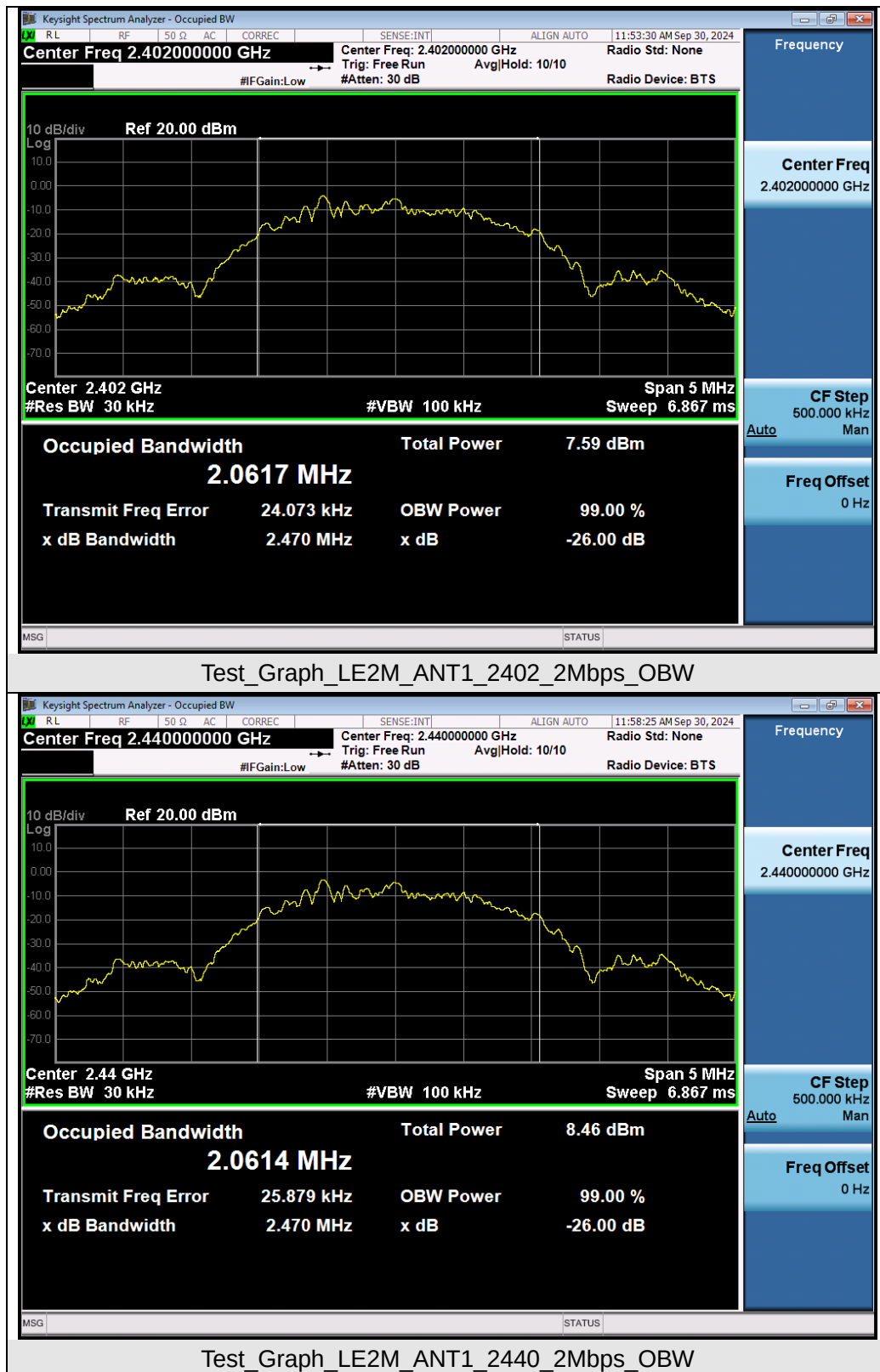


Test_Graph_LE1M_ANT1_2440_1Mbps_OBW

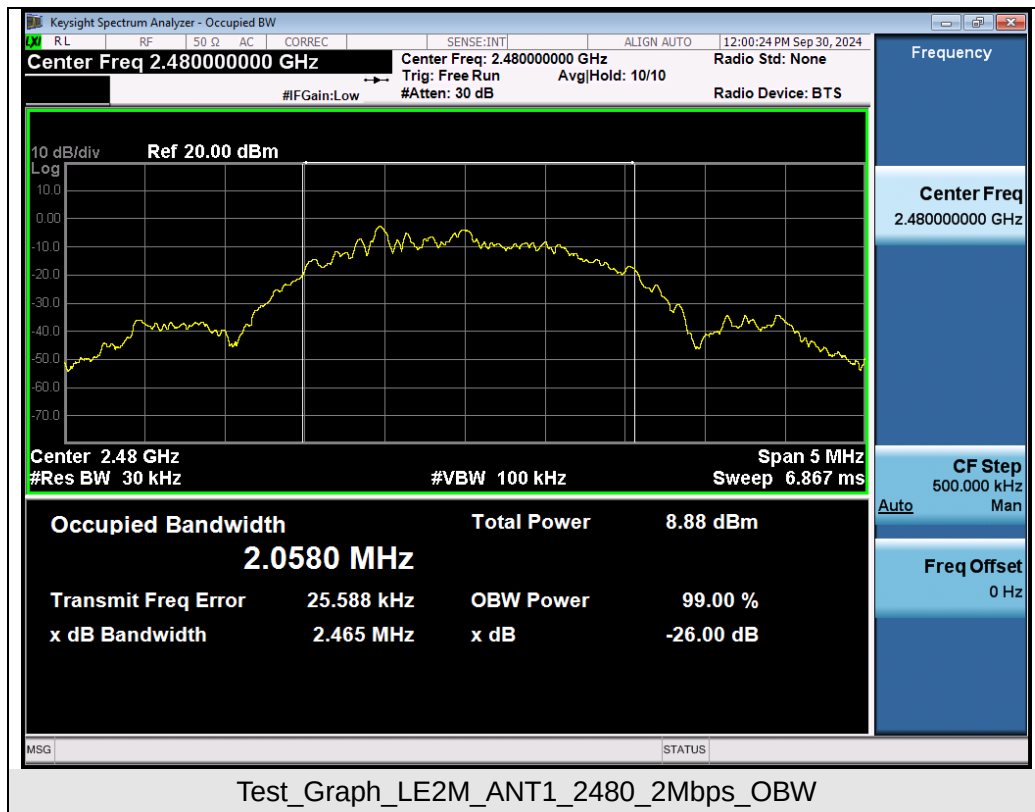


Test_Graph_LE1M_ANT1_2480_1Mbps_OBW

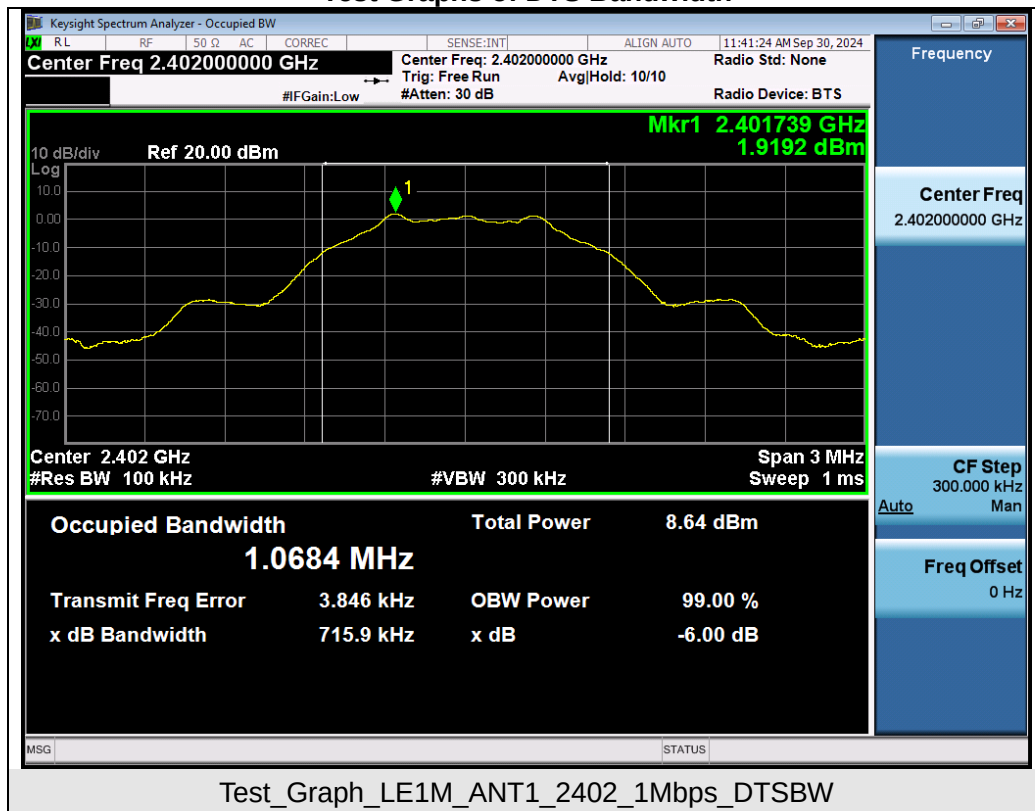

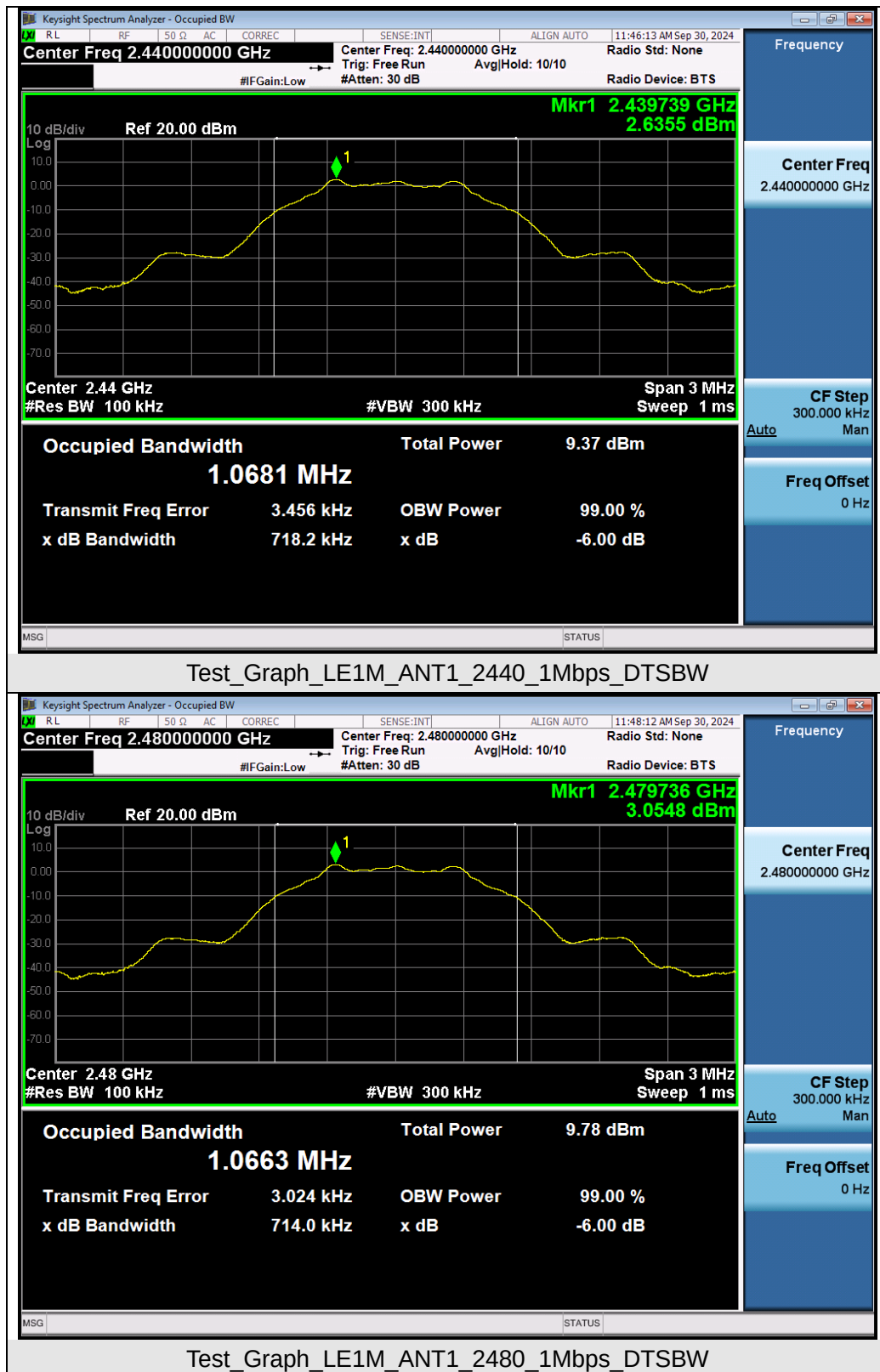

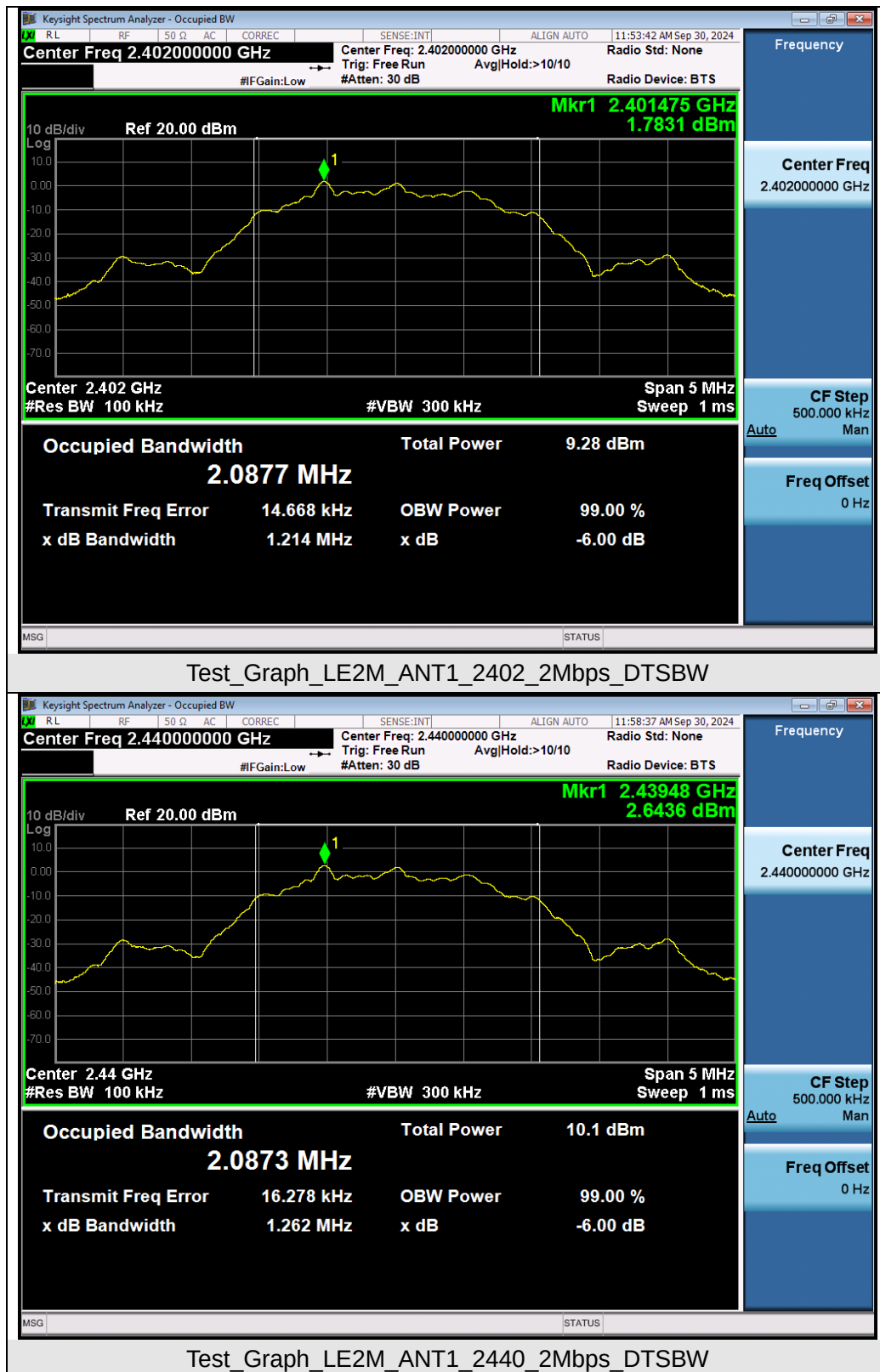
Test Graphs of DTS Bandwidth



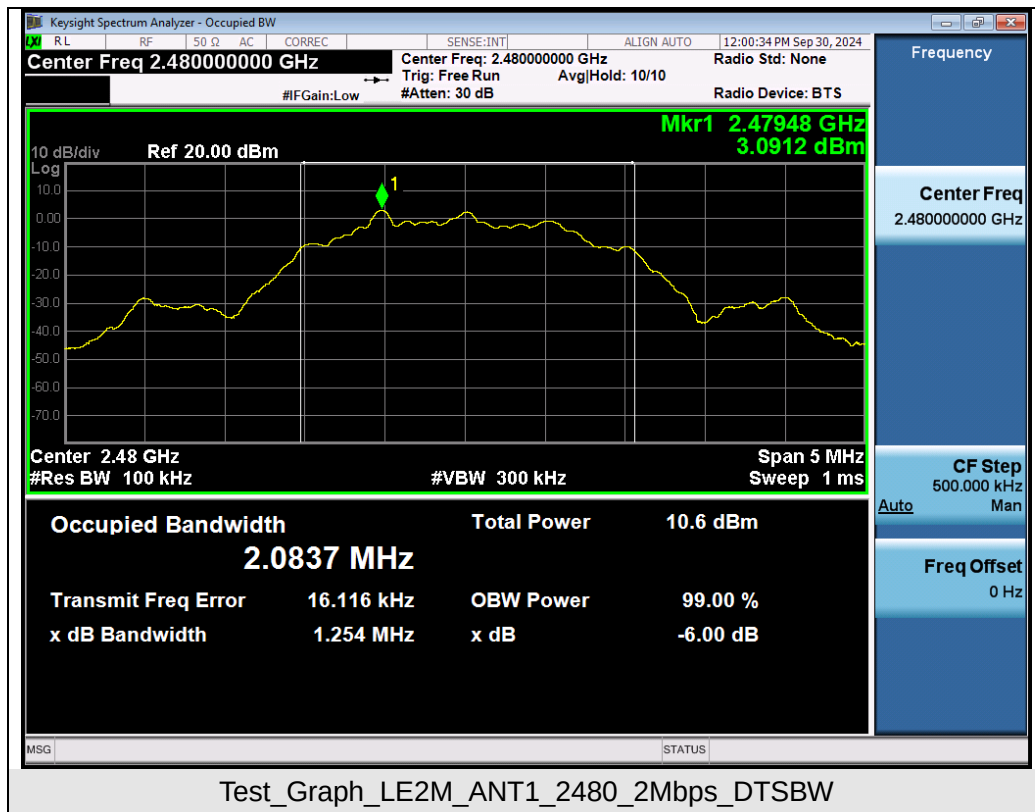

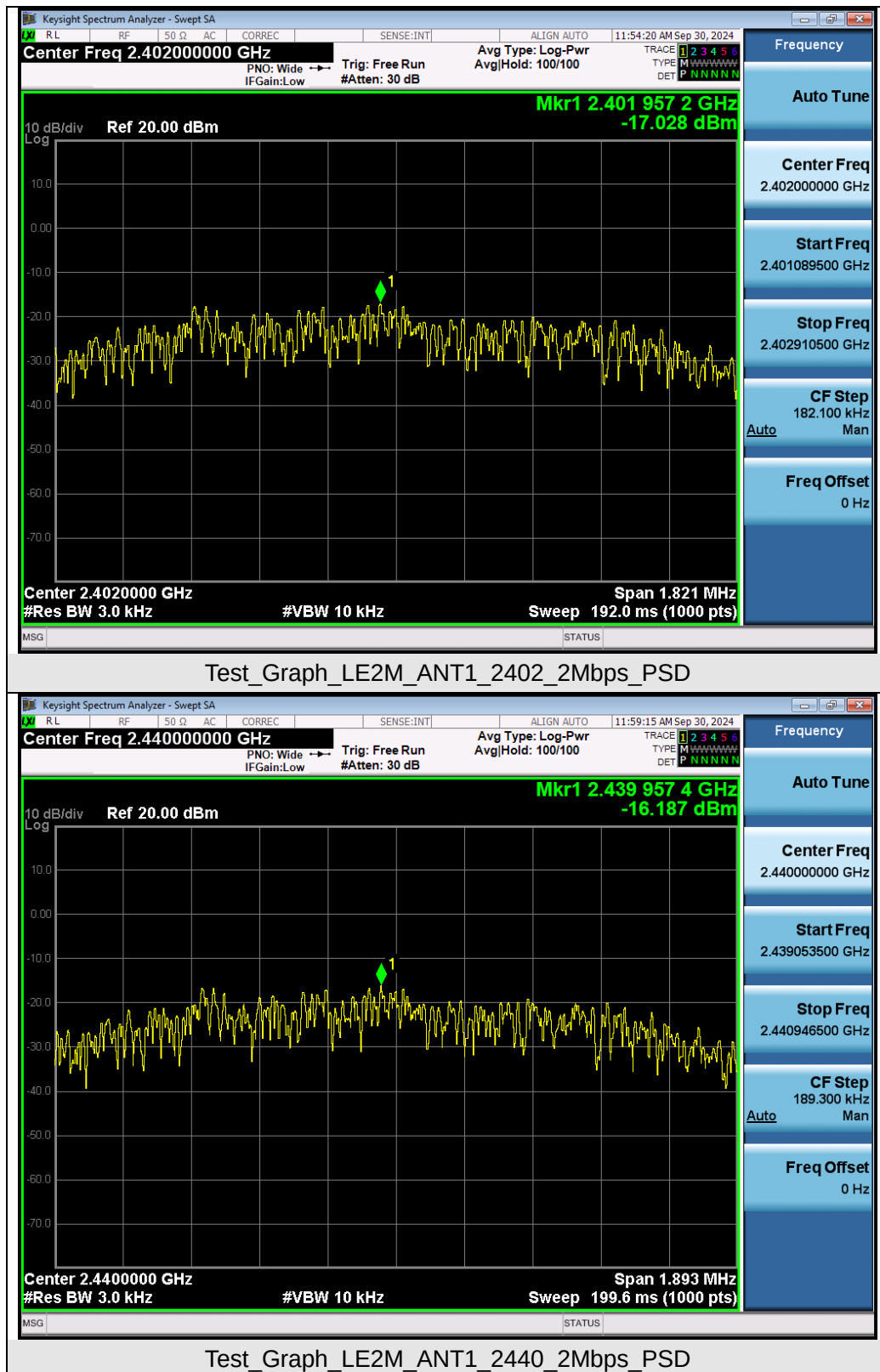
Test Graphs of Conducted Output Power Spectral Density



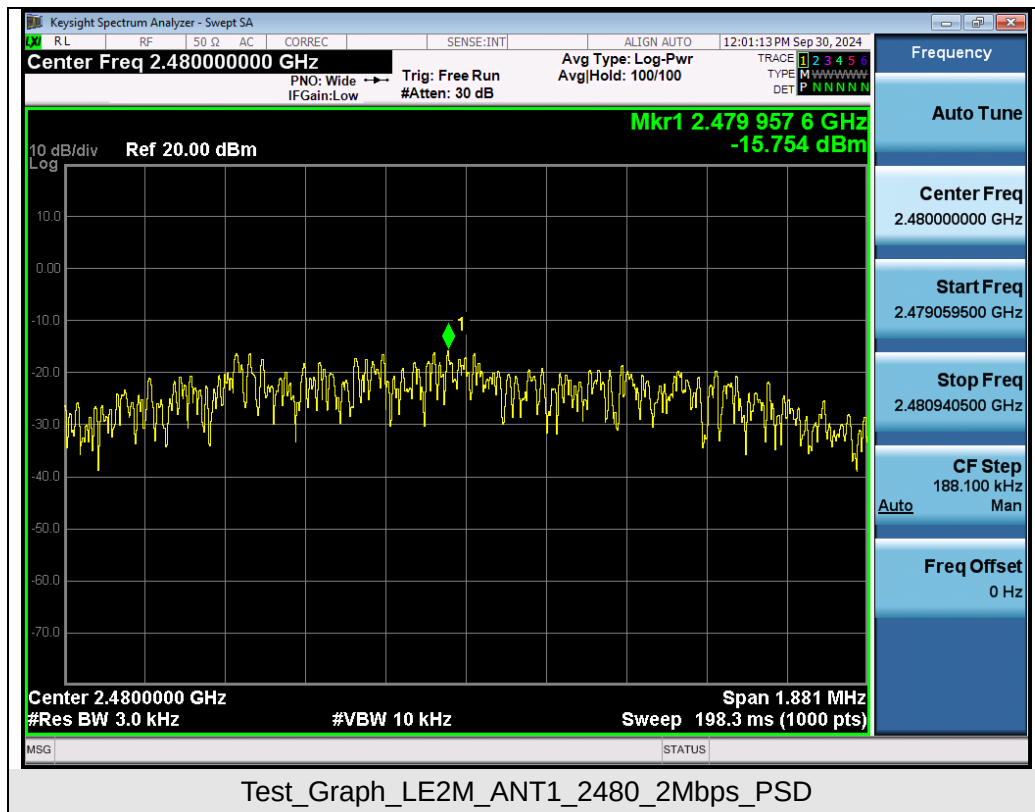

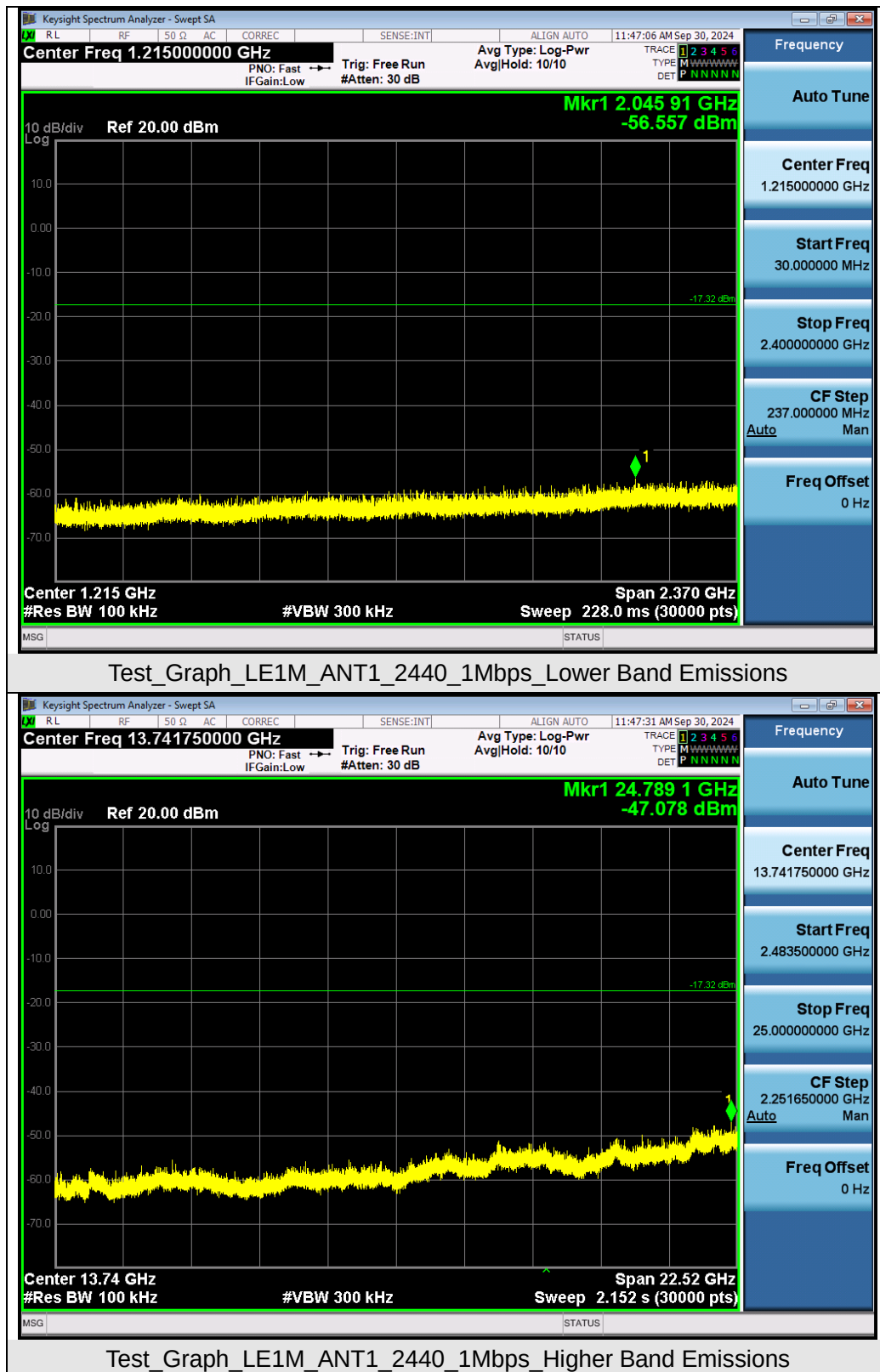
Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands



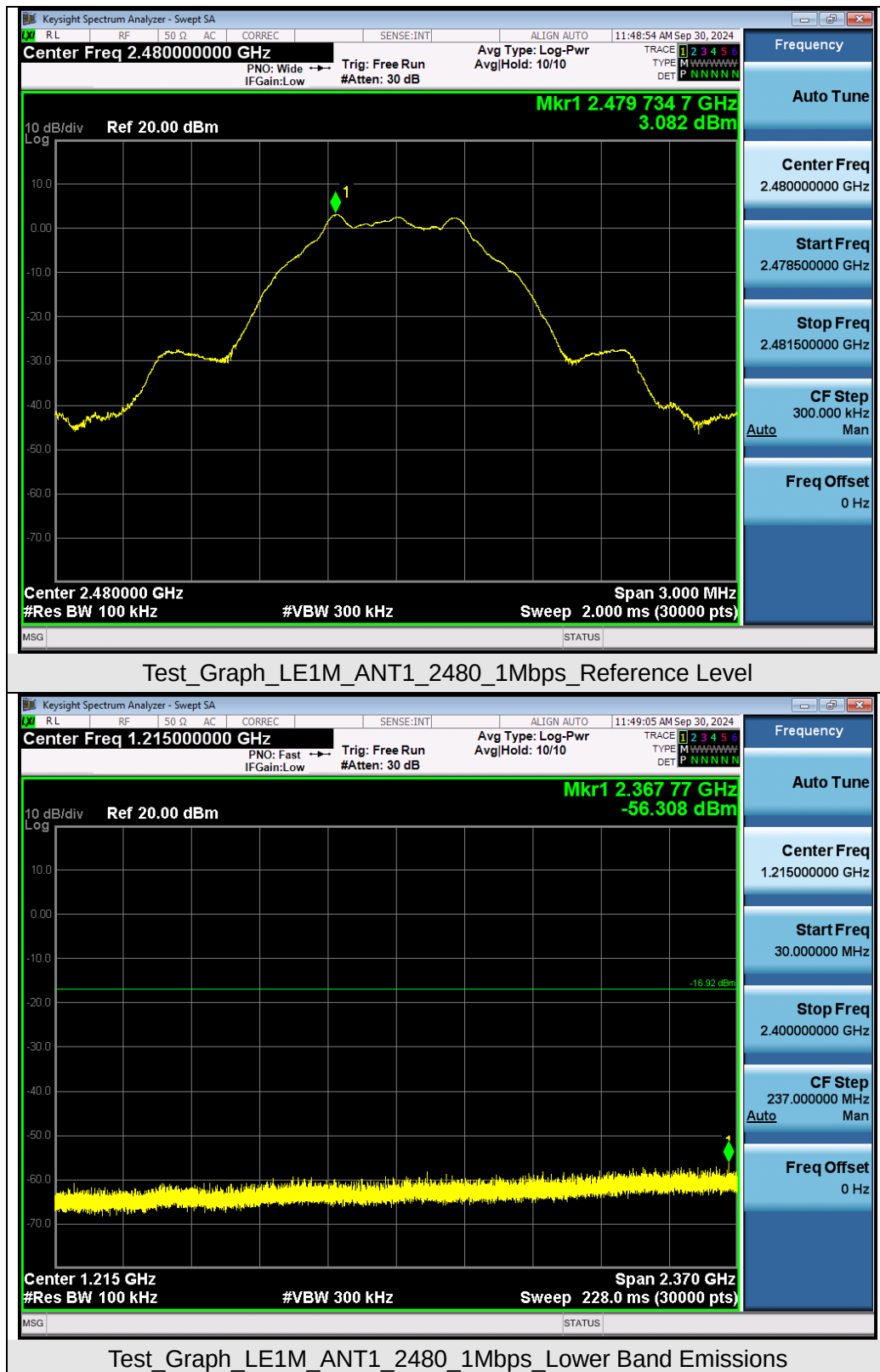

Test Graphs of Band Edge Emissions in Non-Restricted Frequency Bands

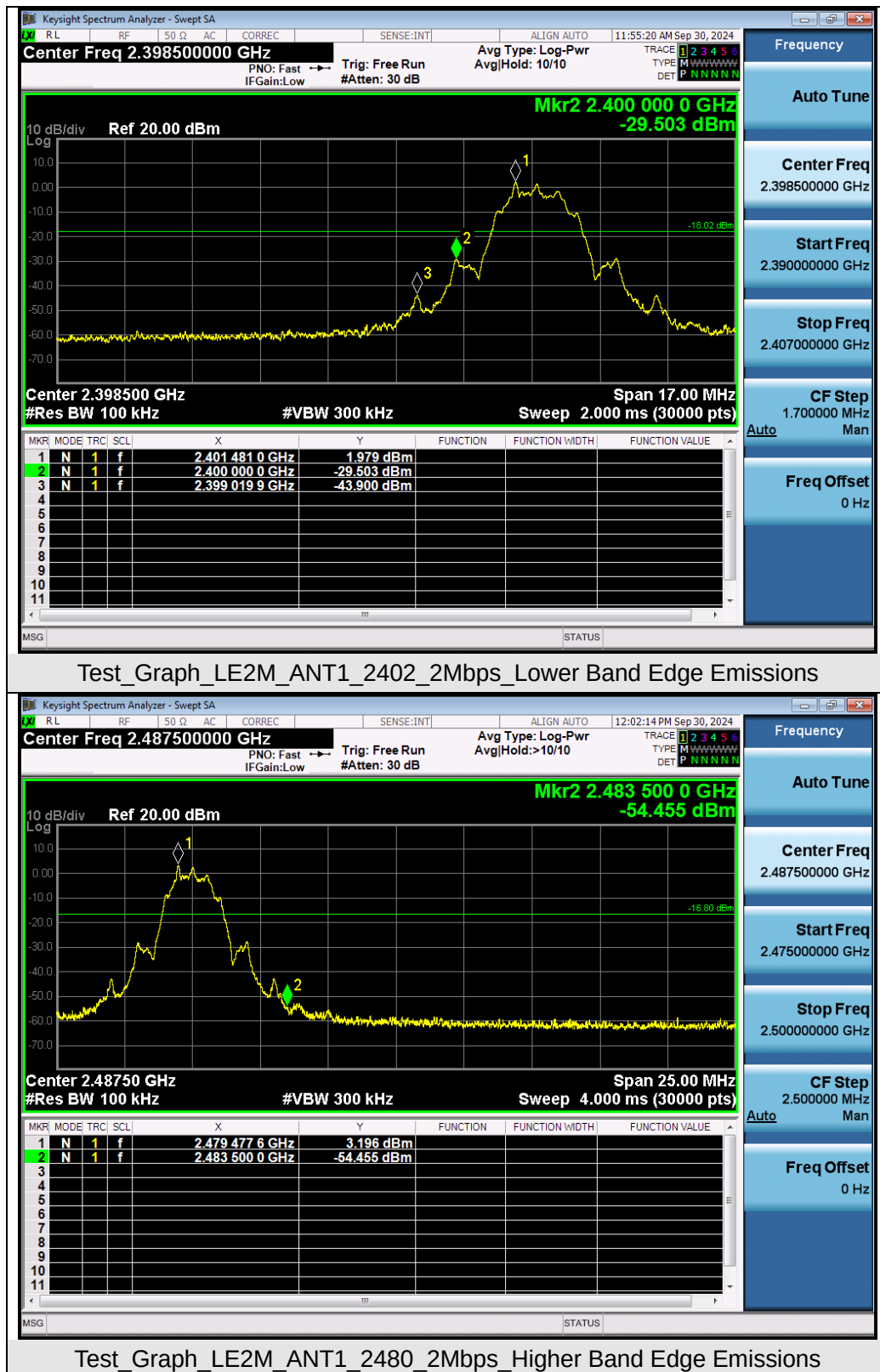


Test_Graph_LE1M_ANT1_2402_1Mbps_Lower Band Edge Emissions

11.2 Measurement Procedure

1. The EUT was placed on the top of the turntable 0.8 or 1.5 meter above ground. The phase center of the receiving antenna mounted on the top of a height-variable antenna tower was placed 3 meters far away from the turntable.
2. Power on the EUT and all the supporting units. The turntable was rotated by 360 degrees to determine the position of the highest radiation.
3. The height of the broadband receiving antenna was varied between one meter and four meters above ground to find the maximum emissions field strength of both horizontal and vertical polarization.
4. For each suspected emission, the antenna tower was scan (from 1 M to 4 M) and then the turntable was rotated (from 0 degree to 360 degrees) to find the maximum reading.
5. Set the test-receiver system to Peak or CISPR quasi-peak Detect Function with specified bandwidth under Maximum Hold Mode.
6. For emissions above 1GHz, use 1MHz RBW and 3MHz VBW for peak reading. Place the measurement antenna away from each area of the EUT determined to be a source of emissions at the specified measurement distance, while keeping the measurement antenna aimed at the source of emissions at each frequency of significant emissions, with polarization oriented for maximum response. The measurement antenna may have to be higher or lower than the EUT, depending on the radiation pattern of the emission and staying aimed at the emission source for receiving the maximum signal. The final measurement antenna elevation shall be that which maximizes the emissions. The measurement antenna elevation for maximum emissions shall be restricted to a range of heights of from 1 m to 4 m above the ground or reference ground plane.
7. When the radiated emissions limits are expressed in terms of the average value of the emissions, and pulsed operation is employed, the measurement field strength shall be determined by averaging over one complete pulse train, including blanking intervals, as long as the pulse train does not exceed 0.1 seconds.
8. As an alternative (provided the transmitter operates for longer than 0.1 seconds) or in cases where the

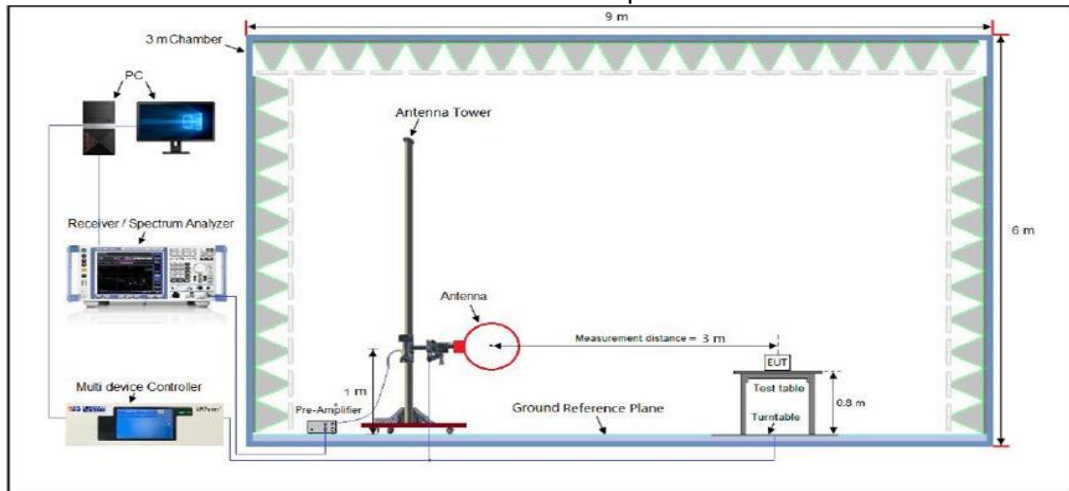

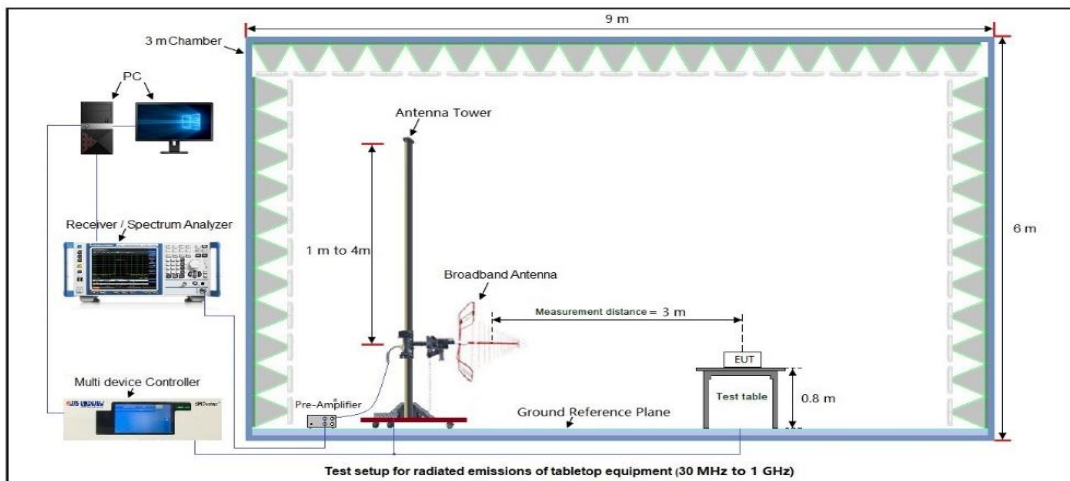

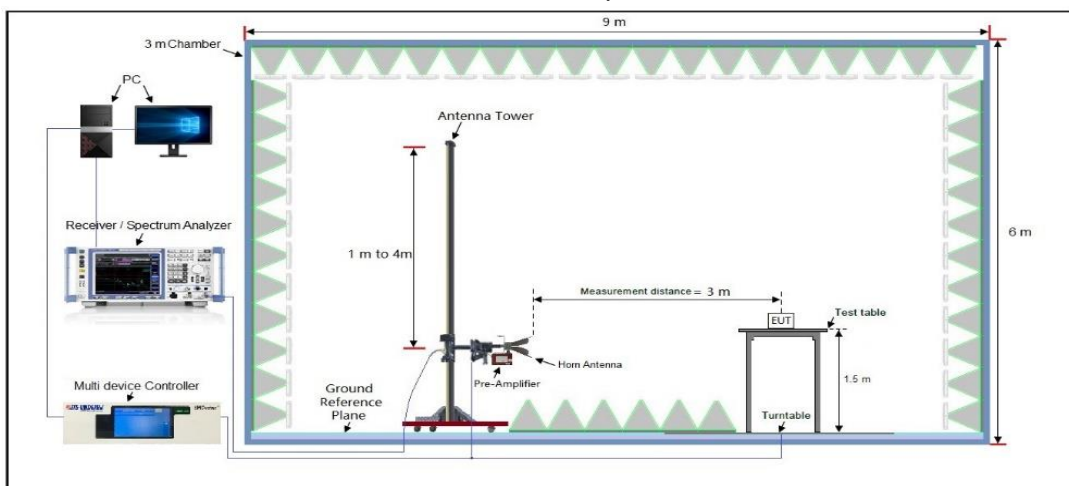
Radiated Emission Test Setup 9kHz-30MHz

Radiated Emission Test Setup Above 1000MHz

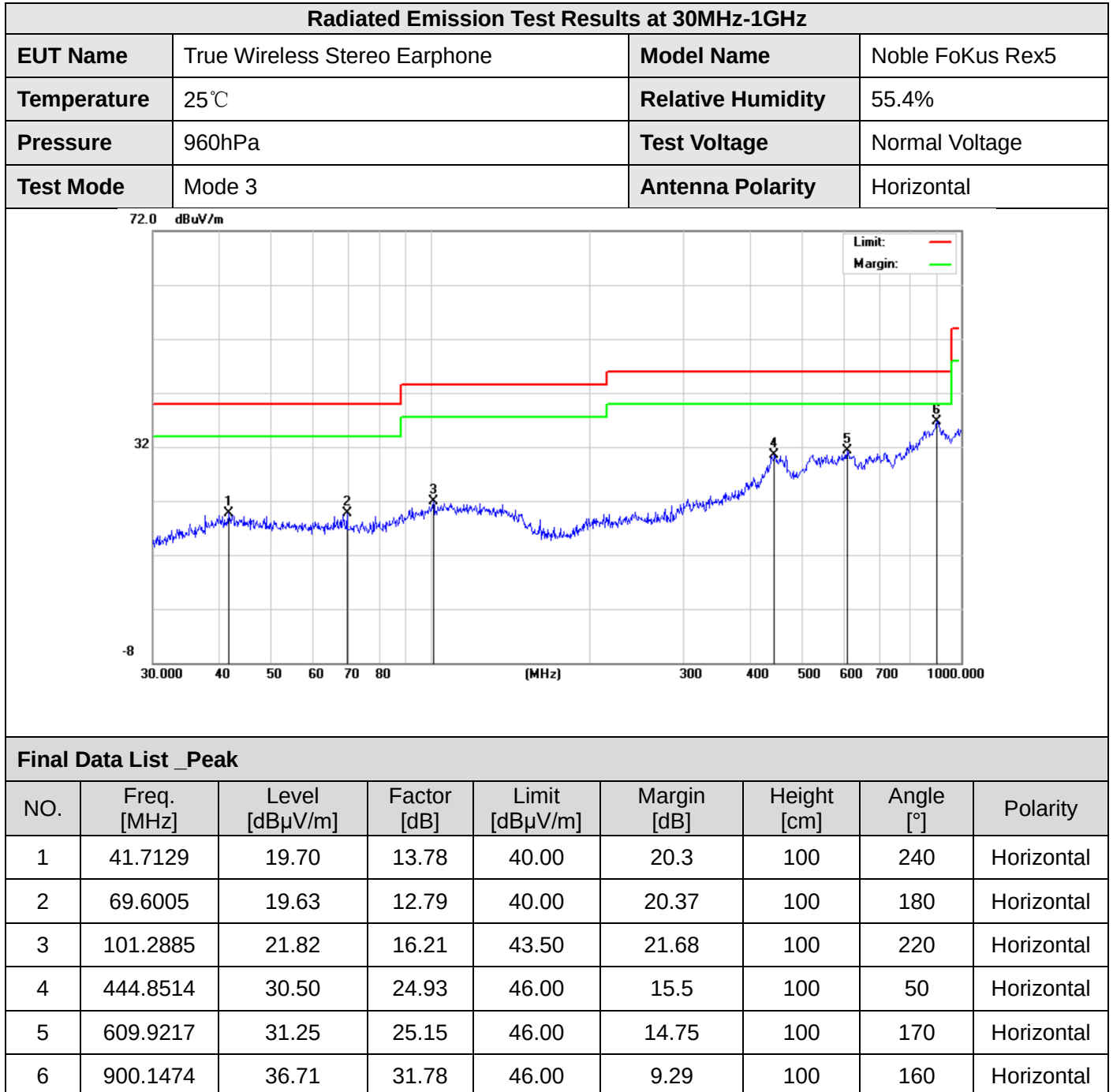

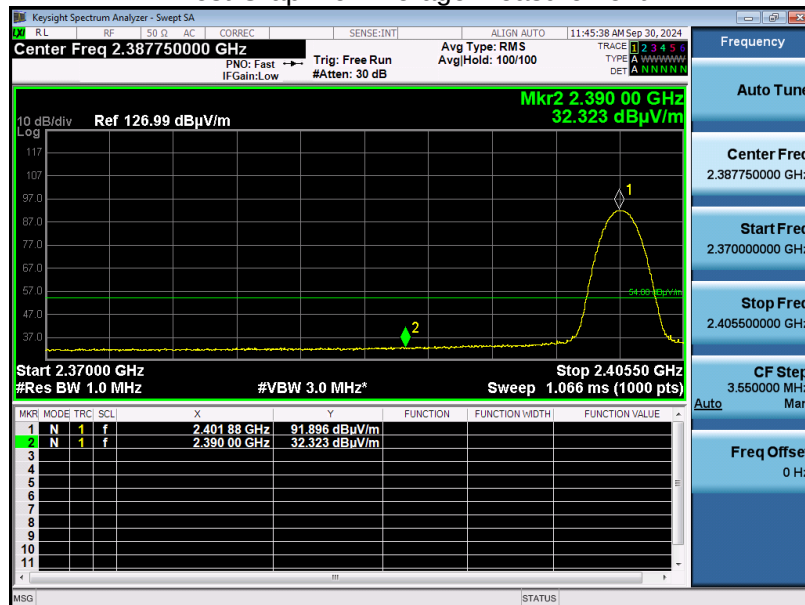

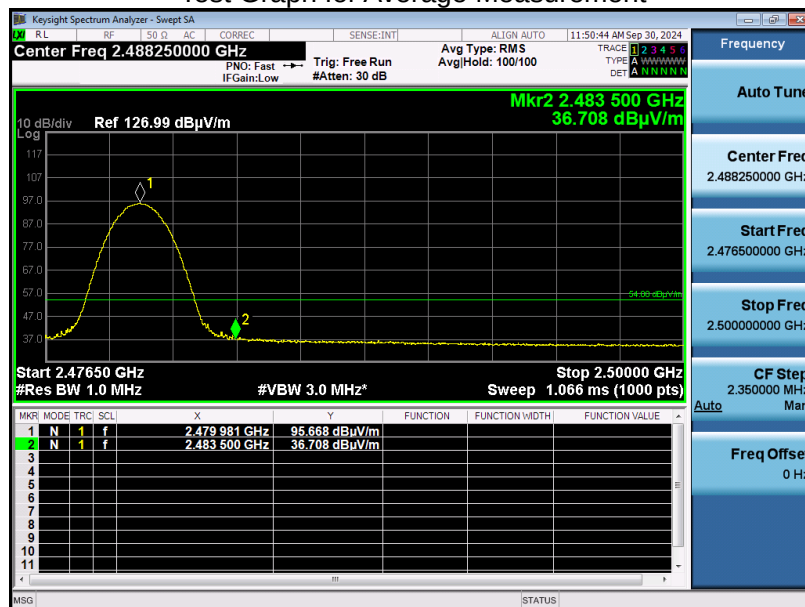

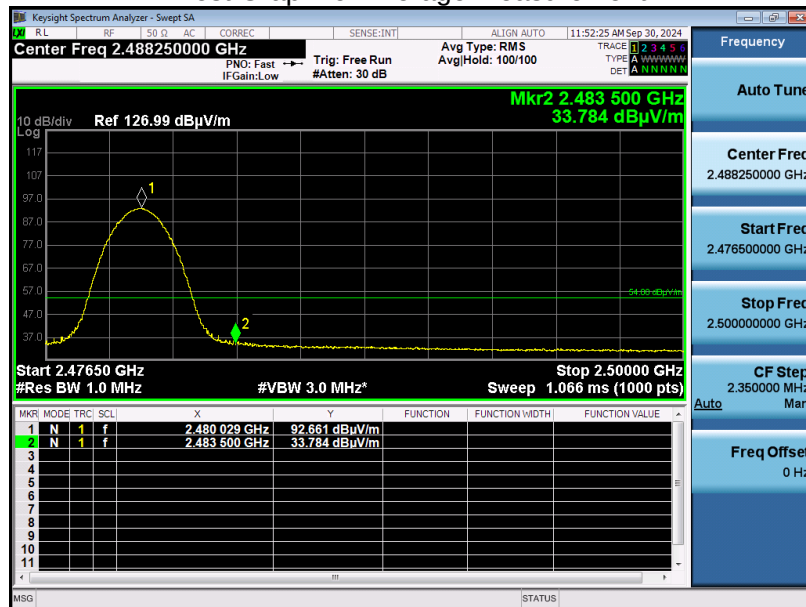
