All RF parameters remain the same as before. The main measuring model is WS-MC-20, only the results for WS-MC-20 was recorded in this report.

## 2. Device Category and RF Exposure Limit

Per user manual, this device is a DIGITAL MEDIA RECEIVER. Based on 47CFR 2.1093, this device belongs to portable device category with General Population/Uncontrolled exposure. **Portable Devices:**

## 4. RF Exposure Evaluation

#### > Standalone Transmission SAR Evaluation:

- According to KDB 447498 section 4.3.1, the 1-g SAR test exclusion thresholds at test separation Distances≤ 50 mm are determined by: [(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)]·[√f(GHz)] ≤ 3.0.
  - f(GHz) is the RF channel transmit frequency in GHz
  - · Power and distance are rounded to the nearest mW and mm before calculation
  - $\cdot$  The result is rounded to one decimal place for comparison
- 2. When the device is used, 5mm as the most conservative minimum test separation distance was used for evaluating.
