SET UP WITH APPLE FIND MY

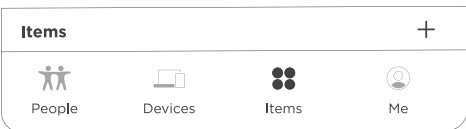
- Update your iPhone to the latest version of iOS. Activate Bluetooth on your iPhone.
- Check the drawing below to locate the button. Press your LOC8 Finder Passport Wallet 2 button once. You will hear a beep sound, indicating your device is ready for pairing.



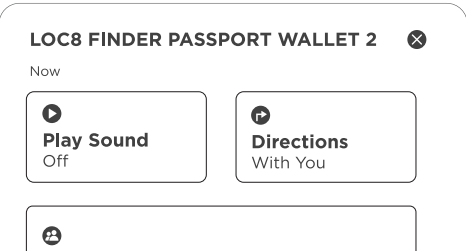
- Open the Apple Find My app.
- Tap "+"; select "Add Other Item"; LOC8 Finder Passport Wallet 2 will show up on the screen for pairing.

LOCATE LOC8 FINDER PASSPORT WALLET 2

- In "Find My" app, tap "Items".



- Check your LOC8 Finder Passport Wallet 2's last known time and place.
- Click and select the LOC8 Finder Passport Wallet 2 from the list.
- Tap "Play Sound" and listen for a chime.
- For distant items, click "Directions". Open Maps to navigate to the last-known location.



USE LOST MODE

- If you can't find your LOC8 Finder Passport Wallet 2, enable Lost Mode. This will trigger Find My App notifications when your card is nearby.
- Tap "Continue".
- Follow the on-screen steps to finish setting up Lost Mode.

Your LOC8 Finder Passport Wallet 2 will stay linked to your Apple ID, unless you unpair it. If someone finds your item while it is in Lost Mode, they can use their iPhone or any NFC-capable device to reach you.

TROUBLESHOOTING

This device can be reset if you have trouble pairing the card with your iPhone, or if you want to unpair it and give it to someone else.

To reset:

- Hold down the button for 10 seconds.
- Release the button when you hear the ringtone sound five times.
- You can repeat this step in "SETUP WITH APPLE'S FIND MY APP" to pair the LOC8 Finder Passport Wallet 2 with your iPhone.

CHARGING YOUR LOC8 FINDER PASSPORT WALLET 2

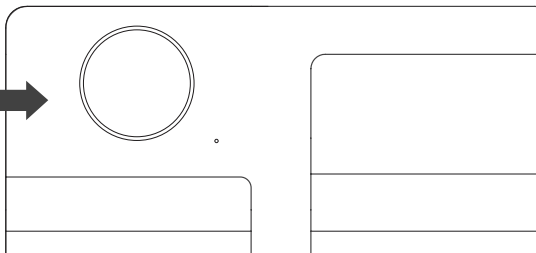
To charge your LOC8 Finder Passport Wallet 2, unfold the wallet and flip it down so that the inside circle ring faces down on the wireless charging pad. Ensure the ring is centered on the pad for proper alignment.

The wallet is compatible with chargers delivering 2.5W or more.

When the battery level is low, you will receive an urgent beep sound from LOC8 Finder Passport Wallet 2. The Find My app will send a notification to your phone to remind you that the product's battery is low. You can also check the battery level of the LOC8 Finder Passport Wallet 2 in the Find My app.

To charge the product, simply place it on the wireless charging pad. Rechargeable battery lasts up to 4 months on a full charge.
