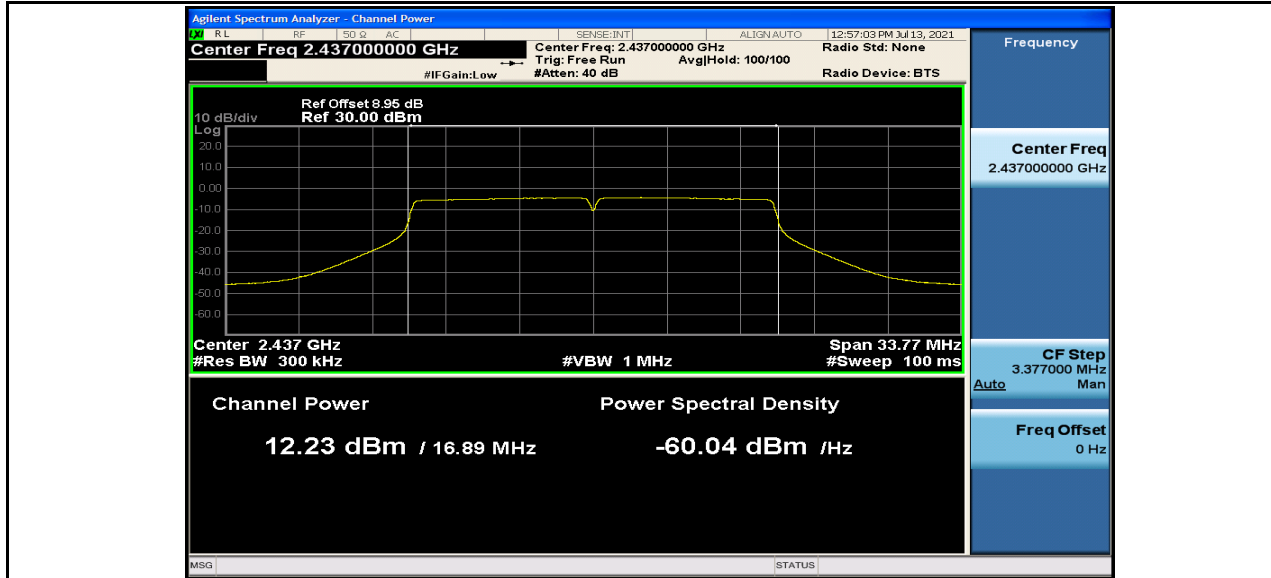


Maximum conducted (average) output power_11G_2412_Ant1

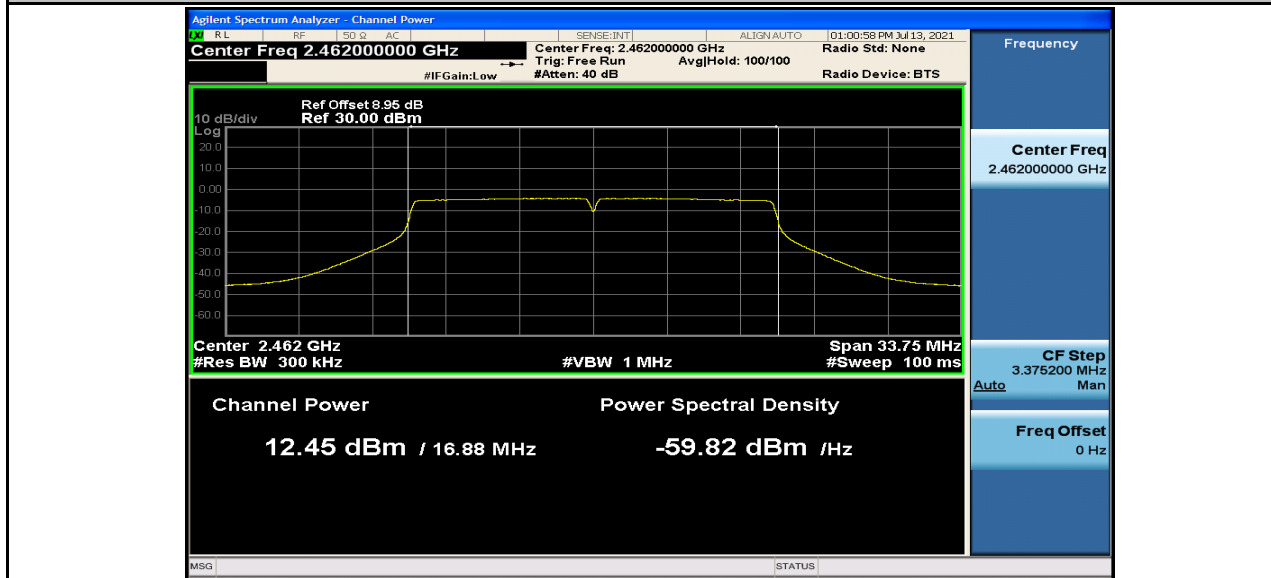


Maximum conducted (average) output power_11G_2437_Ant1





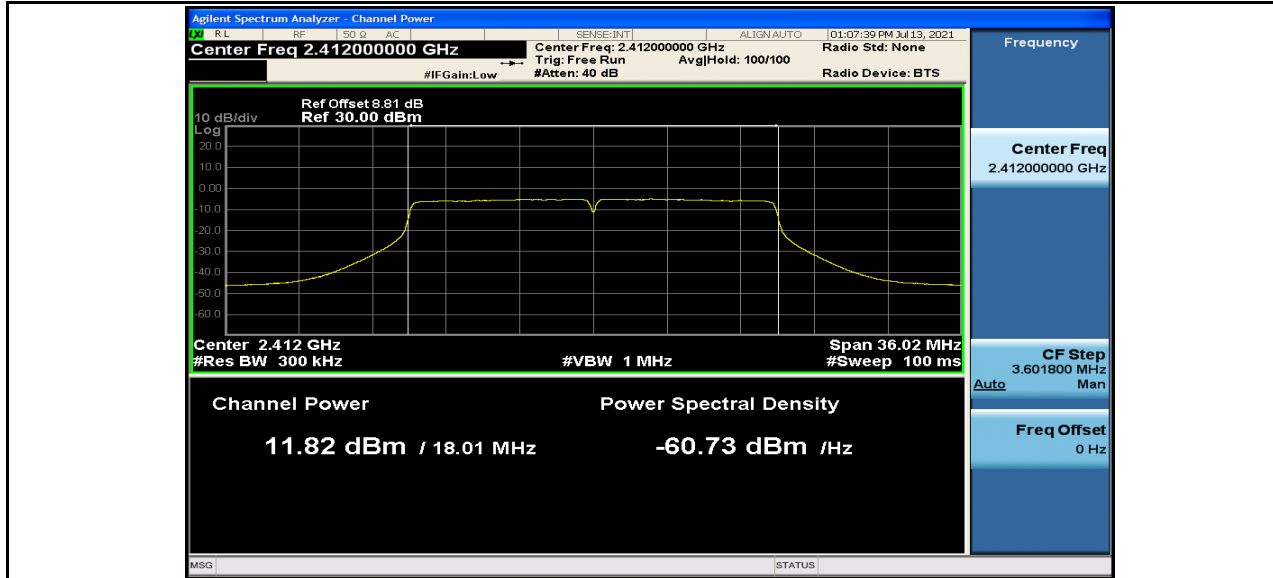
Maximum conducted (average) output power_11G_2462_Ant1



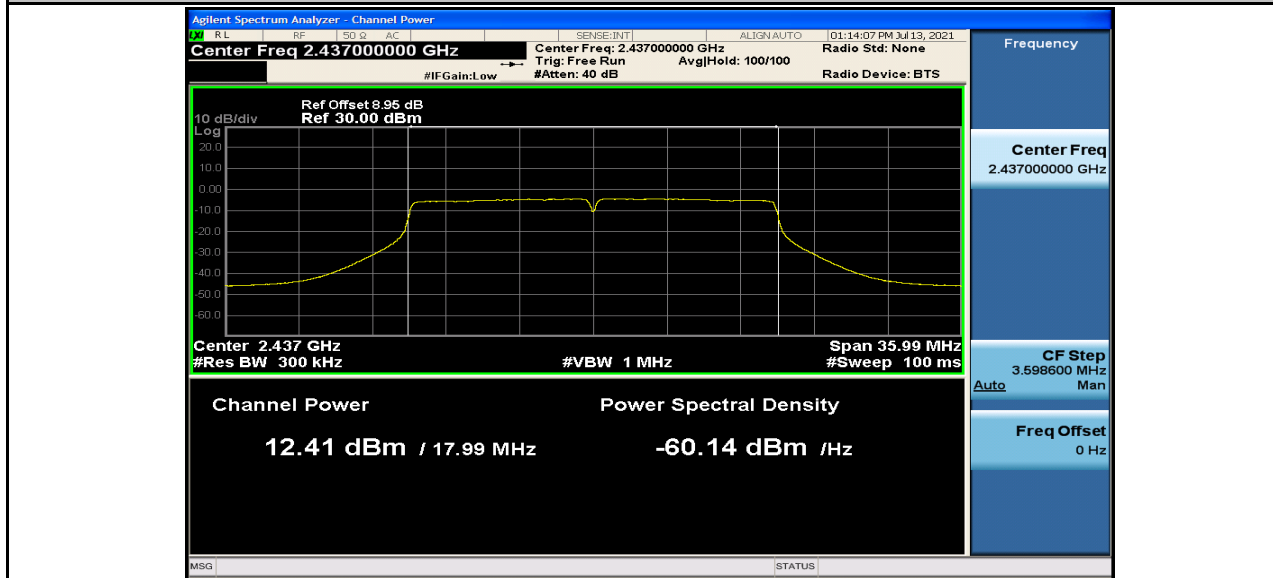
