1. Specification for power supply unit:

Input:120Vac,60Hz ,0.20A
Output:30VDC,0.12A
2. **READ AND FOLLOW ALL SAFETY INSTRUCTIONS.**
3. Read and follow all instructions that are on the product or provided with the product.
4. Do not use an extension cord.
5. Reference the National Electrical Code, ANSI/NFPA 70, specifically for the installation of wiring and clearance from power and lighting conductors.
6. Installation work and electrical wiring must be done by qualified person(s) in accordance with all applicable codes and standards, including fire-rated construction.
7. Do not install or use within 10 feet of a pool.
8. Do not use in a bathroom.
9. **WARNING: Risk of Electric Shock.** When used outdoors, install only to a covered Class A GFCI protected receptacle that is weatherproof with the power unit connected to the receptacle. If one is not provided, contact a qualified electrician for proper installation. Ensure that the power unit and cord do not interfere with completely closing the receptacle cover.
10. **WARNING: Risk of Fire.** Installation involves special wiring methods to run wiring through a building structure. Consult a qualified electrician.
11. **WARNING: Risk of Electric Shock.** Mount the unit at a height greater that 1 foot (0.3m) from the ground surface. (For used power cord connected model only.)
12. For direct plug-in units. using pictorials or equally effective means. not to use with receptacles that are weatherproof only when the receptacle is covered (attachment plug cap not inserted and receptacle cover closed)
