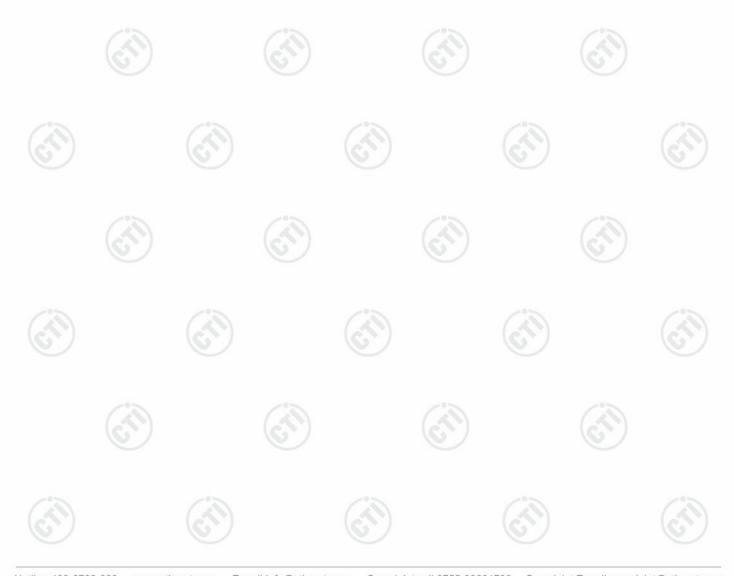

7.1 Antenna Requirement

The vertical ground reference plane was bonded to the horizontal ground reference plane. 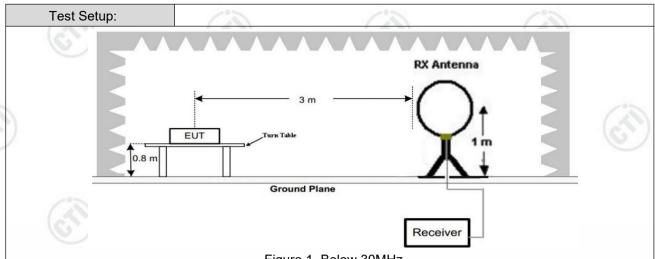
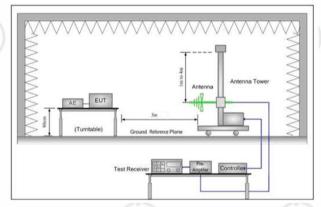


Figure 1. Below 30MHz



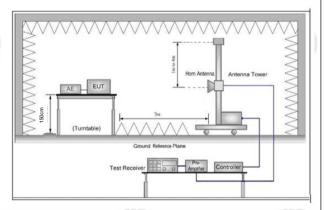


Figure 2. 30MHz to 1GHz

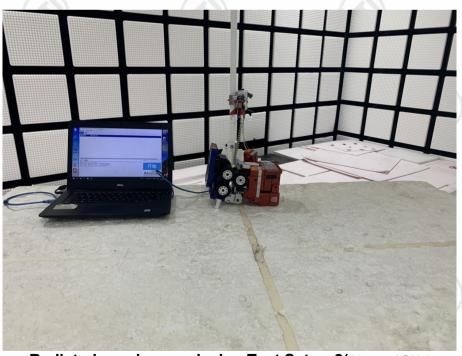

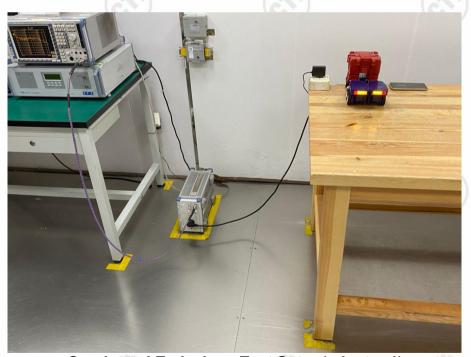
