

Instructions:

- (Be sure to fully charge the speaker before using for the first time).
- 1. Charging the Speaker
- . Connect the provided charging cable to a power source and to the micro USB port on the speaker (3).

The LED indicator light will glow red when charging and turn off when fully charged.

- 2. Bluetooth® Setup:
- . Turn ON/OFF switch to the ON position. LED Indictor will flash BLUE
- . Turn on the Bluetooth function on mobile device. Select "Jack BT" pairing name. LED will glow BLUE if successfully paired
- * Speaker will automatically pair if the mobile device has been paired before.
- . Press and hold ON/OFF button to turn off the device
- 3. Wireless Charging:
- . Connect the provided charging cable to a power source, place wireless charging supported mobile device on top charging pad.
- · Device will begin to charge automatically
