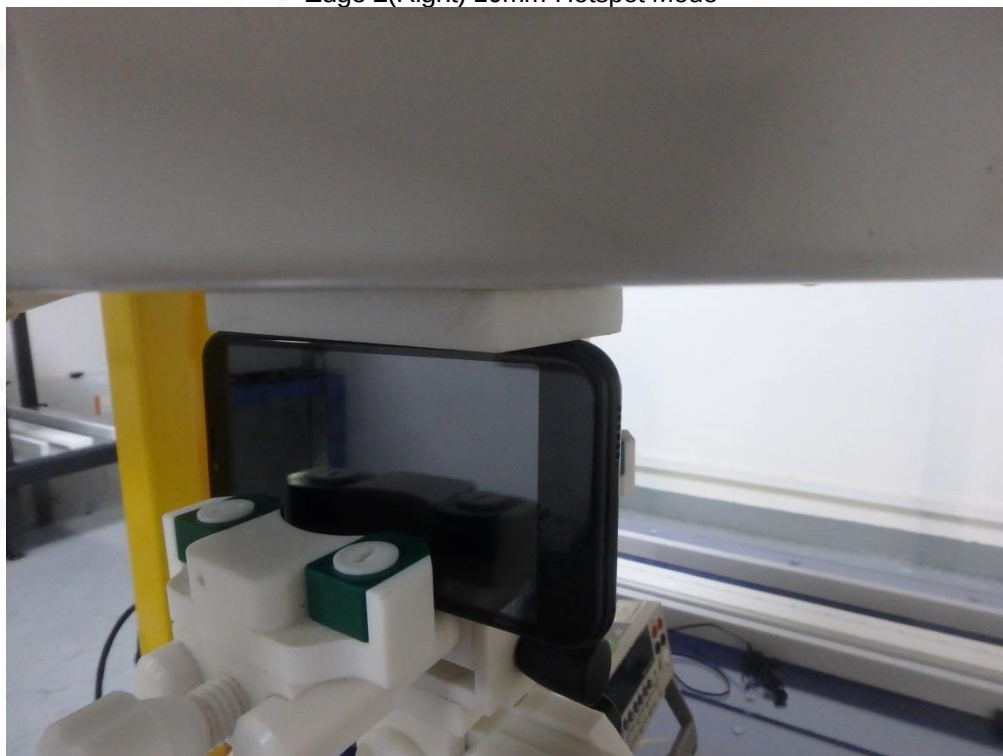

Edge 2(Right) 10mm-Hotspot Mode

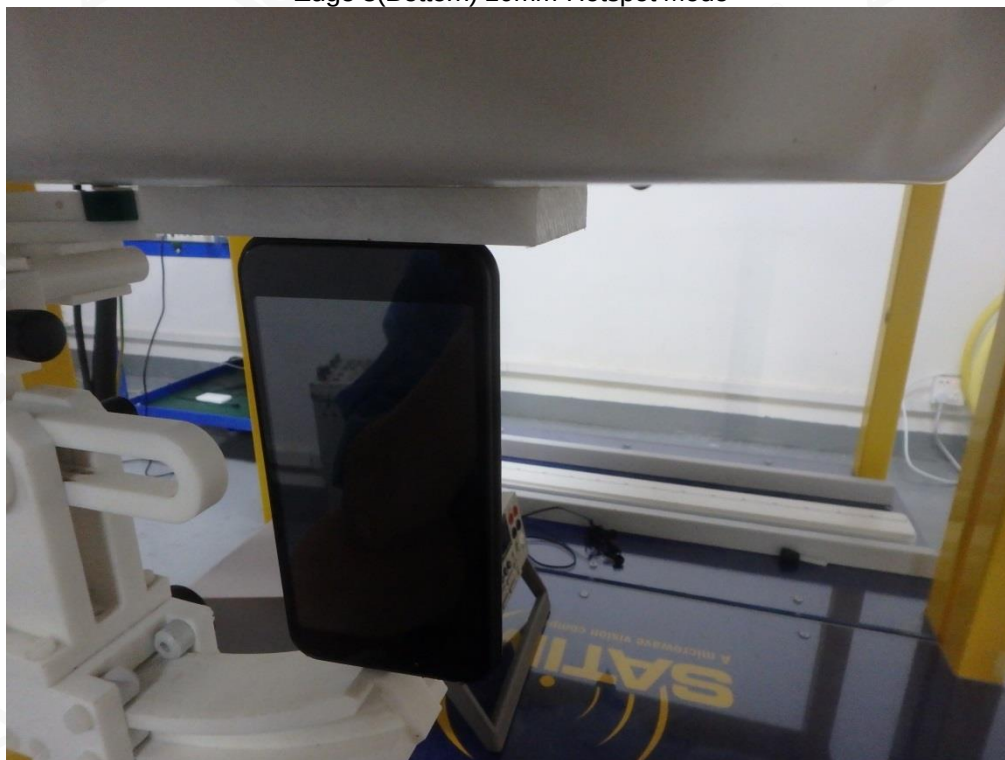
