3DH5_Ant1_2402_0~Reference



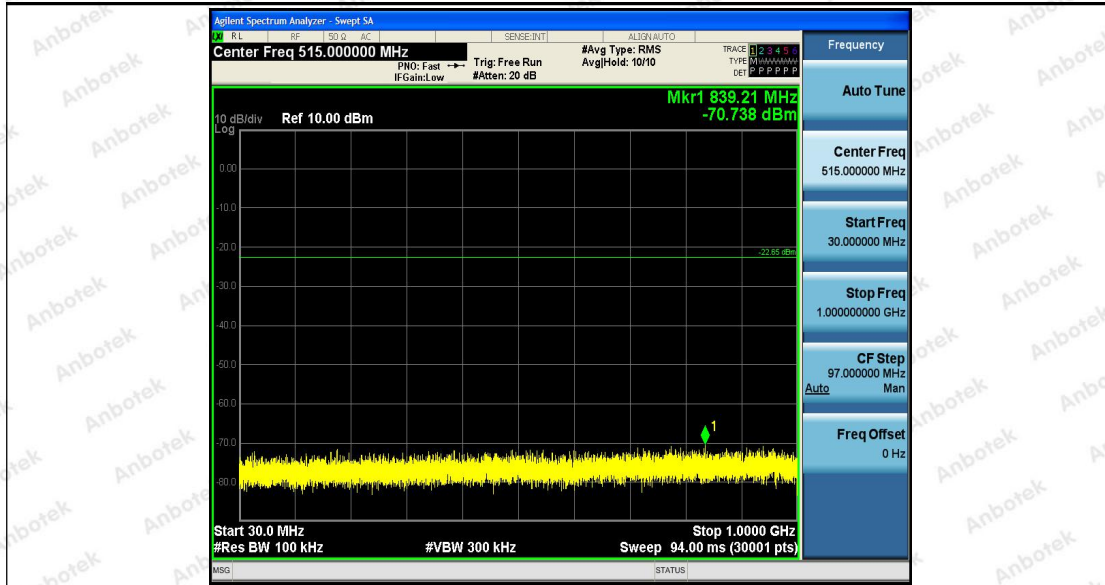
