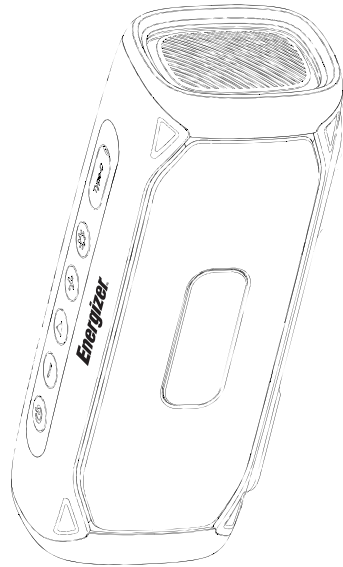

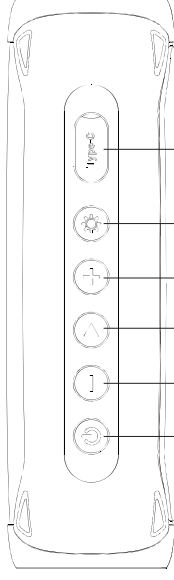

## How to USE ?

1. Power button: Long press the power button to turn on/off the speaker.
2. Bluetooth: Turn on the speaker to enter bluetooth pairing mode, enable bluetooth connection on your device, search and connect to "Energizer H2O-MAG Speaker"
3. Pause and play: Press Pause/play button on the device to play or pause the music.
4. Volume control: Press the volume up button to increase in volume, press the volume down button the reduce in volume.
5. Play next/ Previous song: Long press the "+" button the play next song. Long press the "-" button to play previous song.
6. The speaker supports MP3, WAV, APE.
7. USB-C output: Charge your device through USB-C output port.
8. Recharge port: To charge the speaker, connect the charging cable to your speaker and a power source to begin recharge.
9. LED Battery Indicator: Green light flashes when charging. Green light will stay on when the speaker is fully charged.
10. Hands-free mode (Telephone):
  - Answer incoming call: Press play/pause button
  - Reject incoming call: Press and hold play/pause button
11. Double press Play/ Pause button to switch to TWS function.
12. Long press LED Switch Button to turn on/off the RGB light. Short press to switch the light mode.
13. For better waterproof effect, please make sure that the silicone waterproof cover is tightly closed.

Note: The battery life of this product is based on user's activity and volume control.
