Insert the large connector into a USB power source such as the USB port on a computer, or into a 5V USB adapter (not included) and plug into a wall socket.</p>  <p><b>Charging the Earbuds</b> Use the included charging case to protect and charge your earbuds.</p> 	<p><b>Getting Started</b></p> <p><b>Bluetooth Pairing</b></p> <ol style="list-style-type: none"><li>1. The earbuds will automatically power on and pair with one another when removed from the case. After a few seconds, a tone should be heard indicating that the earbuds have connected to each other.</li><li>2. Open your device's Bluetooth menu and select ARTWS50 when it appears.</li><li>3. Another tone will be heard, indicating that the earbuds are successfully connected to your device. The LED indicators on both earbuds will flash WHITE.</li></ol>  <p><b>Pairing Troubleshooting</b> Trouble Pairing the Earbuds to Each Other? Try these steps:<ol style="list-style-type: none"><li>1. Place both earbuds back into the case to power them OFF.</li><li>2. You may need to go into your device's Bluetooth settings and manually "Forget" one or both of the earbuds, and turn your device's Bluetooth OFF while the earbuds pair to each other.</li><li>3.
