

## RF Exposure Evaluation

### Limits

The criteria listed in the following table shall be used to evaluate the environment impact of human exposure to radio frequency (RF) radiation as specified in 1.1307(b)

f = frequency in MHz

Friis transmission formula:  $Pd = (Pout * G) / (4 * pi * r^2)$

Where

**Pd** = power density in mW/cm<sup>2</sup>, **Pout** = output power to antenna in mW;

**G** = gain of antenna in linear scale, **Pi** = 3.1416;

**R** = distance between observation point and center of the radiator in cm

Pd is the limit of MPE, 1 mW/cm<sup>2</sup>. If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

### Test Procedure

Software provided by client enabled the EUT to transmit and receive data at lowest, middle and highest channel individually.

$$EIRP = E_{Meas} + 20 \log(d_{Meas}) - 104.7$$

EIRP is the equivalent isotropically radiated power, in dBm

$E_{Meas}$  is the field strength of the emission at the measurement distance, in dB  $\mu$  V/m

$d_{Meas}$  is the measurement distance, in m

For Simultaneous transmitting, 1): The sum of the ratios of the spatially averaged results to the applicable frequency dependent MPE limits =  $0.00141/1 + 0.00152/1 + 0.000093/1 = 0.003023 < 1$  Since the sum of the MPE ratios for all simultaneously transmitting antennas incorporated in the device is  $\leq 1.0$ , the EUT is considered to satisfy MPE compliance for simultaneous transmission operations.
