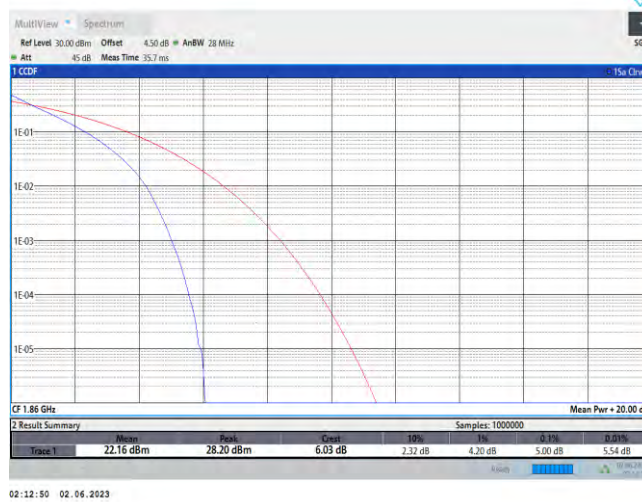

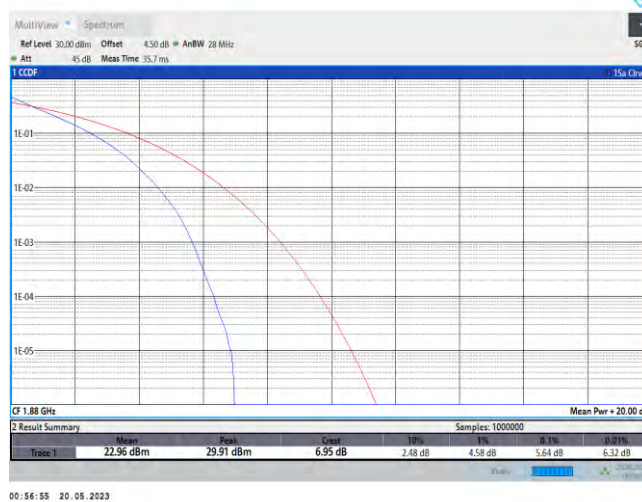

Band2-20MHz-QPSK-18900-100RB#0

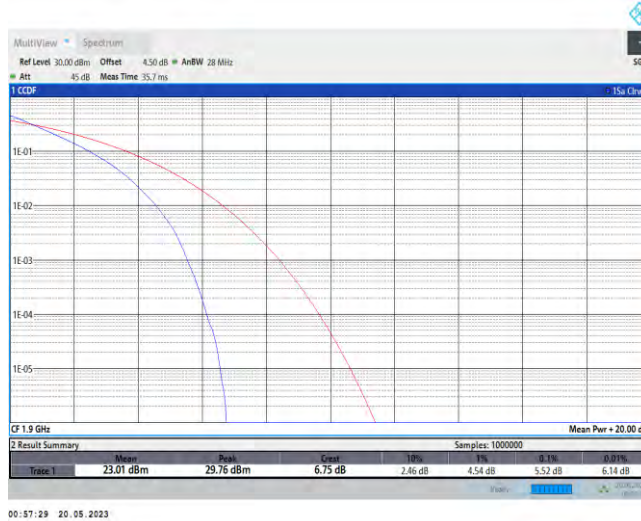

Band2-20MHz-16QAM-18900-100RB#0

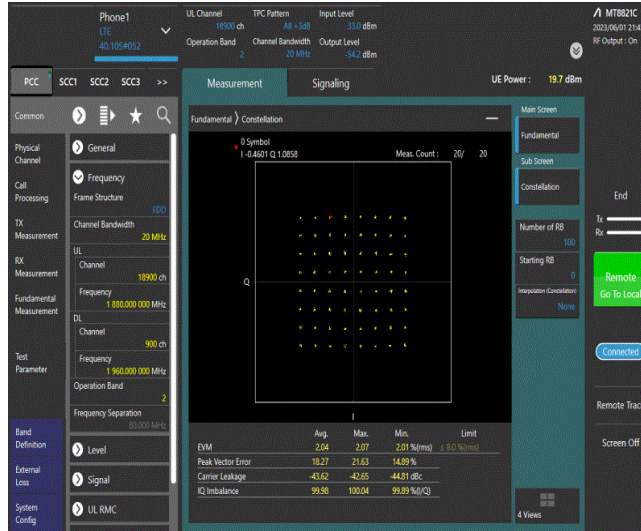
