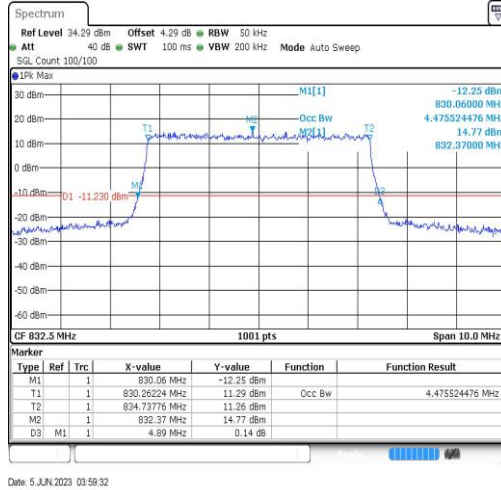

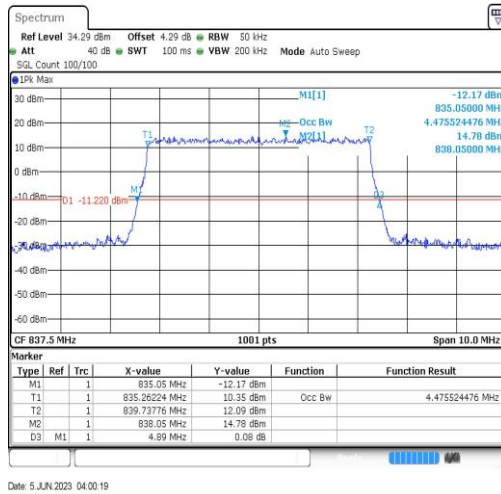

Band19-5MHz-QPSK-24025-25RB#0

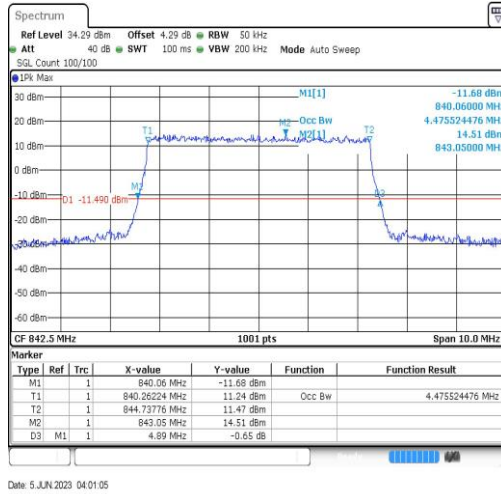
