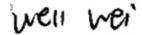

	 The EUT was connected to AC power source through a LISN 1 (Line Impedance Stabilization Network) which provides a 50Ω/50μH + 5Ω linear impedance. The power cables of all other units of the EUT were connected to a second LISN 2, which was bonded to the ground reference plane in the same way as the LISN 1 for the unit being measured. A multiple socket outlet strip was used to connect multiple power cables to a single LISN provided the rating of the LISN was not exceeded. 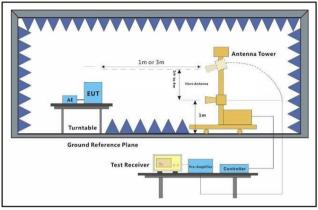


Figure 3. Above 1 GHz

- f. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- g. Test the EUT in the lowest channel, the middle channel ,the Highest channel.
- h. The radiation measurements are performed in X, Y, Z axis positioning for Transmitting mode, And found the X axis positioning which it is worse case.
- i. Repeat above procedures until all frequencies measured was complete.
- j. The low frequency, which started from 9 kHz to 30MHz, was pre-scanned and the result which was 20dB lower than the limit line was not reported
- k. The disturbance above 18GHz was very low, and the harmonics were the highest point could be found when testing, so only the harmonics had been displayed.

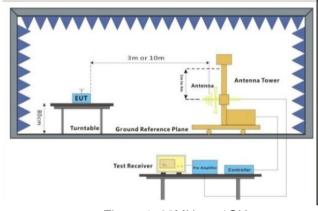

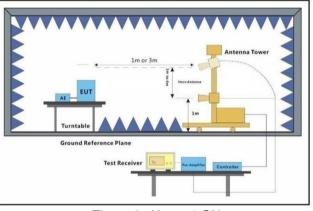


Figure 1. 30MHz to 1GHz

Conducted Spurious Emission Test Graphs





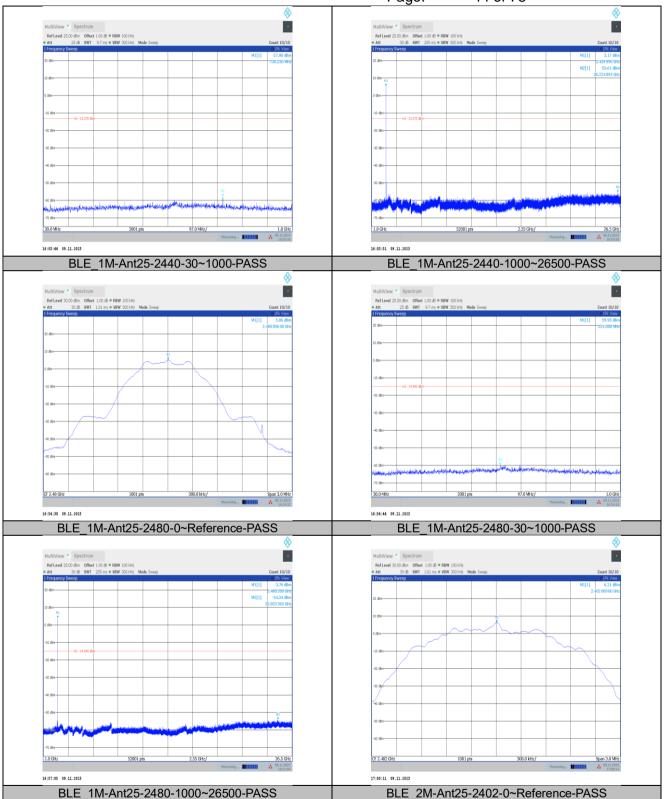
