4.6 Peak-Average Ratio

A peak to average ratio measurement is performed at the conducted port of the EUT. Below 1GHz test procedure as below:

- 1). The EUT was powered ON and placed on a 80cm high table in the chamber. The antenna of the transmitter was extended to its maximum length.






