Summary of the specific operational use conditions

The Bluetooth Low energy module ASM11374 is built on the BT chip nRF52832 from Nordic semiconductor. The module is using an omni-directional antenna, no limitation needs to be remarked.

Since the antenna is a part of the module, it is not allowed to change the antenna.

This radio transmitter has been approved by FCC and ISDE to operate with the antenna types listed below with the maximum permissible gain indicated. Information on test modes and additional testing requirements
