# **1.3 MPE Calculation Method**

- $S = (30*P*G) / (377*R^2)$
- S = power density (in appropriate units, e.g., mw/cm<sup>2</sup>)
- P = power input to the antenna (in appropriate units, e.g., mw)
- G = power gain of the antenna in the direction of interest relative to an isotropic radiator, the power gain factor is normally numeric gain.
- R = distance to the center of radiation of the antenna (in appropriate units, e.g., cm)
