

SPECIAL REQUIREMENTS:

1. The vendor should notify Triple Jump in writing prior to making any changes in the process or materials used.
2. The raw materials must be compatible with the drawing requirements and must be from an approved supplier.
3. COT & COA (for raw material) reports should be supplied with each LOT; Other documentation should be supplied as indicated in the Purchase Order.
4. The COT &COC Reports shall include:
 1. Manufacturer name
 2. Manufacturer site
 3. Manufacturing date
 4. Part number
 5. Revision
 6. LOT number
 7. Raw material type and batch number
 8. Dimensions checked
 9. Tools used for inspection
 10. Final decision
5. Any damage or re-work done on the components are to be reported and documented.
6. The entire LOT shall be produced on the same production line.
7. Labels must include Triple Jump part number, Revision number, Description, LOT number, manufacturing date and Quantity in package. Parts that are received without proper identification will not be accepted.
8. Part shall be clean and free of all foreign materials or contamination.
9. Packaging (unless otherwise specified):
 1. Packaging shall include a single bag in carton box.
 2. Clean Parts shall be packed in two bags in a carton box.
10. Parts shall be stored at room conditions and shall be protected from damaging, contaminations, excess humidity, direct sunlight etc. (special storage conditions should be detailed).
11. Parts must be transported in a way to prevent damage or contamination. Parts that are received with damaged packaging will not be accepted.
12. Inspection Dimensions shall be tested according to AQL Inspection table level (Table 1).
