The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this section.

The antenna is a **PCB Antenna** which permanently attached, and the best case gain of the antenna is **4.4dBi**. It complies with the standard requirement.



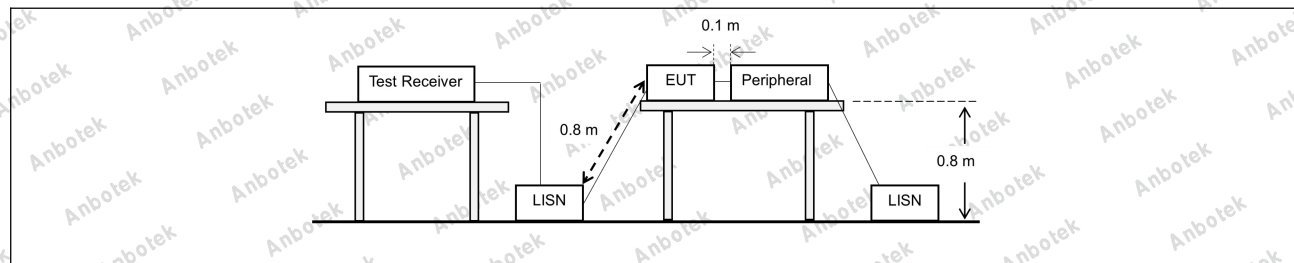

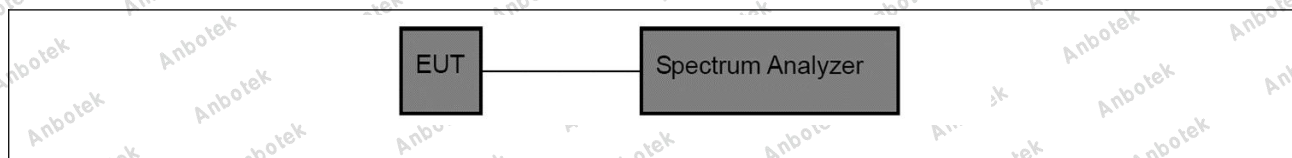
5. Maximum Conducted Output Power
