2.. MPE CALCULATION METHOD

For 100 MHz to 6 GHz and test separation distances \leq 50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)] \cdot [\checkmark f(GHz)] \leq 3.0 for 1-g SAR, and \leq 7.5 for 10-g extremity SAR,30 where \Box f(GHz) is the RF channel transmit frequency in GHz

Measurement Record:

The minimum distance for the EUT is less than 5mm.

Since maximum peak output power of the transmitter is -4.13 dBm \approx 0.39 mW < $\frac{3^*d}{\sqrt{f}}$ = 9.52 mW.

Hence the EUT is excluded from SAR evaluation according to FCC KDB Publication 447498 D01 General RF Exposure Guidance v06.
