




### 10.4 Dialling a number

- ▶ In the phone menu, tap the **Dial pad** tab, if necessary.
- ▶ Enter the number.
- ▶ Tap  to call the number you entered.

Or:

- ▶ Enter the first digits of the number. The number of matches corresponding to the entered digits is displayed beside the  symbol.
- ▶ Tap  to display the numbers from your contacts that match what you have entered.
- ▶ Tap the desired number. The selected number is called.

### 10.5 Calling a contact from the phone book

- ▶ In the phone menu, tap the **Contacts** tab, if necessary.
- ▶ Tap the desired contact. If there are several numbers of equal priority stored for the contact, all these numbers will be displayed.
- ▶ Tap the desired number. The number is called.

### 10.6 Calling an entry in the call list

The call list stores the numbers that have been dialled and the numbers of received calls.

#### Note:

A maximum of 60 items are stored in the call list.

- ▶ In the phone menu, tap the **Calls** tab, if necessary.
- ▶ Tap the desired number. The number is called.

### 10.6.1 Tone dial feature (DTMF)

During a current call, you can generate DTMF tones:

- ▶ Tap .
- ▶ Enter a number.


### 10.7 Second call

You can manage two calls simultaneously if you answer another call during your current call.


#### 10.7.1 A second incoming call

If you receive a second call during your current call, the following notification appears:



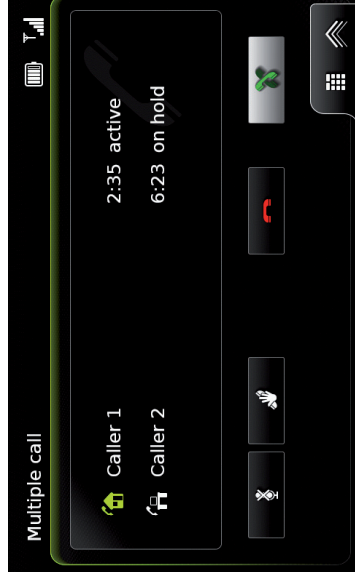
Tap  to answer the second call.



- ▶ To reject the second call, tap .
- ▶ If you answer the second call, your current call is automatically interrupted and the connection put on hold.


#### 10.7.2 Switching between two calls

If there are two simultaneous calls, the following display appears:



To switch between the two calls, tap .

To end the currently active call,

- ▶ tap .

The call that is on hold will be activated automatically.

### **i** **Note:**

Even if the person you are calling ends the active call, the call that is on hold will be activated automatically.

## 10.8 SMS text messages

### 10.8.1 Reading an incoming text message

### **i** **Note:**

You can enable or disable the displaying of incoming text messages. For further details on this, please read the following section.


The following notification appears when an incoming text message arrives:




To display the text message,  
▶ tap .


The text message is displayed.

To close the text message,



▶ tap .

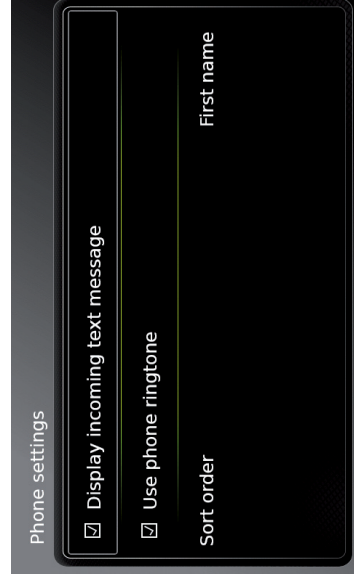

▶ If you wish, you can have the system read the message aloud. To do so, tap . Please note that this function is not available in all system languages.

▶ To call the message sender, tap .



### 10.8.2 Incoming text message display – on/off

▶ In telephone mode, tap  .



▶ Tap **Display incoming text message**.

▶ Tap   to close the menu.

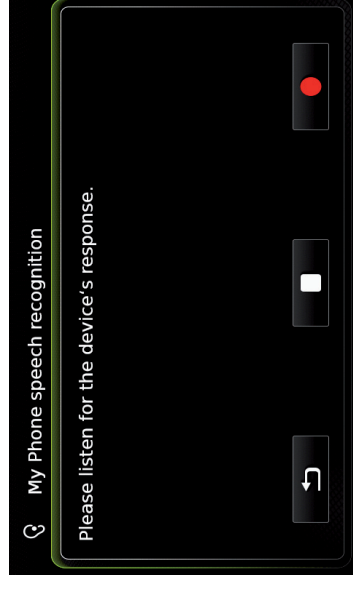
## 10.9 Activating the voice control system of the connected mobile phone

### 10.10.1 Ringtoneofthemobilephone

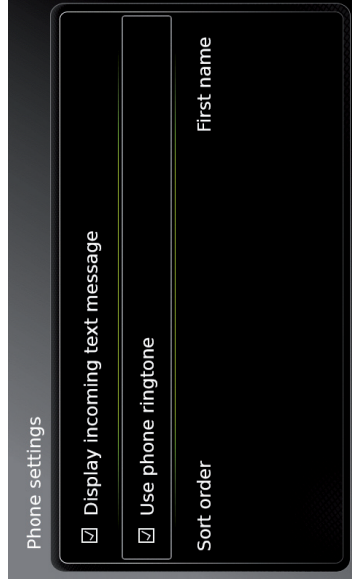


**Note:**

- ▶ In telephone mode, tap .



- ▶ Tap **Use phone ringtone**.

Your mobile phone's ringtone is used when the check mark is displayed in the checkbox.

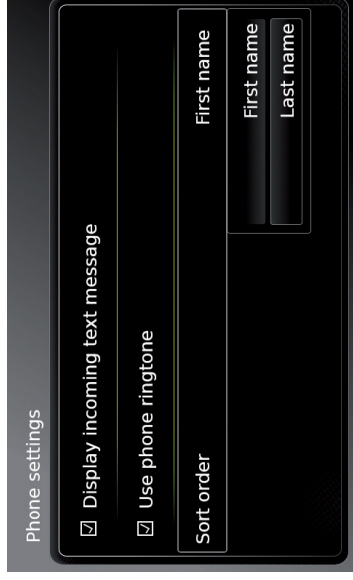
- ▶ Tap to close the menu.

### 10.10.2 Phone-book sort order

You can select the order in which the phone-book entries are displayed.

- ▶ In telephone mode, tap .

The telephone settings are displayed.



- ▶ Tap **Sort order**.

▶ Tap the desired option, **First name** or **Last name**.

- ▶ Tap to close the menu.

## 11 Smartphone integration

You can connect a smartphone to the device via MirrorLink™ or Apple CarPlay.

A software update may be required in order to use Apple CarPlay. For more information, please contact your SUZUKI dealer.

- ▶ The smartphone manufacturers are responsible for the content and functions of smartphone applications. The device merely provides the option to display and operate these applications.
- ▶ For information on using smartphone applications on your smartphone, please read your smartphone's instruction manual.
- ▶ For safety reasons, you cannot access some applications when the vehicle is moving.

#### **Notes about MirrorLink™ feature**

- ▶ Telephone functions: If the connected smartphone is not

connected via Bluetooth® too, you will not be able to use the device as a hands-free set. In this case, audio input and output happens via the speaker and microphone of your smartphone.

- ▶ Audio output:
  - The audio output of the connected smartphone (such as announcements from a navigation app) will be mixed with the current audio output of the device (such as currently playing media).
  - When connected via MirrorLink™ the Bluetooth® audio player feature may not be available, please use the MirrorLink™ audio player instead.

#### **Notes about Apple CarPlay**

- ▶ Telephone functions: To use a connected iPhone for telephoning, use the telephone app of your iPhone. The device's telephone functions are not available. If you try to access the device's telephone functions, you will be automatically redirected to the telephone app of your iPhone.

- ▶ Navigation functions: You can only use one navigation system at a time. If you start a navigation app on your iPhone and there is a route guidance session already active on the device's navigation system, that route guidance session will be cancelled automatically (and vice versa).
- ▶ Audio output: The audio output of the connected iPhone (such as announcements from a navigation app) will be mixed with the current audio output of the device (such as currently playing media).

### **11.1 Calling up the smartphone display**

- ▶ Tap the *Connect* area in the Home menu. Your smartphone's user interface is displayed.

### **11.2 Selecting a particular application on a smartphone**

Certain types of smartphones may provide various compatible applications.



To select an application,

- ▶ tap  in the Home menu.
- The list of compatible applications is displayed.
- ▶ Tap the desired application.
- The selected application's user interface is displayed.

## 12 Rear-view camera



### Note:

This function is only available if the vehicle is equipped with a rear view camera.

The picture from the rear-view camera is automatically shown on the display for as long as the reverse gear is engaged.





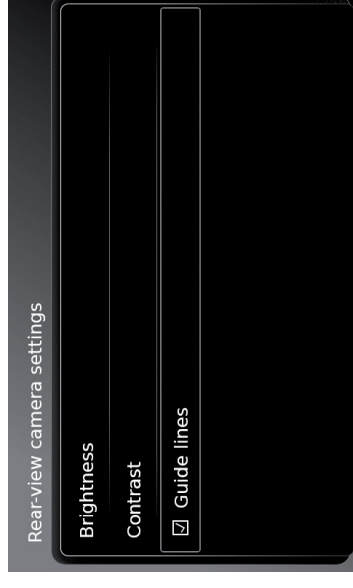
### Road safety

When reversing, if you only look at the picture provided by the rear-view camera, you may fail to notice other road users or objects outside the picture and may cause an accident. Therefore, please always also pay attention to your vehicle's surroundings.

### 12.1.1 Guide lines – on/off

The superimposed guide lines project the dimensions of the vehicle onto the section of road behind.

- ▶ Tap  .





- ▶ Tap **Guide lines**.

The guide lines are shown when the check mark is displayed in the checkbox.

Tap   to close the settings.

### 12.1 Picture settings for the rear-view camera

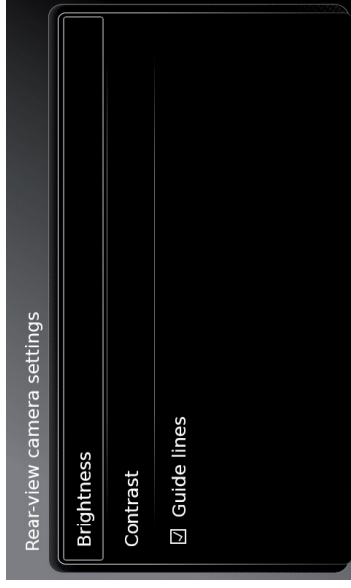




You can only change the settings while the reverse gear is engaged.

### 12.1.2 Adjusting the picture brightness and contrast


- ▶ Tap  .
- The settings for the rear-view camera are displayed.



- ▶ Tap **Brightness** or **Contrast**.  
The picture from the rear-view camera is displayed.
- ▶ Tap  or  to decrease or increase the value.

-  Tap   to close the settings or tap  to return to the settings for the rear-view camera.  
The settings are also closed when you disengage the reverse gear.


## 13 Voice control

-  **Note:**  
This feature is only available if the selected system language supports voice recognition. To select a system language, please read the section entitled “Setting the language” (page 20).







Using the voice control feature, you can select many of the device’s functions by means of spoken commands.  
Voice control is available for the following operating modes:

- ▶ Telephone
- ▶ Navigation
- ▶ Playing media (audio)

-  **Note:**  
When voice control is active, the currently available voice commands are shown on the display. To ensure the device correctly recognises your command, please say the command as it is shown in the display.  
The device can, however, also recognise other corresponding commands (e.g. “satnav” instead of “navigation”).

### 13.1 Voice control – start/stop

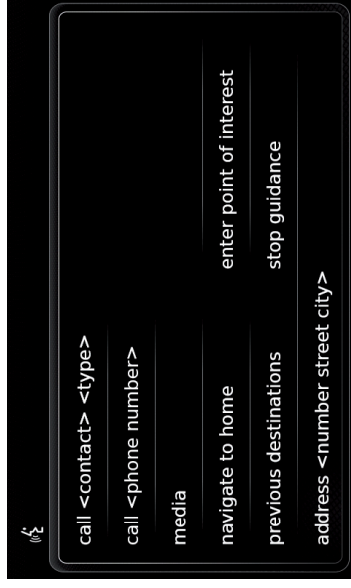
- To start voice control,  
▶ tap  .
- To stop voice control,  
▶ say “Cancel”.
-  **Note:**  
To stop voice control, you can also tap  .



## 13.2 How voice control works

### 13.2.1 The main menu

As soon as you start voice control, the main menu appears:



voice commands that you can use directly for the most important functions:

- ▶ Telephone
  - Call a contact
  - Dial a number
- ▶ Navigation
  - Enter an address for route guidance
  - Select a point of interest for route guidance
  - Start route guidance to the home address
  - Select one of the previous destinations for route guidance
  - Cancel the current route guidance session

### ▶ Playing media (audio)

- Start playback of a song, audiobook or podcast



- ▶ For each operating mode there is a separate menu containing further commands (see the section entitled “Opening the menu for an operating mode” (page 63)).
- ▶ If a voice command opens a sub-menu, you can return to the previous menu by saying “Back”.

Certain commands are combined with names or numbers, e.g. “Call <number>”. Say the displayed command and the desired number or name.

### 13.2.3 Opening the menu for an operating mode

For each operating mode there is a separate menu containing further commands.


- To open the menu for an operating mode,
- ▶ say the corresponding command:
    - “Phone”
    - “Navigation”
    - “Audio”

### 13.2.2 Saying voice commands

The available voice commands are shown in the display. The device reads out the available options. After that, a beep indicates that the device is ready to accept your voice command.



#### Note:

When the device reads out the available options, you may interrupt it by tapping  5. The beep sounds immediately, and the device is ready to accept your voice command.

Say the displayed command to select the corresponding function, for instance, “navigate to home” to start route guidance to the stored home address.

### 13.2.4 Selecting from a list

If you have various items at your disposal they will be displayed in a list (e.g. various navigation destinations or various music tracks for media playback).



To select the desired item, say the number of the corresponding list item, e.g. “Three”.



**Note:**

To scroll up or down in the list, say “Previous page” or “Next page”.

**13.3 Help for voice control**

To obtain help with the voice control system,

► say “Help”.

## 15 HD Radio troubleshooting

Symptom	possible cause	Possible solution
Delay in digital audio on HD Radio broadcasts.	The radio acquires an analog station first and blends to an digital signal.	This is not a malfunction.
Audio skips, stutters, or echoes.	The radio station has not properly aligned the digital and analog audio.	Verify correct operation on another station. Report any station with poor performance.
Volume changing up/down.	The radio station has not properly aligned digital and analog audio level.	Verify correct operation on another station and check <a href="http://www.hdradio.com">www.hdradio.com</a> for stations in the area. Report any station with poor performance.
Sound fading in and out.	The transition between analog and digital is taking place (blending).	Verify transition performance on several stations in the area. Report any stations with poor alignment.
Excessive blending (transition between analog and digital).	The vehicle is located near the edge of the digital coverage area.	Refer to <a href="http://www.hdradio.com">www.hdradio.com</a> to verify radio stations in your coverage area.
Digital audio is no better than analog audio.	Audio processing on the digital audio at a station can potentially decrease the digital audio sound quality.	Verify correct operation on another station. Report any station with poor performance.

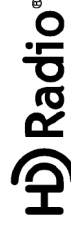
