



产品特色

- 6.应看管好儿童，以确保他们不将无线充电器当成玩具来玩，以避免不必要的意外。




This is a magnetic charger for iphone with the latest version of iOS and other Qi-enabled devices. Please read the manual carefully before using the product, and keep properly for checking.




Characteristic

1. There is a ring of magnets inside the product, which can magnetically attract the phone;
2. This is a ultra-thin, small size product and convenient to carry;
3. This product is an integrated wireless charger, not need additional cable;
4. The input port USB specification is equipped with Type-C port;
5. This product supports 15W fast charging.

Features

Place the mobile phone with magnetic attraction function on the wireless charger, and the built-in magnet of the wireless charger will automatically align, accurately adsorb to the mobile phone, and start wireless charging; For other mobile phones without magnetic attraction function, place the center of the mobile phone at the center of the wireless charging to be wirelessly charged!

Attention

1. Do not squeeze or collisions.
