

**To Turn Vibrations On:
On the TRYST v2:**

1. Press **1** to turn on LED display and activate product.
2. Press **1** again to start vibrations of motors 1 & 2, located in the arms of the TRYST v2.
3. Press **2** to turn on motor 3 in the base of the TRYST v2
4. Continue to press **1** to cycle through 10 vibration modes in motors 1 & 2. Continue to press **2** to cycle through 10 vibration modes in motor 3.

On the Wireless Remote:

5. After completing Steps 1 & 3, press **1** on the remote. Continue to press it to cycle through the 10 vibration modes of motors 1 & 2.
6. Press **2** on the remote to cycle through 10 vibration modes on motor 3.

**To Turn Vibrations Off:
On the TRYST v2:**

1. Hold **1** on the TRYST until the LED display and motors 1 & 2 power off.
2. Hold **2** on the TRYST until the LED display and motor 3 powers off.

On the Wireless Remote:

1. Hold **1** on the remote until motors 1 & 2 power off.
2. Hold **2** on the remote until motor 3 powers off.

[Please note: the remote cannot work before the product is activated.]

**To Charge
TRYST v2:**

Plug included cable into a USB power source, then locate the charging port on the TRYST v2 and plug in.

Charge time: 60 minutes.
Usage time: 90 minutes.

**Cleaning and
Storage:**

Spray your TRYST v2 with Doc Johnson Toy Cleaner or wash with mild soap and warm water. Allow to air-dry completely before storing separately from other toys in a cool, dry place. Use with water-based lubricant/glide. Doc Johnson Toy Cleaner sold separately.

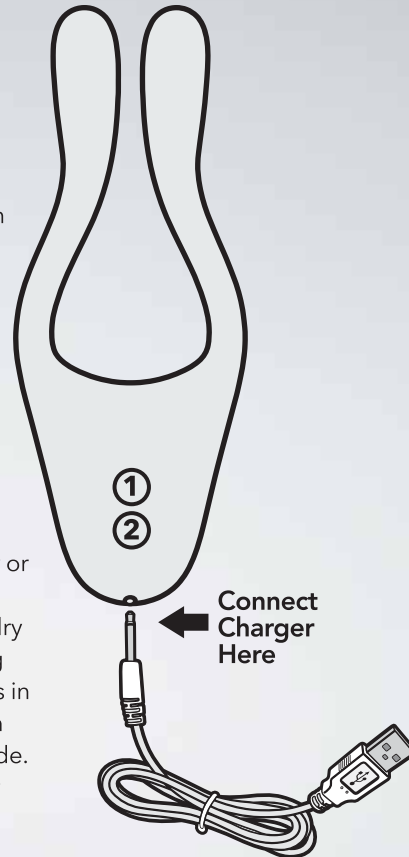

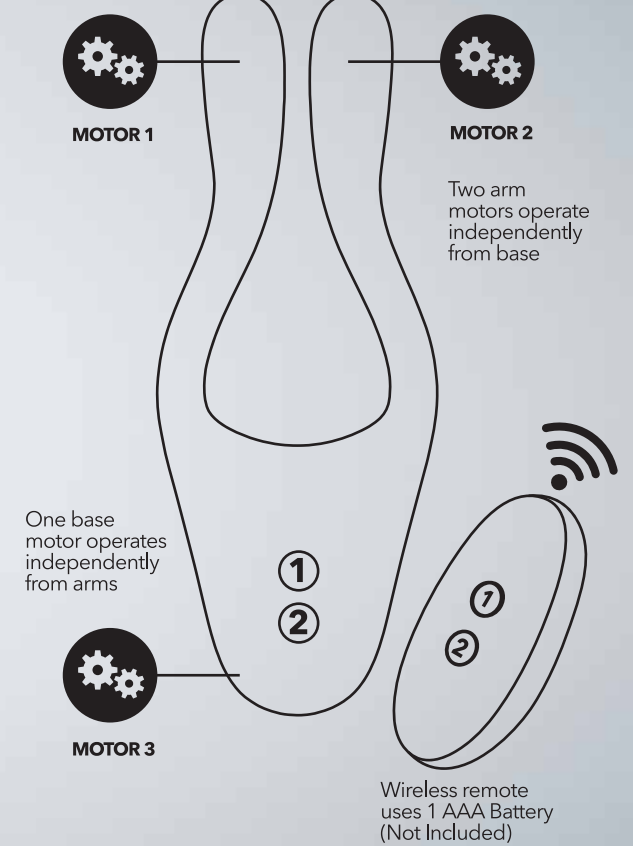

REMOTE CONTROL

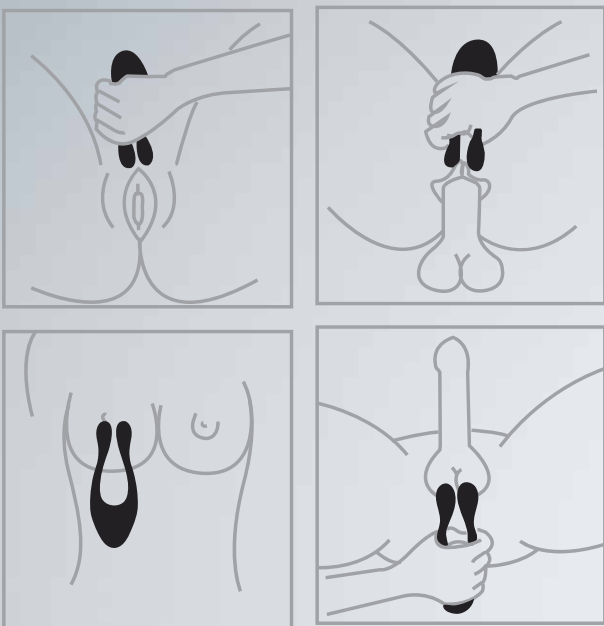


About This Product

SUGGESTED USES:

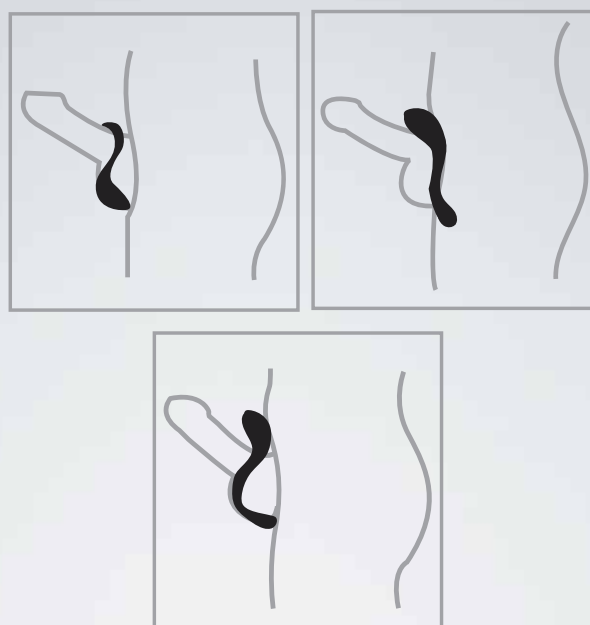
The vibrating arms can bend to squeeze the clitoris, nipples, testicles, and anywhere else, applying exactly the right amount of pressure during solo or partner play.



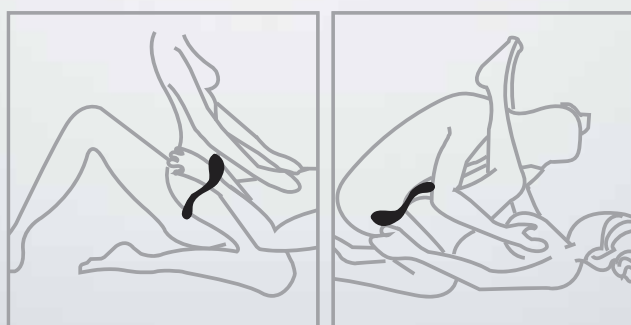

TRYST v2 can be worn as a form-fitting C-ring in various positions and levels of snugness.



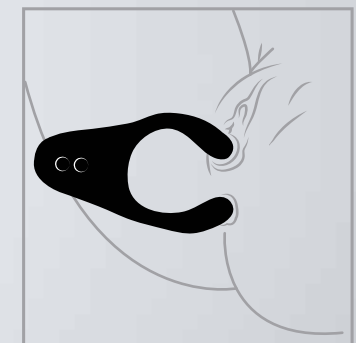
TRYST v2 in C-ring mode can be enjoyed hands-free during intercourse. Experiment with base and arm position to maximize everyone's pleasure!
