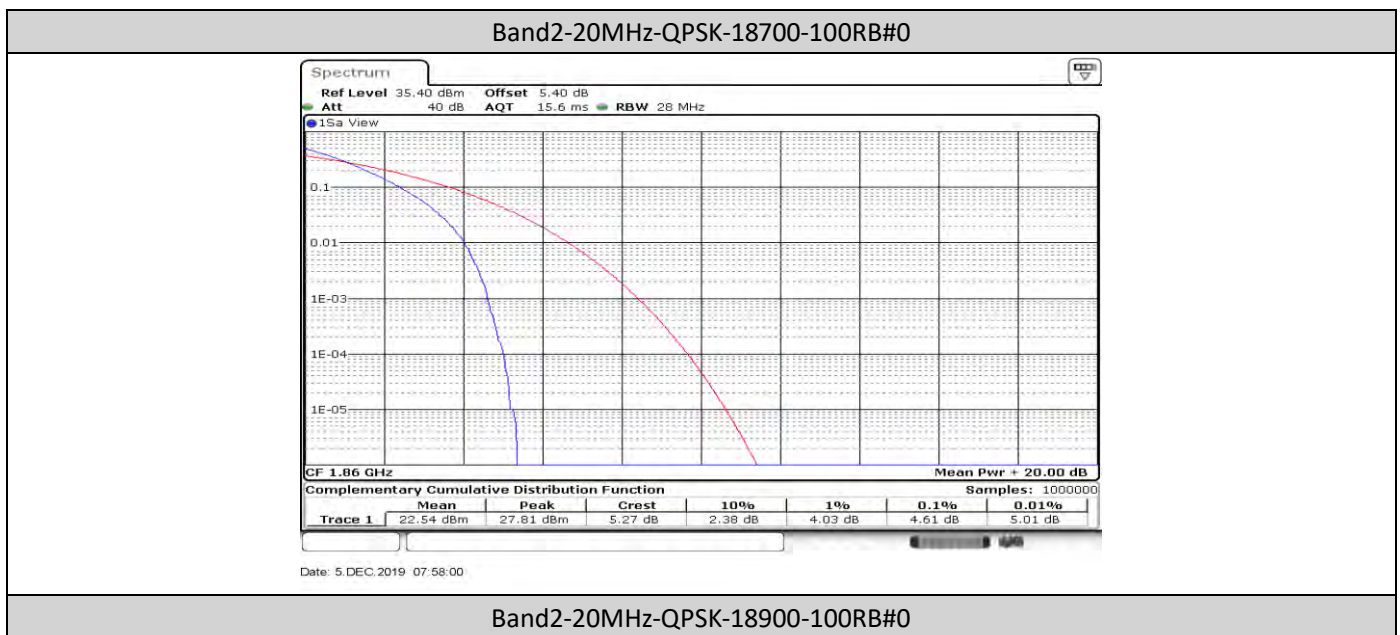

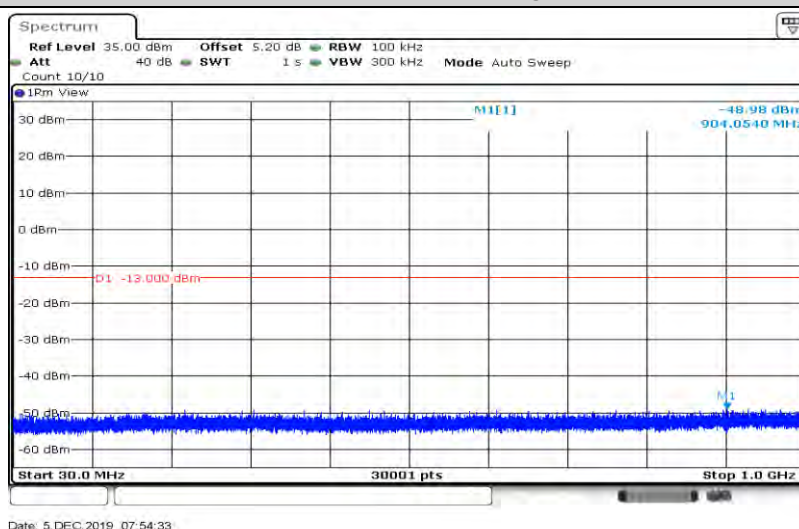
6. Spurious Emission at Antenna Terminal

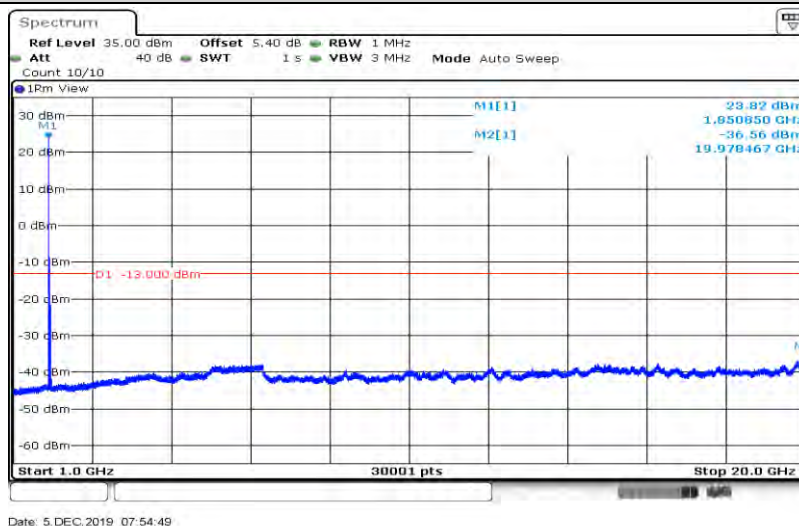

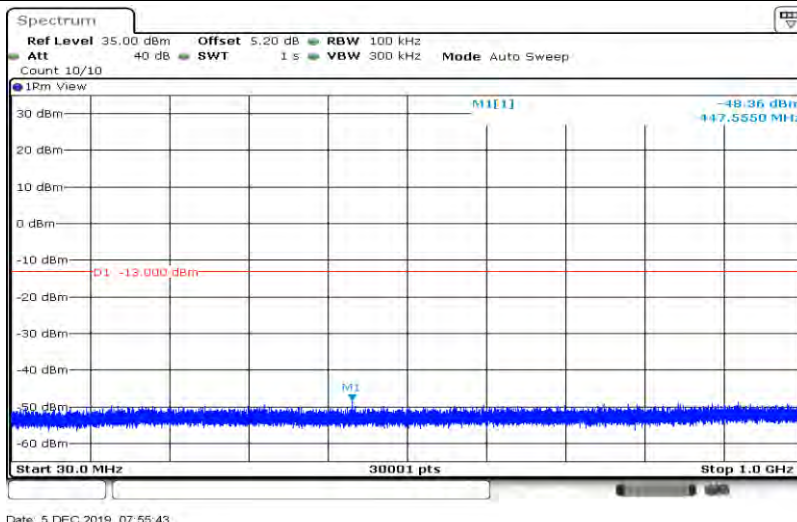


Band2-20MHz-QPSK-18700-1RB#0-Range2:1000~20000MHz

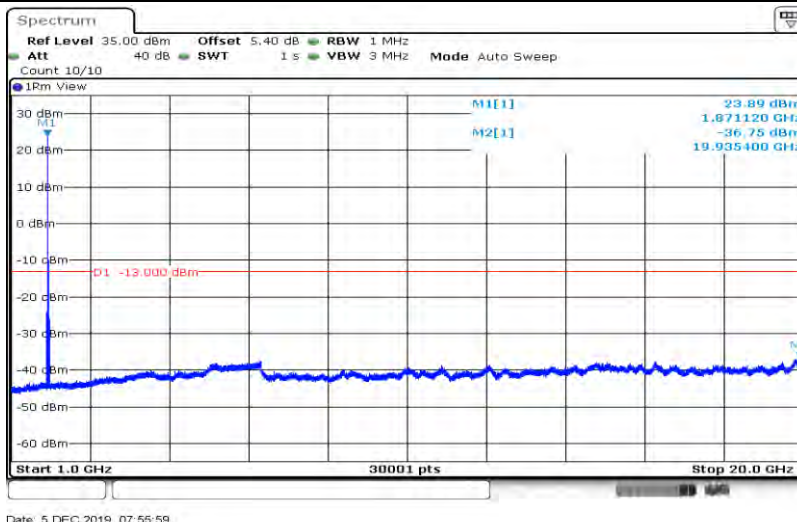


Band2-20MHz-QPSK-18900-1RB#0-Range1:30~1000MHz
