5 SAR Evaluation

5.1 RF Exposure Compliance Requirement

5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v06

4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

5.1.2 Limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances ≤ 50 mm are determined by:

[(max. power of channel, including tune-up tolerance, mW)/(min. test separation distance, mm)] $\cdot [\sqrt{f(GHz)}] \le 3.0$ for 1-g SAR and ≤ 7.5 for 10-g extremity SAR, where

f(GHz) is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation¹⁷

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is ≤ 50 mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is < 5 mm, a distance of 5 mm is applied to determine SAR test exclusion

At frequencies below 100 MHz, the following may be considered for SAR test exclusion:

a) The power threshold at the corresponding test separation distance at 100 MHz in below step 1) is multiplied by $[1 + \log(100/f(MHz))]$ for test separation distances > 50 mm and < 200 mm

The power threshold determined by the equation in a) for 50 mm and 100 MHz is multiplied by $\frac{1}{2}$ for test separation distances \leq 50 mm.

[Power allowed at numeric threshold for 50 mm in step 1) + (test separation distance - 50 mm)·(f(MHz)/150)] mW, at 100 MHz to 1500 MHz

When an antenna qualifies for the standalone SAR test exclusion of 4.3.1 and also transmits simultaneously with other antennas, the standalone SAR value must be estimated according to the following to determine the simultaneous transmission SAR test exclusion criteria:36

1) [(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)]·[$\sqrt{f(GHz)/x}$] W/kg, for test separation distances \leq 50 mm;

where x = 7.5 for 1-q SAR and x = 18.75 for 10-q SAR.

2) 0.4 W/kg for 1-g SAR and 1.0 W/kg for 10-g SAR, when the test separation distance is > 50 mm.

5.1.3 EUT RF Exposure

For BT:

The Max. power (including tune-up tolerance) is -0.48 dBm on the lowest channel 2.402 GHz (*)

-0.48 dBm logarithmic terms convert to numeric result is nearly 0.90 mW

For NFC:

The maximum radiated output power specified is -22.23dBm = 0.005984mW

The SAR Exclusion Threshold Level for 13.56MHz when the minimum test separation distance is < 50mm:

- = 474 * [1 + log(100/f(MHz)]/2
- = 442.65 mW

Since the source-based time-averaging radiated output power is well below the SAR low threshold level, so the EUT is considered to comply with SAR requirement without testing.

For BT and NFC mode transmit simultaneously:

According to the formula

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)]- $[\sqrt{f(GHz)/7.5}]$ W/kg

For Bluetooth:

SAR test exclusion = $(0.90 \text{mW} / 5 \text{ mm}) \times \sqrt{2.402 \text{GHz}/7.5} = 0.0372 \text{ W/kg}$

For NFC:

SAR test exclusion = $(0.005984 \text{mW} / 5 \text{ mm}) \times \sqrt{0.01356 \text{GHz} / 7.5} = 1.8582 \times 10^{-5} \text{ W/kg}$

The total SAR test exclusion $\approx 0.0372 \text{ W/kg} < 1.6 \text{ W/kg}$
