This letter is to request Limited Modular Approval in accordance with FCC Rule Part 15.212(b) for the certification request under FCC ID: 2AVQUOC25112ST. This product is a wireless power receiver and battery charger module and can be used in autonomous devices to recharge the on-board batteries.
