


- a. The Product was placed on a nonconductive table 0.8 m above the horizontal ground reference plane, and 0.4 m from the vertical ground reference plane, and connected to the main through Line Impedance Stability Network (L.I.S.N).
- b. The RBW of the receiver was set at 9 kHz in 150 kHz ~ 30MHz with Peak and AVG detector in Max Hold mode. Run the receiver's pre-scan to record the maximum disturbance generated from Product in all power lines in the full band.





(A) Radiated Emission Test-Up Frequency Below 30MHz




(B) Radiated Emission Test-Up Frequency 30MHz~1GHz

12.2 Limit

Frequency hopping systems shall have hopping channel carrier frequencies separated by a minimum of 25 kHz or the 20 dB bandwidth of the hopping channel, whichever is greater. Alternatively, frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater, provided the systems operate with an output power no greater than 0.125W.

12.3 Test Procedure

- 1. Remove the antenna from the EUT and then connect a low RF cable from the antenna port to the spectrum.
- 2. Set the spectrum analyzer: RBW = 30kHz. VBW = 100kHz , Span = 2.0MHz. Sweep = auto; Detector Function = Peak. Trace = Max hold.
