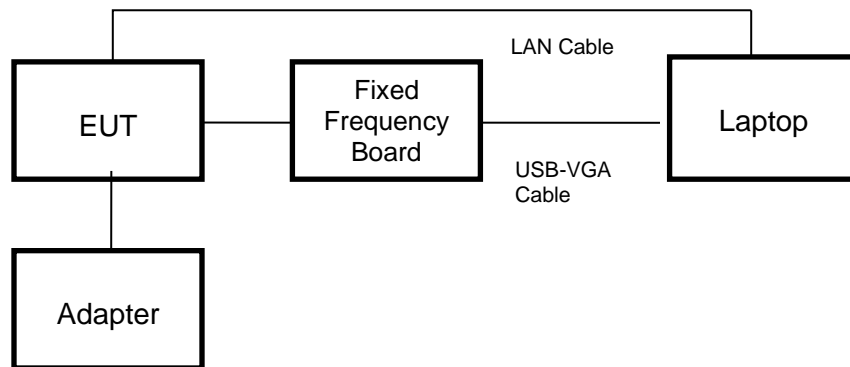

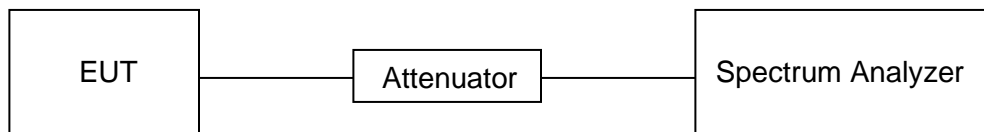

11B ON TIME AND DUTY CYCLE MID CH (WORSE CASE)

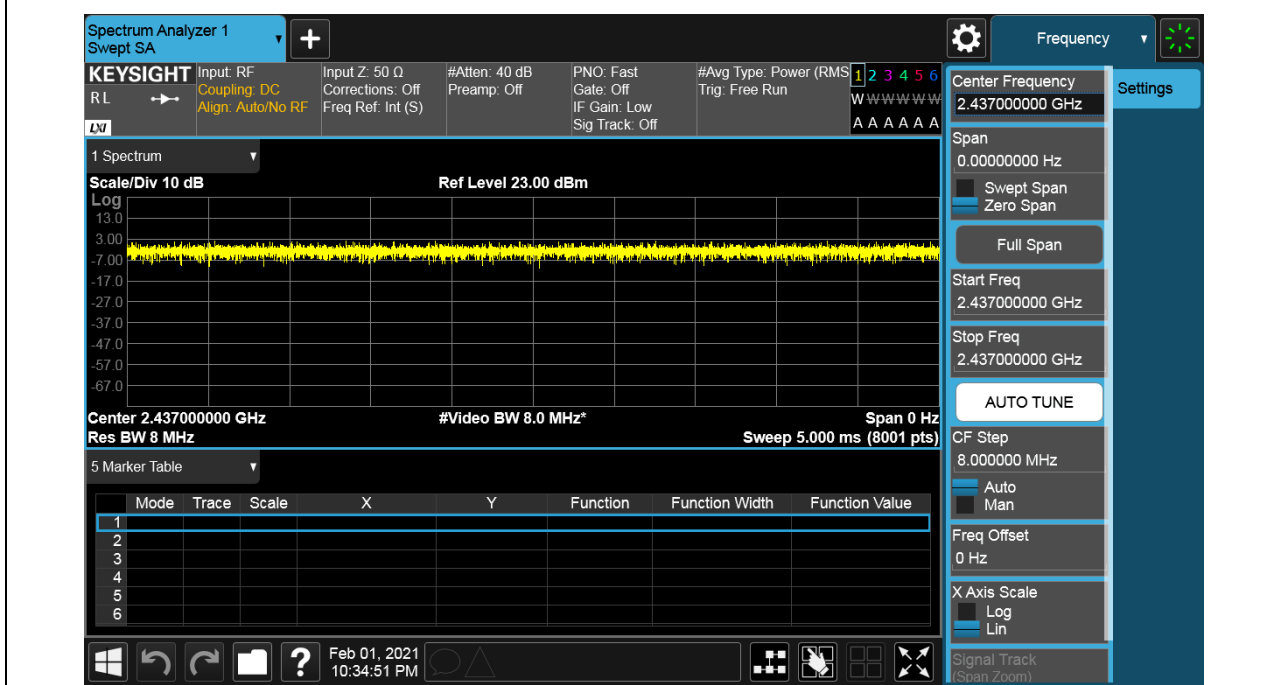


11G ON TIME AND DUTY CYCLE MID CH (WORSE CASE)

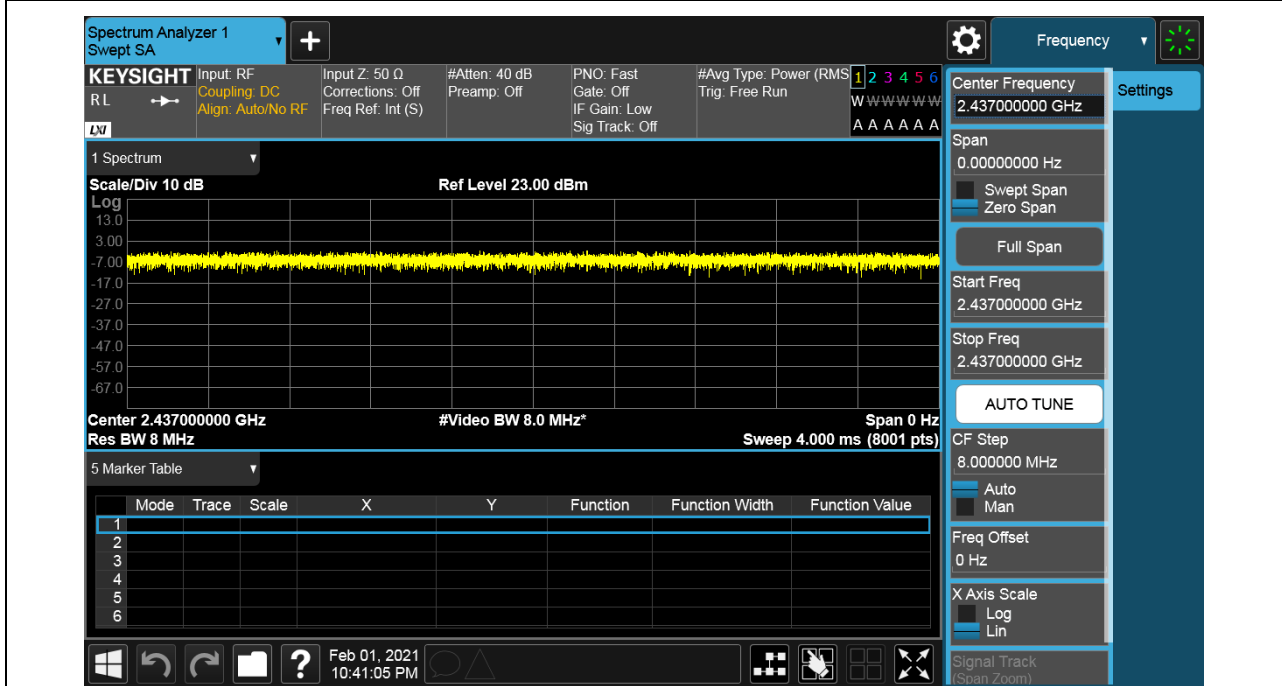




11N HT20 MIMO ON TIME AND DUTY CYCLE MID CH (WORSE CASE)
