

2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with KDB 447498 D01 General RF Exposure Guidance v06 and FCC Guidelines for Human Exposure IEEE C95.1.

#### 3. FACILITIES AND ACCREDITATION

Note 1: All tests measurement facilities use to collect the measurement data are located at No. 2, Chengwan Road, Suzhou Industrial Park, Suzhou 215122, People's Republic of China

Note 2: For below 30MHz, lab had performed measurements at test anechoic chamber and comparing to measurements obtained on an open field site. These measurements below 30MHz had been correlated to measurements performed on an OFS.

Note 3: The test anechoic chamber in UL-CCIC COMPANY LIMITED had been calibrated and compared to the open field sites and the test anechoic chamber is shown to be equivalent to or worst case from the open field site.
