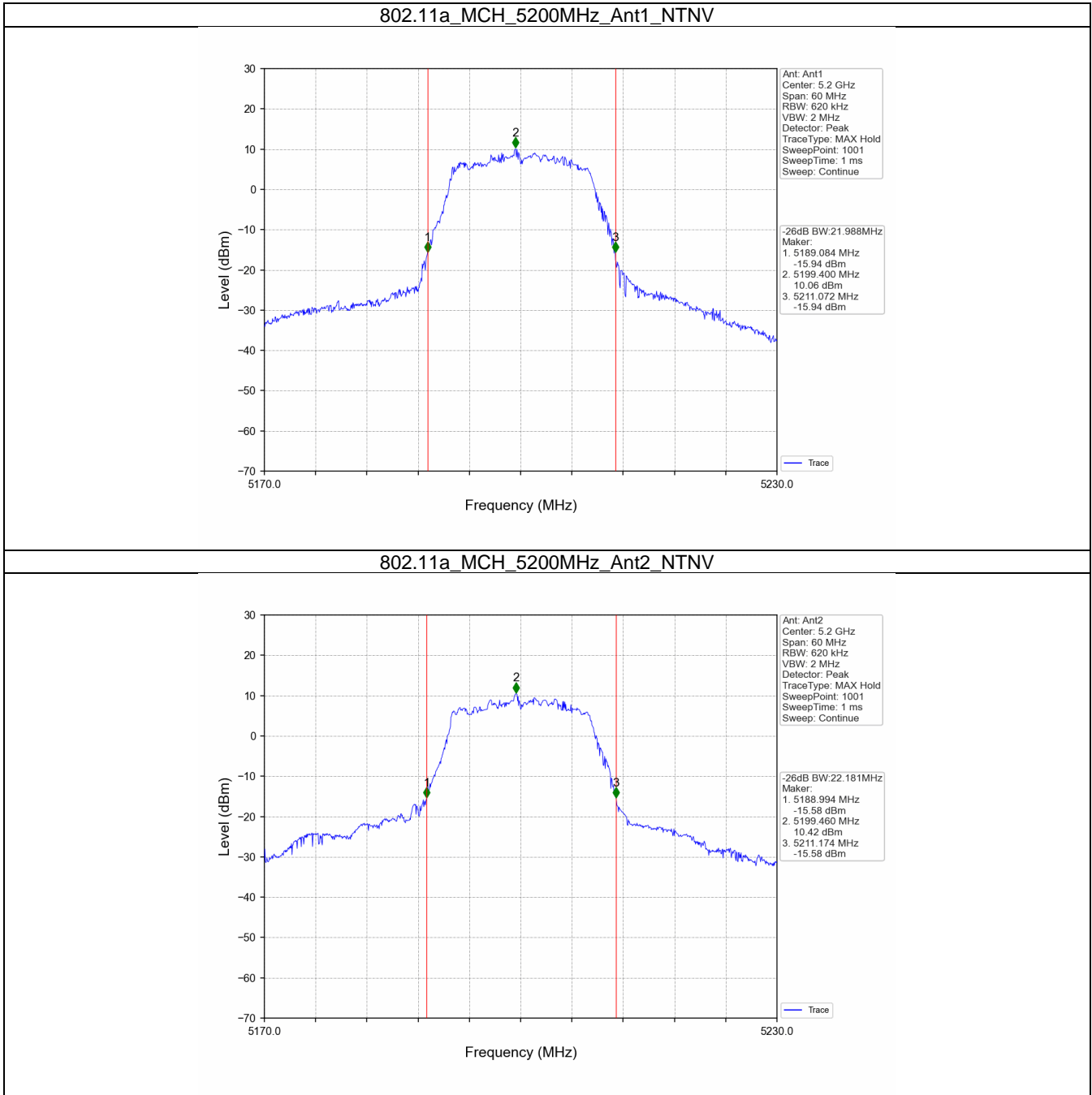


2.3.2 Test Graph



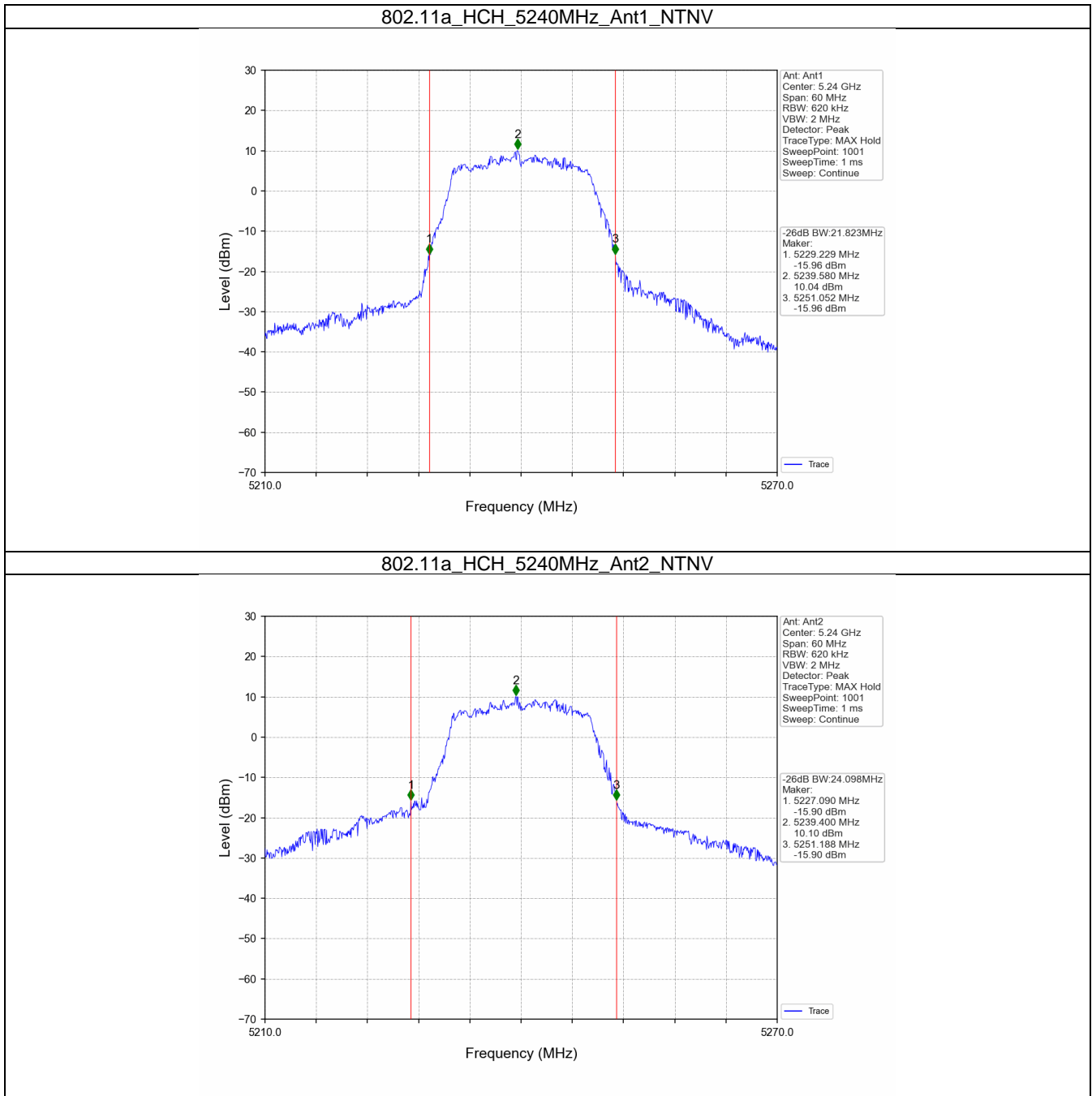
