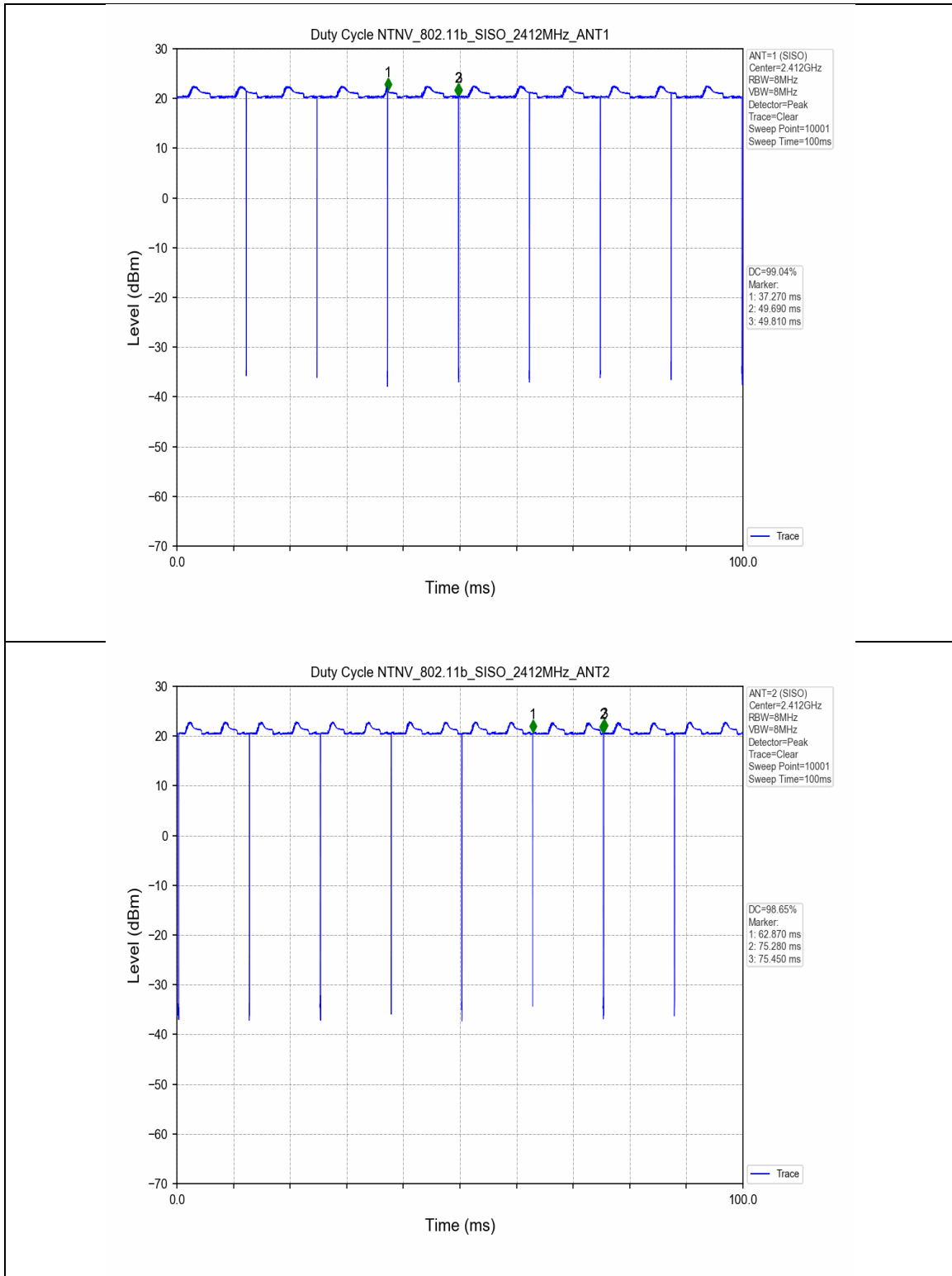

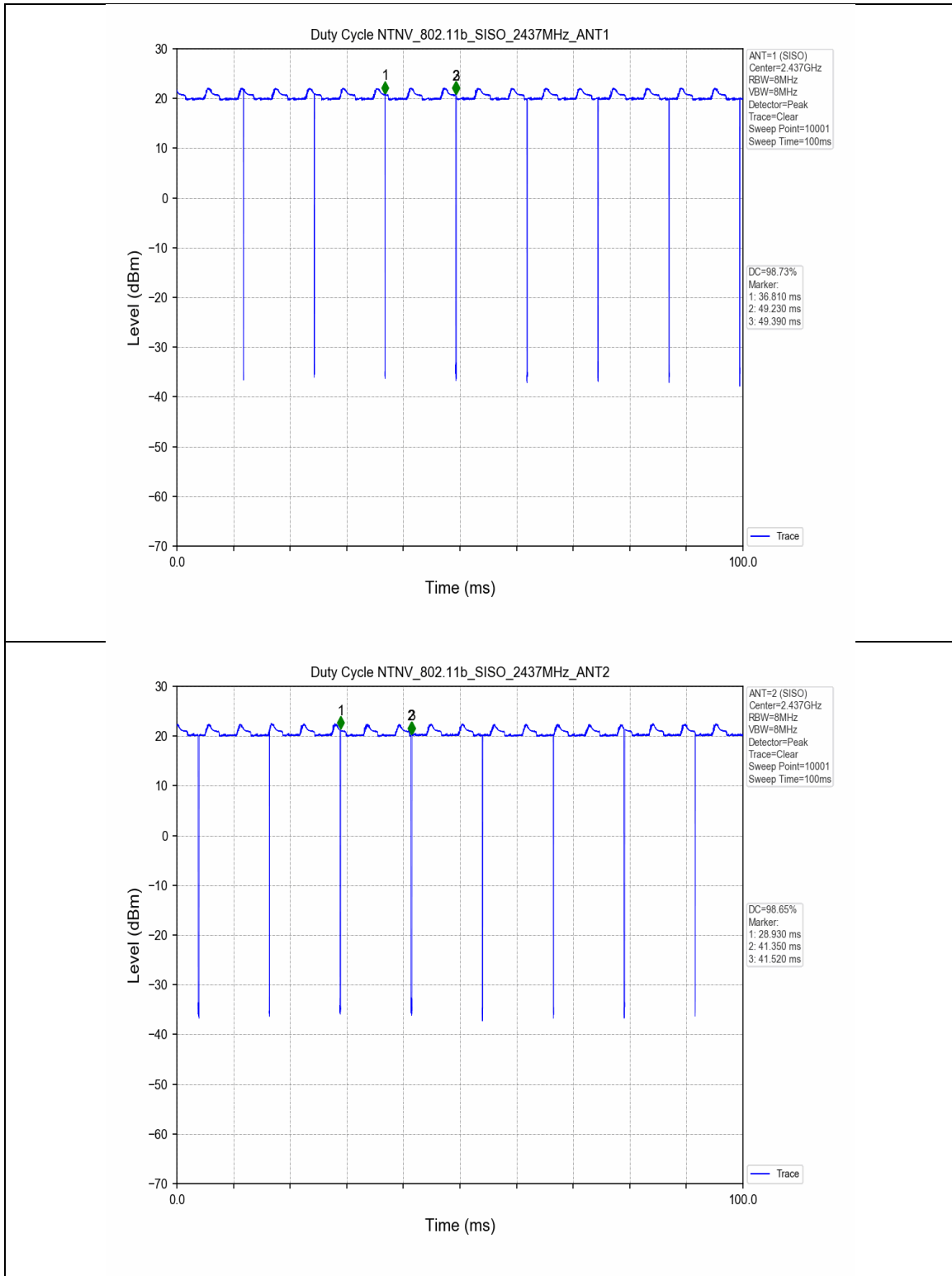
1.2 Test Graph

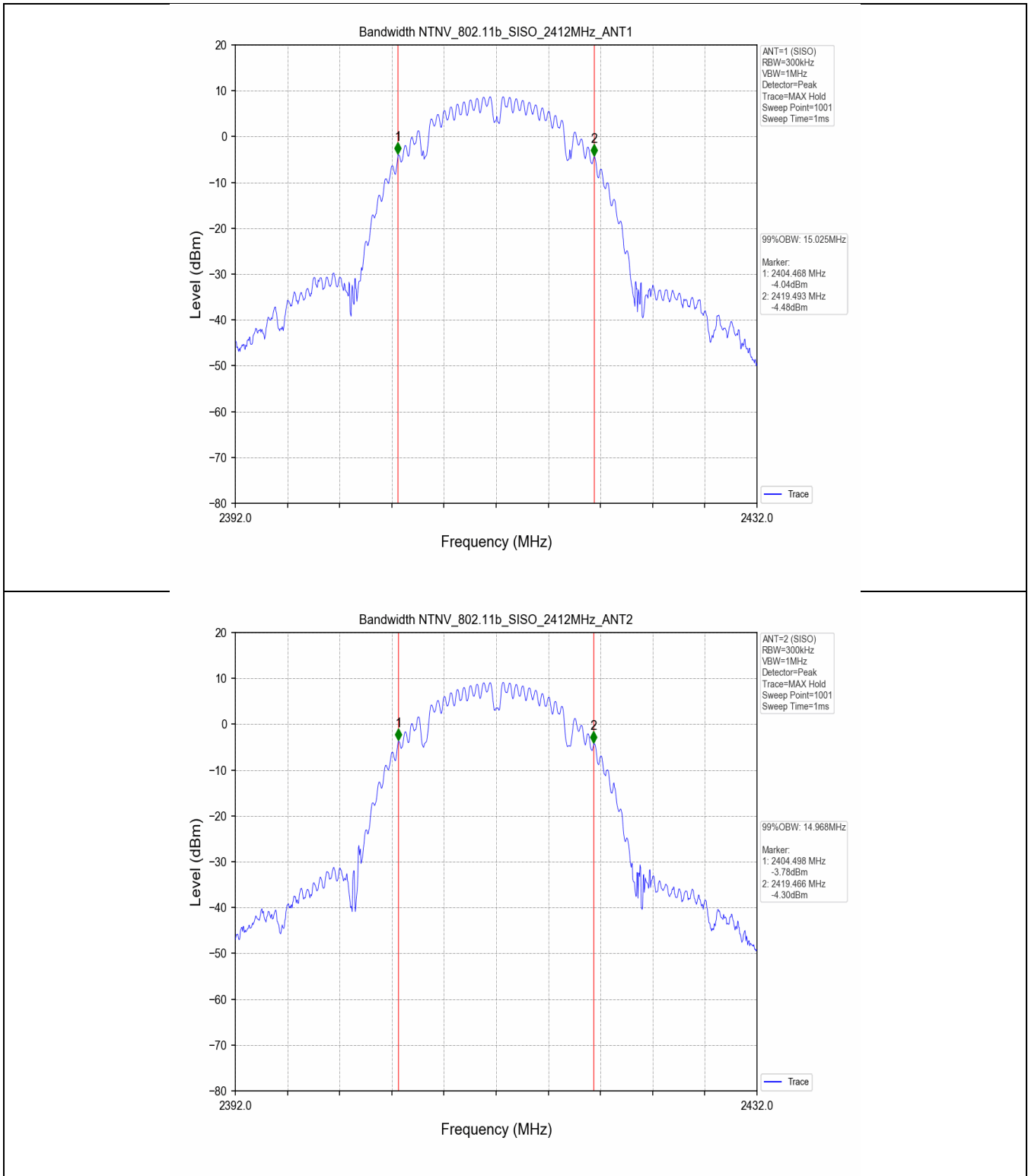


2.3 Test Graph - 99% Occupied Bandwidth



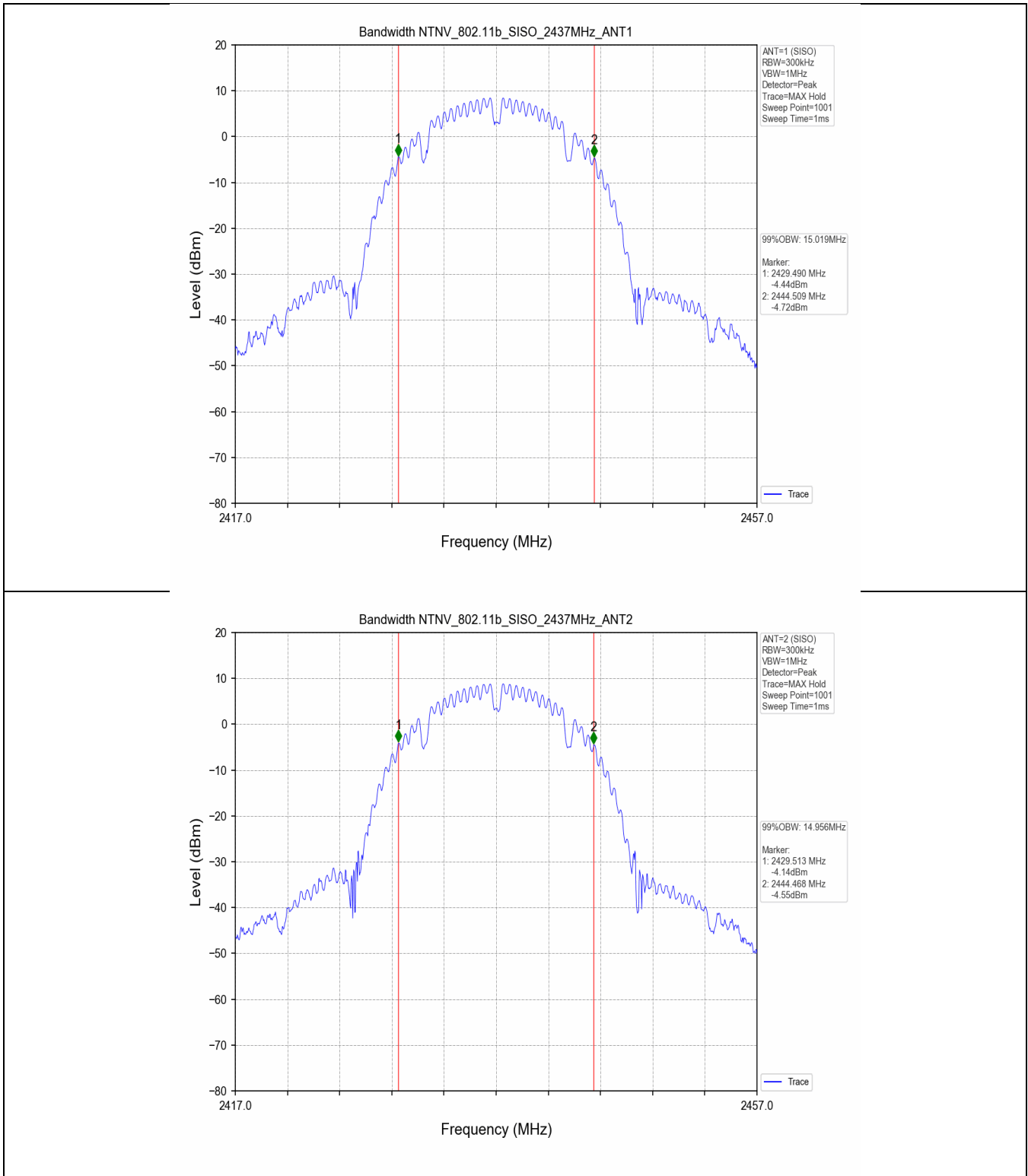
