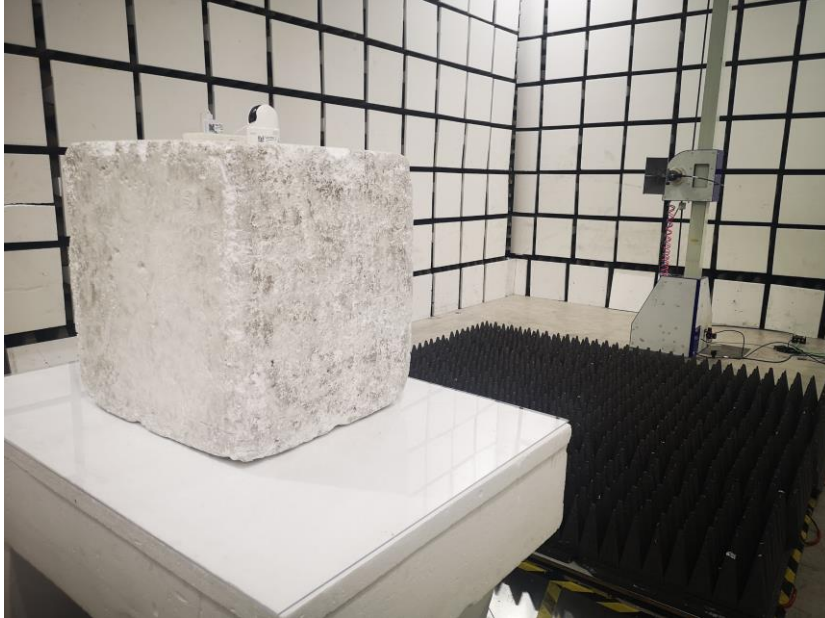


2.2 Radiated Emission Test Setup
